This is to notify you that on Tuesday, March 26, 2013, the City's Licenses Committee voted to recommend to the City's Common Council that the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 5219 W. Hampton Ave. ("Larry's Fiesta") be renewed with a sixty (60) day suspension based on the police report, police testimony, neighborhood testimony, and licensee testimony.
