This is to notify you that on Monday, November 10, 2014, the City's Licenses Committee voted to recommend to the City's Common Council a thirty day suspension of your Class D Operator's license based on items #2-3 of the police report.

Said suspension of your Class D Operator's license is to be in effect between 12:01 a.m., January 1, 2015 through 11:59 p.m., January 30, 2015.
