Meemic Insurance received your letter informing us of that the statutory 120 day timeframe wasn't met therefore barring recovery to Meemic and/or their insured, Teresa and Matthew Breitrick on June 16, 2023. Meemic Insurance is asking for reconsideration and a hearing to show that we made an attempt to send our subrogation demand timely however we mistakenly sent it to the wrong department. A notice of claim form was completed on November 28, 2022 and sent via mail to Milwaukee County Clerk, 901 North Ninth St, Milwaukee, WI 53233.

We have to follow up on our claims every thirty days until the claim is concluded. On December, 16, 2022, I resent our subrogation demand via email to Ryan Anderson at ryan.anderson@charlestaylor.com. It wasn't until December 21, 2022 that I received a response back indicating, "this would need to be directed to the City of Milwaukee Clerk". After returning from vacation, I called the City Clerk's office in February and was given the appropriate instructions on how and where to send subrogation demand notice by Tynecica Shaw who also sent to the instructions to me via email in which I mailed out the demand. You indicated you received it in your office on February 7, 2023.

Please reconsider at least recovery reimbursement to my insured, Teresa Breitrick and Matthew Breitrick, for their \$500.00 out of pocket deductible for the negligent act sustained by your employee by who collided into our insured's vehicle.
