
Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Dennis Civers, 2359 South 51st Street, Apartment #203, Milwaukee, WI 53219, alleges through his attorney, Mei & Associates, S.C., 205 Bishops Way, Suite 221, Brookfield, WI 53005, that on March 9, 2005 he sustained injuries when he received an electrical shock while guiding a pole and it came into contact with an electrical line. They claim damages in the amount of \$1,117,877.28.

Our investigation reveals that Mr. Civers was on duty and going about his duties with the Infrastructure Services Division. As such, the exclusive remedy available to Mr. Civers is Worker's Compensation pursuant to §102.03(2), Wis. Stats. Therefore, we recommend that this claim be denied.
