WHEREAS,

was founded on September 30, 2016 at 3940 N. 21st St. and has served the community; and

WHEREAS, *The Infinite Church is a Non-Denominational Church, head quartered at 3940 N. 21st St., and has become one of the fastest growing churches in the state, with more than 356 active members; and*

WHEREAS, *The Infinite Church's overall vision is to be a catalyst in the community and to be used as a hub for spiritual and temporal needs of all mankind, and seeks to uplift men, women, and children from all walks of life; and*

WHEREAS, *The Infinite Church has answered the call of community service and acts of kindness by rendering more than \$65,000 to families across Milwaukee, helping with food, water, shelter, utilities and transportation since its opening; and*

WHEREAS, *The Infinite Church was founded by Pastor Radontae L. Ashford, who serves as its senior servant and chief executive officer, who was called to preach The Gospel of Jesus Christ on April 17, 2002, where he became licensed as a minister on September 1, 2002, and the church is co-pastored by Dr. Erika M. Ashford, who is the wife of Pastor Radonte and serves as chief operating officer; and*

WHEREAS, *Radontae L. Ashford was officially installed as pastor of the Infinite Church on April 21, 2017 and was later consecrated and apostolically affirmed on April 5, 2019, his wife Dr. Erika Ashford, was consecrated and ordained as a pastor on April 21, 2017; and*

WHEREAS, *Trustee Cheryl Manns serves as the chief financial officer of the church as well as serving the Trustee Board as president, and Deacon Exie Tatum III serves as the chairman of the Deacon Board and as president of Infinite Promises Group LLC, and Deaconess Suzette Anderson-Taylor serves as vice president of the Trustee Board as well as facilitating Infinite Covenant Partners; now, therefore, be it*
