This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/12/07 at 9:24 pm, Milwaukee police were dispatched to an Armed Robbery at 2210 W Keefe Avenue. Officers spoke to the victim and investigation found the victim was robbed while exiting the V & T Liquor store. The victim stated two suspects ordered him into his vehicle at gun point and was made to drive the suspects to 2210 W Keefe where he was robbed of his property. Police did view surveillance video from the liquor store and spoke to the manager, Timothy Pernell, who stated he was working at the time of the robbery. No injuries were reported.

2. On 04/01/2014 a stolen credit card was used to purchase liquor at V&T Wine and Liquor (916 West Burleigh Street). The investigating officer spoke to the applicant on 04/05/2014 and 04/09/2014 in an attempt to obtain store video of the transaction. On both occasions, the applicant told the officer he needed to contact a third party to retrieve the video and the officer would be contacted when this happened. On 04/13/2014, the officer again contacted the applicant about retrieving the video and was told at that time that the video was only retained for a week and had been overwritten.

3. On 08/30/2014 a 16 year old, working in conjunction with Milwaukee police, was able to purchase a Black and Mild cigar from the cashier at V and T Wine and Liquor (916 West Burleigh). The applicant was cited.

Burleigh St. The clerk stated she didn't ask for ID because the juvenile looked old enough. The applicant was mailed a MARTS letter. As of 05/19/2016 the applicant had failed to enroll in MARTS. 6. On 07/19/2018 a 19 year old working in conjunction with the Milwaukee Police Department and D.F.C. Alcohol Compliance initiative, was able to purchase 4 pack of Capricio Bubbly Sangria for \$9.99 from the clerk at V&T Liquor, 916 W. Burleigh St. The officer entered the business and identified the clerk based on the description provided. The clerk denied the sale. The manager came up and stated they would do better in the future and the officer explained the Respect 21 program. The manager stated he was familiar with the program because he had just completed it.

7. On 08/04/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars from the clerk at V&T Liquor, 916 W. Burleigh St. The clerk did look at the ID but made the sale even though the ID showed the juvenile was 16. The clerk was identified and admitted the sale saying she made a mistake looking at the ID. The applicant was mailed a MARTS enrollment package. As of 12/10/2018 the applicant had not enrolled in MARTS and was issued a citation for the violation.

Burleigh St. The officers went to 916 W. Burleigh St and spoke to a security guard, who stated there were two subjects fighting in the store. He was able to push one subject outside. This subject produced a firearm and fired shots into the store at the other actor. The second actor was observed with a firearm but he did not fire it. The officers observed a hole in a window and located a bullet inside the store. The officers watched the video which did capture the incident.

This report is written by PO David LETTEER, assigned to Sq. 5468 Tavern Squad, with PO Russell MACRAE.

On 05-28-19 at 8:578 p.m., we were dispatched to the location of N. 6th St. and W. Burleigh St., in the city and county of Milwaukee, for a report of shots fired. The CAD reported that the person calling heard 3 gunshots, but did not see anything, just heard the gunshots.

As we were in the area, another call of a Hold Up Alarm was broadcast from the location of 916 W. Burleigh St., V&T Wine & Liquor Store, in the city and county of Milwaukee, which was 3 blocks west of our location. Upon arrival, we found the Liquor Store to be locked and two workers inside of the store. I pounded on the main entrance and a female worker opened the door for me. I asked if anyone in the store was shot or a shots fired. I was informed that there was a person shooting gun outside of the store shooting into the store. At this time, PO MACRAE put out over the radio that the shots fired and the Burglary Alarm were the same incident.

V&T Wine & Liquor Store is a liquor store located on the north side of W. Burleigh St. To the west of the liquor store is a vacant field, to the the east is a red colored brick home. The front of the business has a handicap ramp, which is accessed from the east and leads to the main entrance. Once you enter the store, to the west wall is an enclosed counter for the cashier which contained the cash registers and various bottles of liquor. Outside of the cashiers area is a cooler, which is used for Red Bull. To the east wall are coolers filled with various liquor bottles. If a person continued north into the store, you stop at the north wall and there is a door that leads into an office area, as well as the cashier area.

As I entered the store, there was a black male, identified at Clarence WARD (b/m 06-02-69) who was holding his left side, with his right hand. I asked WARD if he was armed and he stated he was not. I checked WARD to make sure he did not have a firearm, as well to see if he was injured. WARD did not have any firearm, nor was he hurt. I continued to speak to WARD who was highly agitated. He stated he was working at the store as security/stocker. He stated he began work at 9:00 a.m. and was working all day. He stated as he was out in the main customer area, there was (Actor 1) a black male 5'11, dark skin, short hair, wearing a brown colored sweater fighting with (Actor 2) a black male 5'11, with dread locks and stocky build, wearing grey. He stated as the argument continued, he was able to push Actor 1 out of the main entrance outside. He stated as he did this, Actor 1 opened the door and fired one gunshot, almost striking WARD, causing him to fear for his safety. WARD stated Actor 1 then fled in an older 4-dr. vehicle, unknown make or model, which was parked in front of the liquor store and fled west from the store on W. Burleigh St. This is all the information that WARD could give me at this time. He was upset and he stated that the incident happened so fast, that he could not give further descriptions.

As I continued to speak to WARD, I asked him if he believed that he was the intended target for Actor 1 shooting into the store. WARD stated he believed that Actor 1 was continuing the incident and trying to shoot at Actor 2, who was still in the store. WARD did tell me that the gunshot that came into the store was close to him and he did fear for his safety. WARD did state that he believed there to be 10 to 15 other people inside of the store when the incident happened, but could not give me a description of those people. It should be noted that WARD was the only person, other than BATEMAN in the store

when we arrived.

I then spoke to the female worker, identified as Denice BATEMAN (b/f 12-17-56) who stated she was working as the cashier at the store, since 3:30 p.m. She stated as she was working, she heard arguing out in the customer area of the store and then she heard a gunshot. BATEMAN stated she closed the window between herself and the customer area, went to the back room and pressed the panic button, alerting the police of an incident.

Outside of the store, just to the east of the main entrance door, is a small window, which had a bullet hole, which someone from the outside of the building fired a gunshot through the window and entered the interior of the building. While inside of the store, located on the outside wall of the cashier enclosure, just below the window line was a bullet strike, which entered the wall and exited. The bullet that entered and exited the wall was laying on the floor, next to the Red Bull cooler. PO MACRAE, while outside located two .380 Auto Ammo Inc. spent casings laying in the middle of the road, directly in front of 916 W. Burleigh St.

PO MACRAE watched the video from the DVR system and observed several individuals in the store. Actor 2 was observed to be a black male, with dread locks and a gray in color jogging suit, in possession of a black semi automatic handgun, which was concealed in his right pants pocket, until Actor 1 was pushed outside of the store. After Actor 1 fires the gunshot into the building, Actor 2 pulls out his firearm and kneels behind the Red Bull cooler with his gun in his right hand and waits for a period of time. Once Actor 2 believes it is safe, he leaves the store, without firing a gunshot. Actor 2 never fires his gun, but is observed with his right hand on the firearm during the confrontation.

The workers, as well as the owner Vickie BROOKS, were cooperative and allowed us to review the video, as well as have an Forensic Investigation come out and download a copy of the video for inventory.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
