## NOTICE OF PUBLIC HEARING

## **DEAR PERSON OF INTEREST:**

The Common Council has referred File No. 230628 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Two-Family Residential, RT1, to Local Business, LB1, for commercial development on the western portion of 5208 South 27th Street, located on the east side of South 27th Street, south of West Abbott Avenue, in the 13th Aldermanic District.

The owner of the property located at 5208 South 27<sup>th</sup> Street, Jaggi Ghotra, is requesting to rezone the western portion of the site, which fronts South 27<sup>th</sup> Street, to LB1 to allow commercial development to occur, consistent with the properties to the north and south of this site. The future development would be required to follow the LB1 zoning rules with respect to allowable uses and design standards. The eastern portion of the site will remain zoned residential. A Certified Survey Map has been submitted to divide the existing lot into two parcels.

The City Plan Commission considered this item at its October 16, 2023 meeting. At that time, discussion regarding the anticipated future commercial uses on the subject site was had, and CPC moved to hold this item to allow additional time for conversations between the applicant, alderman, and staff. A second public hearing is scheduled for November 6<sup>th</sup> to resume discussion on the proposed zoning change. **Please refer to the reverse side of this notice for map details.**
