JOB EVALUATION REPORT

Fire & Police Commission Meeting: February 15, 2007

Department: Fire

This report recommends appropriate classifications and compensation levels for three positions in the Milwaukee Fire Department. In reviewing these positions, staff analyzed new job descriptions and held discussions with Fire Chief William Wentlandt, Deputy Fire Chief Gary Miller, and Fire Personnel Office Mary McDougall. The following chart summarizes the recommended changes.

Action Required - Effective Pay Period 1, 2007

In the 2007 Salary Ordinance, under Pay Range 857, add the title "Fire Captain - Incident Safety Officer."

In the 2007 Positions Ordinance, under Fire Department, Firefighting Division Decision Unit, delete three positions of "Fire Captain-Incident Safety Office" and add three positions of "Fire Captain-Incident Safety Officer."

The 2007 budget added three positions of Fire Captain to serve as Incident Safety Officers. Incident scene safety management has become one of the most significant components that support Fire Fighter safety.

These positions will perform overall risk management at fire scenes, focusing on all aspects of an incident, in order to protect the welfare of respondents. They will directly assist the Incident Commander in an emergency that requires a multi-unit response. These positions will be part of the minimum daily 24-hour shift.

These positions will also work closely with the Health & Safety Officer to develop internal safety programs, monitor injuries, and institute a measurable plan to decrease preventable injuries and Worker's Compensation claims.

The nature of work and level of responsibility of these positions are consistent with the classification of Fire Captain. We therefore recommend these new positions be classified as Fire Captain-Incident Safety Officer in Pay Range 857.
