There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines: **Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Kathleen MURPHY assigned to District 5, Early Power Shift, Squad #5261.

On Wednesday, June 28, 2023 at approximately 12:10pm, Police Officer Andrew GROSS and I, while wearing full Milwaukee Police Department uniform with Axon body worn cameras activated, responded to 786 Petro Mart gas station located at 2905 W Fond Du Lac Avenue in the city and county of Milwaukee, Wisconsin regarding a robbery incident.

The caller, "Jonny Stewart" (414-807-1155), stated in the CAD that "cdlr sts he believes the location is getting robbed..sts there were 2 subs inside taking items..sts one of the subs were refusing other customers from coming in".

Upon our arrival on scene, the clerk identified himself as Deep SINGH (A/M, 2/11/1999).

SINGH was hesitant to provide his name and information and initially stated 2/11/1991 and then corrected it to 2/11/1999. SINGH identified himself as Deep SINGH (A/M, 2/11/1999). SINGH also provided a phone # of 414-779-1944. A check of MPD records revealed that phone # from 4/30/2023 listed to Parvinder SINGH (A/M, 11/2/1999). A check through NCIC revealed that neither identity could be confirmed.

I contacted the licensee, Farhan S GHAFFAR (A/M, 3/6/1979), on July 6, 2023 and advised that the clerk had not identified himself with a legal name. GHAFFAR stated he would get ahold of SINGH and have SINGH contact me. It was determined a robbery had not occurred.

This report was written by P.O. Terry BELL assigned to District Five Early Power shift, one-man Squad 5290.

On Tuesday, August 9, 2023 at 6:11 PM I was dispatched to 2905 Fond du Lac Ave for a Trouble With Subject.

Upon my arrival, I observed patrons outside of the business getting gas. There was a female patron exiting the business. I did not observe any panhandlers on scene.

Prior to arrival, I spoke to the licensee, Farhan GHAFFAR (M/B, 03-06-79) who called from his personal cell phone (414-801-0785). GHAFFAR stated that his customers are being harassed by aggressive panhandlers who frequent the business. GHAFFAR stated that the panhandlers would aggressively approach customers and constantly ask for money.

I then spoke to the store manager, Moses OMORUYI (M/B, 12-05-73), who stated that the panhandlers were no longer on scene but that he obtained their physical identities by recording them on his phone while they were on scene. OMORUYI stated that the subjects would travel from their business to the liquor store across the street from the location back and forth.

Both GHAFFAR and OMORUYI were cooperative with my investigation.

OMORUYI was unable to operate the surveillance camera but show me a recording on his phone to assist with identifying one of the subjects. I recognized the subject but was unable to remember his name.

While on scene, I observed the licenses posted on the wall of the cashier area. There were current.

I left a contact card with OMORUYI and then searched the area for the subjects but was unable to locate them.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
