During the struggle a second officer, Officer HEDGLEY arrived and helped in the arrest of MANJEE. After the struggle MANJEE was given another citation for Failure to Change Address on Drivers License and was arrested for State Obstructing.

The case was reviewed by ADA Steven GLAMM who declined to issue the obstructing charge against MANJEE. ADA GLAMM recommended that Officer BOWEN issue MANJEE a city citation for Obstructing an Officer which Officer BOWEN did issue.

## **CONCLUSION:**

Investigation by the CIU revealed that Officer BOWEN stopped Habib MANJEE for a speeding violation. During the stop Officer BOWEN and MANJEE struggled over the citation and a second officer was called to the scene. During the struggle with the two officers MANJEE claims he was struck under the right eye but he can not identify which officer struck him. Detectives attempted to interview the officers involved, however, neither would make a statement. MANJEE told Detective CISKE that he refuses to appear at the District Attorney's office regarding this complaint. Due to MANJEE'S lack of cooperation this complaint will be cleared as baseless.
