This office is in receipt of your claim in the amount of \$1,000.00, relating to injuries you sustained on July 3, 2001 when you allegedly fell on the sidewalk located at or near South 20th Street and West Morgan Avenue.

Our investigation reveals that there is no record of any complaint with the Infrastructure Services Division regarding a defect at this site for one year prior to this incident. Upon notification of this claim, a street maintenance crew ramped the sidewalk with asphalt along West Morgan Avenue at South 20th Street. Prior to this complaint, the City had no notice of this defect with the sidewalk and because of this lack of notice, the City would not be liable. Accordingly, we are denying your claim.
