(1) In accordance with the provisions of Section 295-907 of the Code relating to the establishment of Code relating to the establishment of planned development districts, the Common Council approves the subject amended Detailed Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set forth herein.

(2) The zoning map is amended to change the zoning for the properties located at 2430 North Lake Drive, Tax Key No. 318-0114-000, and 2320 North Lake Drive, Tax Key No. 318-0081-100, to amend the Detailed Planned Development and to change the zoning at 2430 North Lake Drive from Detailed Planned Development (DPD) to Two-Family Residential (DPD) to Two-Family Residential (RT2).
