Dear Administrative Review Board of Appeals:

Enclosed for review, relative to the appeal of the above-captioned matter, are redacted materials related to the nuisance activity identified in the nuisance determination notice.

By letter dated December 20, 2024, the Milwaukee Police Department sent written notice that 4264 N. 27<sup>th</sup> St. is determined to be a nuisance pursuant to Milwaukee City Ordinance (MCO) § 80-10. The letter identified the illegal possession or use of firearms as nuisance activity pursuant to MCO § 80-10-2-c-1-L. These are further referenced as crimes defined in Wis. Stat. § 948.60 and Wis. Stat. Ch. 941. It is a crime to intentionally point a firearm at another individual pursuant to Wis. Stat. § 941.20(1)(c).

The first activity occurred on November 18, 2024. Materials are enclosed as Exhibit A. Officers arrived after being called for a robbery. When officers arrived, they could hear yelling behind the apartment complex door. T.L.H. exited the apartment complex waiving a broom handle. Officers then entered the residence that was five feet from the entrance to the building (unit 1).

T.L.H.'s father, D.H., was interviewed. D.H. described the incident. D.H. heard a knock at the apartment's entrance when two people pushed their way into the hall and then into his apartment. The two people pulled out firearms after D.H. was pushed to the ground.

The people pointed them at him while he was on the ground. The people asked where the money was and where the dope was.

Officers spoke with D.H. a second time. He stated that he picked up a prostitute the day before and brought her back to the residence. He was robbed walking her back. He did not pay her. They smoked cocaine base while they were together. He gets his cocaine base in the same area he picked up the prostitute.

The second activity occurred on December 13, 2024. Materials are enclosed as Exhibit B. Officers were dispatched to a subject with a weapon complaint at this premises. The caller, T.L.H., stated that he and his cousin returned to the premises after getting food. T.L.H. said his cousin then had a mental breakdown from smoking K2 and drinking alcohol all day. T.L.H. said his cousin slammed the door behind them and brandished a firearm from his waistband. T.L.H. and his son were ordered to remove their clothes. They removed their underwear at gunpoint. They were ordered to go outside and walk towards the alley. T.L.H. walked to a neighbor's apartment and called 911.

The possession, manufacture or delivery of a controlled substance in violation of Wis. Stat. Ch. 961 is a listed nuisance activity. MCO § 80-10-2-c-1-i. Controlled substance violations are a nuisance activity type that qualify for two responses in a year. MCO § 80-10-3-a. Cocaine base, or crack cocaine, is a controlled substance where possession, manufacture or delivery is prohibited. Wis. Stats. §§ 961.41(1)(cm) and 961.41(3g)(c).

K2 is a brand name known for synthetic cannabinoids. Wis. Stat. Ch. 961 recognizes synthetic cannabinoids as a controlled substance. Wis. Stat. § 961.14(4)(tb). The possession, manufacture and delivery of synthetic cannabinoids is a criminal violation. Wis. Stats. §§ 961.41(1)(em) and 961.41(3g)(em).

Assessing the cost of police activity against the owner of the premises does not violate any Constitutional rights. There is no possibility that the regulation will chill protected activity because there is no constitutional right to police services. *Hilton v. City of Wheeling*, 209 F.3d 1005, 1006–07 (7th Cir. 2000).

Dear Berrada Properties 34 LLC,

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at 4264 N 27th St ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises. As an individual or entity that is licensed or subject to a license in the operation of a business upon the premises, you are a responsible party for abating the nuisance activities occurring at the premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

As a consequence, you may be subject to a collections action for the cost of future enforcement for any of the nuisance activities listed in MCO § 80-10-2-c that occur at the premises.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

WI' stated they each pulled 9mm black handguns out and pointed them at him while he was on the ground and stated "Don't move, where's the money" and "Don't move, where's the dope". W stated that he told them there was no dope and that he gave them his wallet containing \$30 in cash. W'' stated that they also stole his phone, valued at approximately \$50 that is no longer in service which was on living room table.
