AFFIDAVIT OF CORRECTION FOR CERTIFIED SURVEY MAP NO. 7018

I, Frederick W. Shibilski, Registered Land Surveyor, being first duly sworn, on oath depose and states the following:

This document is written to make the following corrections to pages 1, 2 and 3 of the map as recorded as Document No. 8156506 and Map No. 7018.

Page 1:

The general heading reads: Being a division of Lots 2, 3, 4, and the North 15 feet of Lot 5 in Block 14, Meehan and Somer's Subdivision located in part of the Northwest ¼ of the Northwest ¼ of Section 19, Town 7 North, Range 22 East in the City of Milwaukee, Milwaukee County, Wisconsin; is corrected to read: Being a division of the South ½ of Lot 2, Lots 3 and 4 and the North 15 feet of Lot 5 in Block 14, Meehan and Somer's Subdivision located in part of the Northwest ¼ of the Northwest ¼ of Section 19, Town 7 North, Range 22 East in the City of Milwaukee, Milwaukee County, Wisconsin.

Also a revised sheet 1 of 3 sheets is being filed with this correction affidavit as sheet 2 of 2 sheets.

Page 2:

The general heading has the same corrections as Page 1.

The Surveyors Certificate on lines 1 thru 9 of the legal description reads: That I have surveyed, divided and mapped Lots 2, 3, 4 and the North 15 feet of Lot 5 in Block 14, Meehan and Somer's Subdivision located in part of the Northwest ¼ of the Northwest ¼ of Section 19, Town 7 North, Range 22 East in the City of Milwaukee, Milwaukee County, Wisconsin bounded and described as follows: Commencing at the Southwest corner of the Northwest ¼ of Section 19; thence North 89° 11' 18" East, along the South line of said ¼ Section, 958.54 feet; thence North 00° 51' 02" West, 1489.60 feet to a point on the East right-of-way line of North 24th Place and the point of beginning of the land to be described; thence continue North 00° 51' 02" West (recorded as North), 104.93 feet to the Northwest corner of Lot 2; thence North 89° 10' 59" East (recorded as East, 121.25 feet), 121.45 feet to the Northeast corner of Lot 2; thence South 00° 48' 59" East (recorded as South), along the West line of a public alley, 104.96 feet; thence South 89° 11' 39" West (recorded as West, 121.25 feet), 121.39 feet to the point of beginning; is corrected to read: That I have surveyed, divided and mapped the South ½ of Lot 2, Lots 3 and 4 and the North 15 feet of Lot 5 in Block 14, Meehan and Somer's Subdivision located in part of the Northwest ¼ of the Northwest ¼ of Section 19, Town 7 North, Range 22 East in the City of Milwaukee, Milwaukee County, Wisconsin bounded and described as follows: Commencing at the Southwest corner of the Northwest ¼ of Section 19; thence North 89° 11' 18" East, along the South line of said ¼ Section, 1018.54 feet; thence North 00° 51' 02" West, 1489.60 feet to a point on the East right-of-way line of North 24th Place and the point of beginning of the land to be described; thence continue North 00° 51' 02" West (recorded as North), 89.93 feet to the Northwest corner of Lot 3; thence North 89° 11' 02" East (recorded as East, 121.25 feet), 121.44 feet to the Northeast corner of Lot 3; thence South 00° 48' 59" East (recorded as South), along the West line of a public alley, 89.93 feet; thence South 89° 11' 39" West (recorded as West, 121.25 feet), 121.39 feet to the point of beginning.

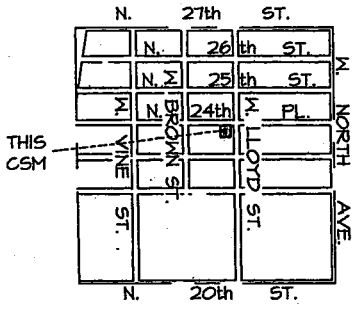
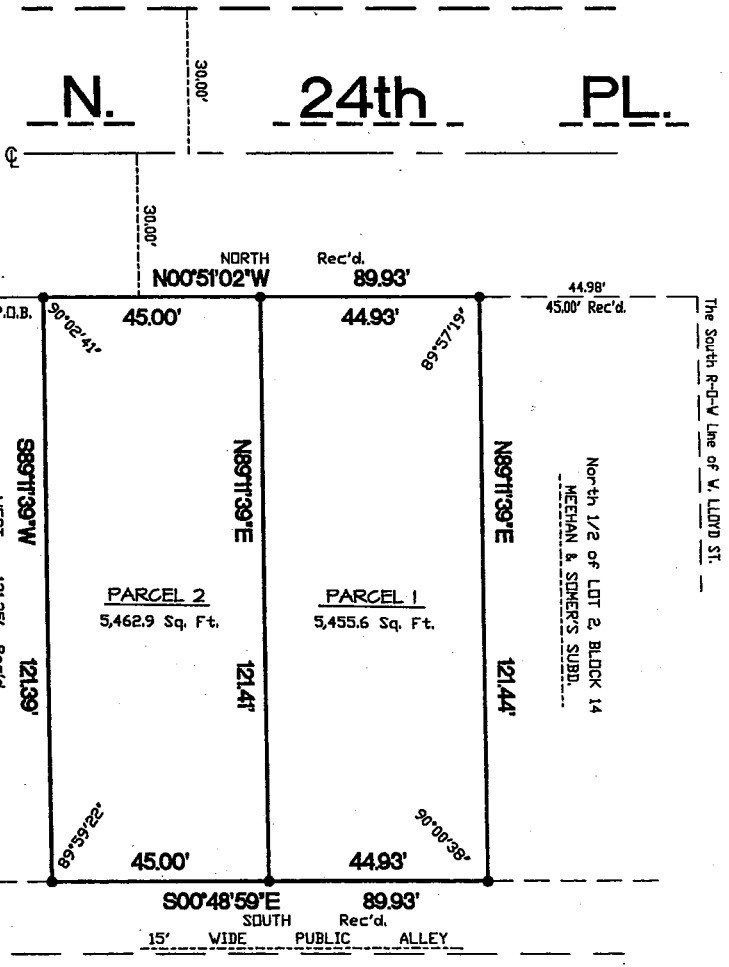
