



# **Departmental Budget Appropriation Category**

#### **New Positions**

17 Operations Driver Worker (ODW)

#### **Eliminated Positions**

12 Sanitation Labor Pool

The increase in ODW positions is partially funded by the elimination of 6 Vehicle Service Technician II positions in the Fleet Section.

#### **Vacancies**

- 2 Sanitation Supervisor
- 52 Sanitation Laborer

Winter and Summer Laborer Pool positions are not counted in the vacancy totals because they are not full-time positions.

The Sanitation Laborer positions are awaiting DER classification.





#### **ODWs and Sanitation Laborers**

The 2021 Budget eliminated auxiliary staff funding and created 60 new Sanitation Laborer positions.

The Laborer title is a lower-skilled, entry-level position and was envisioned primarily to do non-driving work. Operations Driver Workers are assigned to drive garbage packers, recycling trucks, street sweepers and other heavy equipment.

Because Sanitation operates such a wide variety of heavy equipment with overlapping service time periods, DPW requested 85 additional ODWs and 40 fewer San Laborers, for a total of 45 new positions for 2022.

The Proposed Budget provides funding for 17 additional ODWs and 12 fewer Laborers for a net gain of 5 positions.

#### **Sanitation Yard Attendants**

DPW requested 10 additional Sanitation Yard Attendant positions for 2022. The positions were not funded.

Sanitation Yard Attendants provide a variety of crucial services including, repairing and delivering garbage/recycling carts, cleaning up accident debris and making brine for snow operations.

The need for additional positions has grown in recent years as DPW has increased its capacity to manufacture and use liquids for snow and ice control.

#### **New Special Funds**

The Proposed Budget creates 2 new special funds.

Funding for salt and de-icing chemicals was moved out of the Other Operating Supplies account into the Salt Supply special fund.

Funding for waste disposal tipping fees was moved out of the Other Operating Services account and into the Waste Disposal special fund.

Salt and tipping are Sanitations' 2 largest operating expenses. Putting them into separate special funds will better define the annual need specific to those functions. It will also provide some accounting efficiencies by dedicating a special class number specific to each category of payment.


# Recycling


DPW implemented a universal every-other-week recycling collection schedule for all one-4-unit households in summer 2021, replacing 5 unique collection schedules. Recycling carts were supplied to approximately 18,600 households currently using recycling bins.

In June 2022, Sanitation will have one complete summer and winter collection cycle under the new schedule. Collection operations will be reviews and route adjustments and reroutes will be implemented as need in 2022.

## **Holiday Collection**

The Recycling Partnership provided the City with a grant to analyze the City's holiday collection schedule. The current holiday collection system shifts most route schedule whenever a collection date falls on a holiday. As a result, collection day can change as many as nine times through the year. The analysis found that there are several options which would allow more consistent holiday collection schedules. Each option would increase operating costs by \$456,000, which roughly equates to a 1% increase in the 2021 solid waste fee or \$2.50 per household.

# **Street-Sweeping**

Currently, most of the area outside of the combined sewer area is swept once per month while most of the combined sewer area is swept twice per month. The downtown area (roughly from Juneau to Canal and 6th St to Lake Michigan) is swept weekly. In 2022, the department will target the same sweeping frequencies.

## **Drop Off Centers**

The fee structure at the Self-help centers was revised in 2019 to encourage proper disposal of waste. Fees were waived for much of 2020 due to COVID-19, resulting in a significant revenue loss for 2020.

Solid waste disposed of through the Drop Off Centers increased by 93% in 2020, with the majority of increases occurring during the months of fee suspension.

Fees were reinstated in September 2020. Because of the fee interruption, it has been difficult to assess the effect of the revised fees on illegal dumping. The fee schedule is not expected to change in 2021.

There are no anticipated changes at the Drop Off Centers for 2022.
