I had to take a taxi from the airport to my home on December 26, 2016 at approximately 4:45 PM. The taxi company was KASIMA (spelling?) and the taxi number was 898.

- 1) The taxi was filthy, absolutely filthy. I still feel dirty toady, December 27, 2016
- 2) The driver spoke very limited English. When I attempted to tell him the directions to my home, he insisted on entering the address into his telephone on google maps. He kept saying "Googly, googly." I was reluctant to give him my information because he would have my home address permanently in his phone. But, my 88 year old friend who was with me really needed to get home. I was the one who had to enter the information on his cell phone because he did not understand

anything I was telling him. (How can your department license someone with such limited command of the language most commonly spoken by the people he is supposed to drive?)

- 3) In our drive from the airport entrance ramp to the freeway to the Ryan Road exit, he was honked at two different times by two different vehicles as he swerved from lane to lane without blinkers. He is a danger to all of his passengers, and to all drivers on the road.
- 4) Once on Ryan Road heading west, he drove in the parking lane from south 27th Street to approximately 38th Street. I kept telling him to "get out of this lane" but he did not understand.
- 5) At my home, I asked him for a receipt for the cost of the ride, \$29.50, and he just looked at me. I asked him again, and he shrugged his shoulders.
- 6) Also at my home, he got very loud with me in my driveway in very broken English when I tried to take a picture of the name of his cab company on the side of his vehicle. I am now

extremely concerned that he has my address in his telephone.

I'm very concerned that this man will continue to drive at least until his license comes up for renewal. (That could be a day from now, or a year from now. Who really knows???) He is unsafe and a danger to all other drivers. Your department should also be very concerned about this menace on the road. But, as Linda told me on the telephone on December 27, 2016, "...there is nothing we can do until his license comes up for renewal."



He then asked for my credit card which the posted rules clearly stated he should not do. I am very displeased with the service of this driver and company.
