The clerk stated a female subject grabbed the garbage can from by the pumps and threw them around the lot. The female then grabbed a metal pipe and hit a window causing it to spider web. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

34. On 02/29/24 at 10:15p.m., Milwaukee Police were dispatched to a Theft at 5758 W. Appleton Ave. Investigation revealed the business was the victim of a retail theft. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

A check of the vehicle revealed it was reported stolen from the City of Greenfield. The employee working at the time of the investigation did not have access to the security camera system.

This report is written by P.O. Joseph MACK assigned to District 3, Squad 3321, Late Shift, along with P.O. Aaron FROH. P.O. FROH and I were in full duty uniform equipped with an Axon body worn camera activated and in a marked squad vehicle.

On Thursday, November 21, 2024, at approximately 3:42 am P.O. FROH and I were dispatched to a theft complaint at 5758 W Appleton Ave (Citgo Gas Station).

Upon arrival, I spoke with the caller, Tony V SMITH (B/M, 3-22-86, 414-217-7200), who stated he may have left his two cellphones on the counter of the gas station when he was checking out. SMITH stated the employee told him that he could not look at the surveillance video, but the police can, so he decided to contact the police. SMITH described one of the cellphones as a Samsung Galaxy A15 with a camouflage case and the other as a Samsung Galaxy A13 with a black case.

Inside of the gas station P.O. FROH spoke with the employee, Daljinder SINGH (W/M, 9-15-94), who was cooperative in letting him review the surveillance video. Surveillance video did show SMITH at the checkout counter on Thursday, November 21, 2024, 1:09 am. SMITH put various snacks on the counter along with one of his cellphones. By the angle of the video, it is hard to tell if there are two cellphones, one on top of the other. After completing his transaction, SMITH walked away with his purchase but left the cellphone on the counter. At approximately 1:14 am, the next customer completes a purchase and as he walks away, he grabs SMITH's cellphone and walks away with it going outside to his white colored sedan and exited the property. The unknown person is described as a black male, wearing a black jacket, and black pants.

SMITH estimated the value of the cellphones at \$300. When asked, SMITH did say if the subject was identified he would like them to be cited for theft.

I spoke with SINGH who stated he did not see or remember a cellphone being left behind.

While on scene, I observed the licenses posted and they were up to date. The licenses observed were the cigarette and tobacco, extended hours, weights and measures, filling station, and food dealer with an expiration date of 1-31-25.

During the investigation of the theft complaint, I did not observe any violations in the licensed premise.

This report is written by P.O. Joseph MACK assigned to District 3, Squad 3321, Late Shift, along with P.O. Liam PEDERSON. P.O. PEDERSON and I were in full duty uniform equipped with an Axon body worn camera activated and in a marked squad vehicle.

On Saturday, December 14, 2024, at approximately 12:20 am P.O. PEDERSON and I were dispatched to an MVA with injuries complaint at CITGO Gas Station 5758 W Appleton Ave.

Upon arrival, I observed a Blue Ford Fusion parked at a gas pump with a female standing outside of hit. Inside the vehicle there was a male in the driver's seat with three small children in the back seat. P.O. PEDERSON spoke with the male driver. I observed damage on the front passenger door frame. The Milwaukee Fire Department (Engine 34, Blue Shift, Lt. MICHAELS) was already on scene and informed me that they checked out the individuals inside of the vehicle, but they refused further medical assistance.

I spoke with the female outside of the vehicle, Tajieana K NEAL (B/F, 8-11-98), who stated on Saturday, December 14, 2024, at approximately 12:00 am they pulled into the gas station to the gas pump. NEAL stated she opened the passenger door to get out at which time a white sedan was pulling around her passenger side and struck her opened car door. NEAL said the vehicle stopped, backed up and then parked the vehicle. NEAL stated the female driver of the white sedan got out and immediately started to argue with her. NEAL described the driver as a black female, dark complexion, approximately 5'2", over 200 lbs, wearing a black sweatshirt with a reflective vest, grey or black sweatpants, and braided hair. NEAL said during the argument her boyfriend in the driver seat said he was calling the police which prompted the other female driver to get back inside of her white sedan then fled the property.

I went inside of the CITGO gas station to review video. I spoke with the license premise employee, Daljinder SINGH (B/FM, 9-15-94), who stated he did not hear or see anything and did not know there was an accident in the parking lot. SINGH allowed me to review the surveillance video. On video review I observed on Saturday, December 14, 2024, at 12:14 am the blue Ford Fusion pull into the parking lot to a gas pump and park. Due to the angle of the camera compared to where the vehicle was, I could see the driver side of the vehicle but not the passenger side. At 12:15 am the white sedan pulled into the parking lot to drive around the Ford Fusion on the passenger side. I observed the Ford Fusion briefly shake while parked and the white sedan stop when getting to the passenger side. The white sedan reversed then parked in front of the Ford Fusion. The female driver of the white sedan got out and started to approach the Ford Fusion. I observed NEAL and her boyfriend approach the unknown female driver. By their body language, it appeared they were arguing. I did not observe any physical altercation, it only appeared verbal. At 12:24 am the unknown female got back into the white sedan then left the property.

The CITGO gas station does not have any security officers on scene.

While on scene, I observed the licenses posted and they were up to date. The licenses observed were the cigarette and tobacco, extended hours, weights and measures, filling station, and food dealer with an expiration of 1-31-25.

During my investigation for the MVA with injuries I did not observe any violations in the license premise.


