### Background

The Department of Employee Relations has received a request from the Milwaukee Health Department to classify a new temporary title related to COVID- 19. For this, the department is requesting to repurpose sixteen positions of Temporary Disease Intervention Specialist Coordinator, to create sixteen new temporary positions of Temporary Community Education Assistant. Those hired into this position will be brought on as temporary employees. A job description was provided and discussions were held with Rocio Serna, Human Resources Officer and Sarah Wangerin, Human Resources Analyst - Senior.

The Temporary Community Education Assistant will work within the Milwaukee Health Department to increase awareness of COVID- 19 in response to the current pandemic. Those hired into this position will inform individuals and families in the community about COVID- 19 education, prevention, support resources, and provide support for the activities related to the COVID- 19 emergency response.

- Provide information to the community and individual clients on identified topics within the community.
- Respond to emergency and/or broad impact events as needed.
- Work with site leader to coordinate activities related to program activities.
- Assist with transportation of supplies or clients, as well as delivery of meals as needed.
- Distribute educational materials in the community.
- Participate in community activities to heighten the awareness of COVID- 19.
- Help clients obtain necessary resources from the MHD and other agencies related to COVID- 19.
- Obtain feedback from community groups regarding education materials.
- Assist community members and health field personnel to assess, plan for and provide needed health and related services.
- Represent and support the MHD COVID- 19 emergency response initiatives in the community.
- Attend community meetings and events and serve as liaison representing and supporting MHD interests.

Minimum qualifications include experience in community outreach, customer service, counseling, education, other work related to the above essential functions; related education may substitute for experience; Valid Driver's License and properly insured vehicle to be used on the job at time of

appointment and throughout employment. (These requirements have not yet been assessed by the Staffing Division).

# **Analysis and Recommendation**

The new positions of Temporary Community Education Assistant are necessary to effectively manage the City of Milwaukee's response to COVID-19. This title will be responsible for performing community outreach initiatives and duties related to providing the community with resources in response to the current COVID-19 pandemic. Additionally, the Health Department has expressed a need for this position to staff the expanding testing site. The title of Temporary Community Education Assistant is comparable in level and scope to the responsibility of the full-time Community Education Assistant in PR 5BN (\$30,530 - \$37,456) and therefore the same rates of pay are recommended for this temporary title.
