Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Good Morning –

I wanted to follow-up with you all regarding 3177 N 29<sup>th</sup> St. MHD, DNS and MPD stopped out at the establishment yesterday afternoon at 230pm and observed the store open and selling to the public. MHD issued a \$699 citation to the LLC for which the PIC, Yolanda, at the time refused to sign. Between MPD, MHD and DNS, the store was observed on 3 separate occasions over the last week operating after orders to cease on 8/7.

At the time of visit, Yolanda/PIC and myself spoke over the phone with a person named, Keisha, who claimed Shonta Smith, the owner, is currently in jail and that she is “operating” under her until she is able to fully purchase the business and take over ownership. Keisha claimed she came down to apply at City Clerk and pay fees last week under Shonta’s name and presumed she was approved to operate, but we know they were all well-aware of the current orders. This story though sort of checks out as we have been having no luck at getting in contact with Shonta throughout the last several months and presume someone has been standing in for her. Meanwhile, there is no active food or tobacco license. DNS Inspector Campbell also determined the building is not currently registered with the City/no occupancy, and is in bad shape and posing several health and safety concerns in and out of the building. They have a lot of work to do before ANY licenses will be issued, and hopefully this will be taken into consideration at the time of review.

I do want to provide our utmost respect and gratitude to Officers Nelson and Romo for their assistance yesterday. Between MHD, DNS and MPD we were able to approach this establishment safely, work through the issuing of citation, and identify several additional concerns that pertain to each our duties as city officials. We all agreed that these departmental collaborations are the most effective and productive approaches to the important work we do, as well as getting to learn more about the details of each other’s roles. We certainly invite MPD and DNS to reach out to schedule more stops together or when immediate food or tattoo-related concerns are identified in the field as we are typically quick to respond in a short moments notice, if requested. My line is open anytime!

Hello MPD 5 and Ald Jackson –

We wanted to alert you of the concerns we are having with the owner, Shonta Smith, and her operation 29<sup>th</sup> St Food Market at 3177 N 29<sup>th</sup> St.

First things first, is there any officer that would be able to stop to see if this establishment is currently open to the public? Milwaukee Health ordered them to close yesterday for not having a license (provisional expired) to operate and we received notice that they are potentially open today.

In order to get their license renewed, per their license file, they need to verify with LIU that they have a CPTED in place by alders request. We are not familiar with what that all entails here at Health, but we know this might take some time to complete before the license can be approved by the alder which is why we felt it's necessary also to alert the alders office of the extensive issues we have had at this location whether it be due to operating without a license,

rodents/cockroaches, non-compliance with other health orders, conflict with the persons representing the operation or significant safety concerns and altercations with patrons in and outside the establishment while our staff were conducting business.

Our other issue is that the owner, Shonta Smith, is evading communication with City staff and has made it very difficult for us and DNS to understand who is in charge. There are several individuals speaking for her and the business, but are misleading even to each other and have become contentious with our staff. Dept of Neighborhood Services has been requested to accompany us on the site visit to address the floor and ceiling integrity issues through the store, but they cannot complete their inspection without the owner, Shonta Smith, on-site. The floors and ceilings are significant health and safety risks at this point and they need to be addressed immediately before someone falls through.

We at Health determined we will no longer approach this without MPD assistance and our field staff is quite booked for the day. In the least, is MPD able to stop by this location to confirm if they are open and let us know?

The listed items are in related to the license business located at 3177 N. 29<sup>th</sup> Street, 29<sup>th</sup> Street Food Market.

1. On 01/28/25, at 4:02 p.m., officers were dispatched to a Trouble with Subject complaint. Upon officers' arrival the subject was no longer on scene. No business violations observed.
2. On 01/29/25, at 4:16 p.m., officers were dispatched to a Trouble with Subject complaint. The same actor from the prior day was at the business and an employee called for police service. Upon officers' arrival the subject was not located.

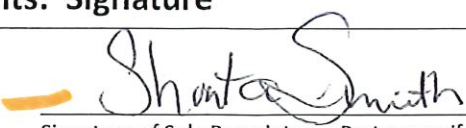
