Resolution recognizing the Institute for the Preservation of African American Music and Arts building and conceptual dedication held on June 1, 2018.

WHEREAS,

celebrated the building and conceptual dedication of the Martel C. Scott Campus and the William J. Tucker Campus on June 1, 2018 at the Swan Road and the Hampton Avenue Sites; and
