**COUNT 01: DELIVERY OF A CONTROLLED SUBSTANCE - COCAINE (1 GRAM OR LESS)
(As to Defendant Jamell Dent)**

On July 26, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly deliver 1 gram or less of cocaine, a controlled substance, contrary to Wisconsin Statutes sections 961.16(2)(b)(1) and 961.41(1)(cm)1g.

**COUNT 02: DELIVERY OF A CONTROLLED SUBSTANCE - COCAINE (1 GRAM OR LESS)
(As to Defendant Jamell Dent)**

On August 1, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly deliver 1 gram or less of cocaine, a controlled substance, contrary to Wisconsin Statutes sections 961.16(2)(b)(1) and 961.41(1)(cm)1g.

COUNT 03: POSSESSION WITH INTENT TO DELIVER CONTROLLED SUBSTANCE - COCAINE (MORE THAN 1 GRAM BUT LESS THAN 5 GRAMS) (As to Defendant Jamell Dent)

On August 1, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly possess with intent to deliver more than 1 gram but not more than 5 grams of cocaine, a controlled substance, contrary to Wisconsin Statute sections 961.16(2)(b)(1) and 961.41(1m)(cm)1r.

COUNT 04: BAIL JUMPING - FELONY (As to Defendant Jamell Dent)

On or about August 1, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, having been

charged with a felony and having been released from custody under Chapter 969 of the Wisconsin Statutes, did intentionally fail to comply with the terms of his bond, contrary to Wisconsin Statutes Section 946.49(1)(b).

COUNT 05: BAIL JUMPING - FELONY (As to Defendant Jamell Dent)

On or about August 1, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, having been charged with a felony and having been released from custody under Chapter 969 of the Wisconsin Statutes, did intentionally fail to comply with the terms of his bond, contrary to Wisconsin Statutes Section 946.49(1)(b).

COUNT 06: DELIVERY OF A CONTROLLED SUBSTANCE - COCAINE (1 GRAM OR LESS) (As to Defendant Sandra Morton)

On July 19, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly deliver 1 gram or less of cocaine, a controlled substance, contrary to Wisconsin Statutes sections 961.16(2)(b)(1) and 961.41(1)(cm)1g.

COUNT 07: DELIVERY OF A CONTROLLED SUBSTANCE - COCAINE (1 GRAM OR LESS) (As to Defendant Sandra Morton)

On July 21, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly deliver 1 gram or less of cocaine, a controlled substance, contrary to Wisconsin Statutes sections 961.16(2)(b)(1) and 961.41(1)(cm)1g.

COUNT 08: DELIVERY OF A CONTROLLED SUBSTANCE - COCAINE (1 GRAM OR LESS) (As to Defendant Sandra Morton)

On or about August 1, 2007, at 2155 S Kinnickinnic Av, City of Milwaukee, did knowingly deliver 1 gram or less of cocaine, a controlled substance, contrary to Wisconsin Statutes sections 961.16(2)(b)(1) and 961.41(1)(cm)1g.

COUNT 09: POSSESSION WITH INTENT TO DELIVER CONTROLLED SUBSTANCE - COCAINE (MORE THAN 1 GRAM BUT LESS THAN 5 GRAMS) (As to Defendant Sandra Morton)

On or about August 1, 2007, at 3445 S 24th St, City of Milwaukee, did knowingly possess with intent to deliver more than 1 gram but not more than 5 grams of cocaine, a controlled substance, contrary to Wisconsin Statute sections 961.16(2)(b)(1) and 961.41(1m)(cm)1r.

AS TO COUNT 01:

Upon conviction of this charge, a Class G felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 10 years or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

AS TO COUNT 02:

Upon conviction of this charge, a Class G felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 10 years or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement

assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

AS TO COUNT 03:

Upon conviction of this charge, a Class F felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 12 years and 6 months or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

AS TO COUNT 04:

Upon conviction of this charge, a Class H Felony, the maximum possible penalty is a fine of not more than \$10,000 or imprisonment for not more than 6 years or both.

AS TO COUNT 05:

Upon conviction of this charge, a Class H Felony, the maximum possible penalty is a fine of not more than \$10,000 or imprisonment for not more than 6 years or both.

AS TO COUNT 06:

Upon conviction of this charge, a Class G felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 10 years or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

AS TO COUNT 07:

Upon conviction of this charge, a Class G felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 10 years or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

AS TO COUNT 09:

Upon conviction of this charge, a Class F felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisonment for not more than 12 years and 6 months or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

I am a City of Milwaukee police officer and base this complaint upon police reports, which state the following:

On July 19, 2007 Officer Rodolfo Ayala called a number that he was given by a citizen informant and told to ask for Sandra. At approximately 9:37 p.m. Officer Ayala called the number he was given and asked for Sandra and he asked a woman who identified herself on the phone as Sandra if she was good. Sandra told Officer Ayala to meet her at the bar. At 10:15 p.m. Officer Ayala went to Chasers Pub at 2155 S. Kinnickinnic in the City and County of Milwaukee where he observed a black female that was later identified as the defendant Sandra Morton and a black male seated next to her who was later identified as the defendant Jamell Dent inside. Officer Ayala approached defendant Morton and asked her if he could get "two." Officer Ayala then handed the defendant Morton two pre-recorded \$20 bills and the defendant Morton gave Officer Ayala two clear plastic corner cut baggies with suspected cocaine base. Officer Ayala gave the suspected cocaine base to Detective Kohnert who subjected it to the Cobalt Thiocyanate Field Test. The substance tested positive for the presence of cocaine and weighed .43 grams.

On July 21, 2007 Officer Ayala called the same number again and spoke to an individual who identified herself as Sandra. He was told to meet at Chasers Pub. Officer Ayala entered Chasers Pub at 2155 S. Kinnickinnic and observed defendant Morton and defendant Dent in the tavern again. Officer Ayala approached defendant Morton and asked for two dubs and handed her two pre-recorded \$20 bills. Defendant Morton gave Officer Ayala two clear plastic corner cut baggies with suspected cocaine base. Officer Ayala gave those two corner cut baggies to Detective Kohnert who subject them to the Cobalt Thiocyanate Field Test and they returned a positive result for the presence of cocaine and weighed .36 grams.

On July 26, 2007 Officer Ayala called the same phone number and asked to speak to Sandra. The individual who identified herself as Sandra told Officer Ayala that she was on the north side but that her boyfriend was at the bar. She advised Officer Ayala that she would call him and tell him that Officer Ayala was on his way. Officer Ayala then went to Chasers Pub at 2155 S. Kinnickinnic and observed the defendant Dent sitting at the bar by himself. Officer Ayala approached defendant Dent and told him that he was a friend of defendant Morton and told him that he needed "two" dubs. Dent reached into his right pants pocket and retrieved a small clear envelope and Officer Ayala observed numerous clear plastic corner cut baggies with suspected cocaine base. Dent removed two of the clear plastic cut baggies with suspected cocaine base and handed them to Officer Ayala who handed defendant Dent two pre-recorded \$20 bills. The suspected crack cocaine was given to Detective Rehbein who subjected it to the Cobalt-Thiocyanate Field Test and it returned a positive result for the presence of cocaine base and weighed .37 grams.

On August 1, 2007 Officer Ayala called the phone number again and asked to speak to

Saundra. Individual who identified herself as Saundra said she was on the north side and that her boyfriend was on his way to Chasers. Defendant Saundra told Officer Ayala that she would be at Chasers later that night. At 9:35 p.m. Officer Ayala went to Chasers Pub on 2155 S. Kinnickinnic Avenue and sat next to defendant Dent and told him that he was looking for "two dubs." Defendant then reached into his right front pants pocket and handed Officer Ayala two clear plastic corner cut baggies with suspected cocaine base. Officer Ayala handed defendant Dent two pre-recorded \$20 bills. Officer Ayala gave the suspected cocaine base to Detective Rehbein who subjected it to the Cobalt-Thiocyanate Field Test and it returned a positive result for the presence of cocaine and weighed .46 grams.

At 11:17 p.m. Officer Ayala called the phone number again and spoke to Saundra and he asked her if she was at the tavern. The individual who identified herself as Saundra said she was at the tavern. At 11:22 p.m. Officer Ayala went into Chasers tavern at 2155 S. Kinnickinnic and observed the defendant Morton sitting at the bar. Defendant Dent was also seated at the bar. Defendant Morton approached Officer Ayala and engaged him in conversation and he advised her that he needed two dubs. Defendant Morton retrieved two clear plastic corner cut baggies with suspected cocaine base from her right front pants pocket and handed them to Officer Ayala. Officer Ayala handed the defendant two pre-recorded \$20 bills. The cocaine was conveyed to Detective Kohnert who subjected it to the Cobalt Thiocyanate Field Test and it returned a positive result for the presence of cocaine base and weighed .49 grams.

On or about August 1, 2007 at about 11:55 p.m. Officer Jason Enk and Officer Juarez received information from Officer Ayala that an undercover drug transaction had occurred inside Chasers Pub. Officer John Schott searched defendant Dent and recovered a small zip-lock bag containing 11 corner cuts of suspected cocaine base and the two pre-recorded \$20 bills that Officer Ayala had given him. Also recovered from defendant Dent was \$73 in suspected drug proceeds. The cocaine received from defendant Dent was conveyed to Officer Navarette who subjected it to the Cobalt Thiocyanate Field Test and received a positive indication for the presence of cocaine base with a weight of 2.39 grams. Complainant based upon his training and experience feels that the weight of the drugs along with the packaging is consistent with an intent to deliver cocaine.

Officer Juarez searched defendant Morton and recovered 13 corner cuts of suspected cocaine base from the defendant's left front shorts pocket along with two pre-recorded \$20 bills that Officer Ayala had given her. Also recovered from defendant Morton was \$142 in suspected drug proceeds. Officer Juarez conveyed the suspected cocaine to the Vice Control Division where she subjected a sample of it to the Cobalt Thiocyanate Field Test and received a positive result for the presence of cocaine with a weight of 3.62 grams. Complainant based upon his training and experience feels that the weight of and packaging of the drugs recovered from defendant Morton was consistent with the intent to deliver.

On August 2, 2007 officers searched defendant Morton's residence at 3445 S. 24th Street in the City and County of Milwaukee. Defendant Morton had given Officer Juarez consent to search her home. Inside the upstairs bedroom of the apartment officers located in the dresser drawer a knotted clear plastic bag containing an off-white chunky substance suspected to be cocaine base along with \$690 and a black digital scale. Located in a blue duffel bag on the floor of the bedroom where the dresser was, were numerous pieces of correspondence addressed to defendant Dent. Inside the dresser drawer were numerous pieces of correspondence addressed to defendant Morton. The cocaine base recovered was tested by

Officer Angela Juarez. Angela Juarez subjected the cocaine to the Cobalt Thiocyanate Field Test and received a positive result for the presence of cocaine base with a weight of 18.99 grams. Complainant, based upon the weight and packaging, along with the recover of the digital scales believes that the cocaine base was intended for distribution.

Detective Rehbein spoke to defendant Morton after advising her of her constitutional rights. Defendant Morton states that she lives at 3445 S. 24th St. and she has lived there for two years. She stated she is currently involved in an relationship with defendant Dent. She states that she has been selling cocaine for the past four or five months and that she is unemployed and needed to make money. She stated that she has been selling cocaine at the Chaser's bar on the south side of Milwaukee. She stated that she sold two rocks of cocaine to Officer Ayala on a few occasions.

A review of Milwaukee County Circuit Court Case #2007CF1970 reveals that defendant Dent was charged with the felony offense of Child Abuse - Intentionally Causing Harm, 948.03(2) (b). A review of Milwaukee County Circuit Court Case #2007CF1948 reveals that the defendant Dent is charged with the felony offenses of Felon in Possession of a Firearm, 941.29(2)(a) and Possession of Marijuana, 2nd or Subsequent Offense, 961.41(3g)(e). The files in both of these cases further reflect that the defendant was released from custody in those cases under the provisions of Wisconsin Statutes Chapter 969 with a condition that the defendant commit no new further criminal violations of law on both cases. The above-stated facts show that the defendant was in direct violation of the conditions of bond on both cases as recited above. Said file further reflects that the above-conditions of bond in both cases were in effect at the time of this offense.

A review of Milwaukee County Circuit Court Case #1994CF940454 reveals that the defendant Dent has a conviction of a drug offense under 161.41(1)(m). This conviction remains of record and has not been reversed.

This clearance report is being written by P.O. Robert GLOWINSKI, assigned to District Number Two, Early Shift. On Sunday, July 23rd, 2006, at approximately 12:44 A.M., while assigned to Squad 922D with P.O. Nicole REAVES, we conducted a license premise check at a tavern named Chasers Pub, 2155 South Kinnickinnic Avenue, with Squad 2E Michael KARWOSKI, Squad 627G P.O. John SCHOTT and P.O. 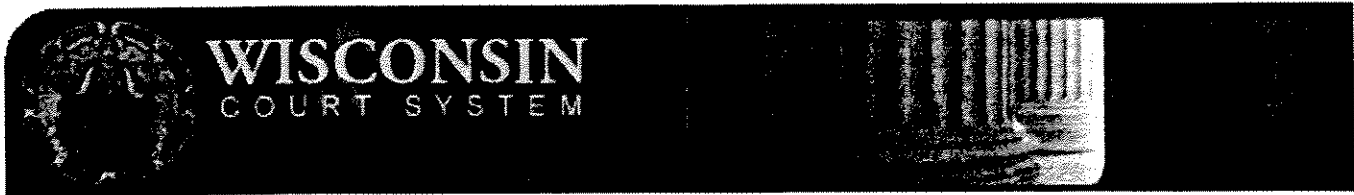

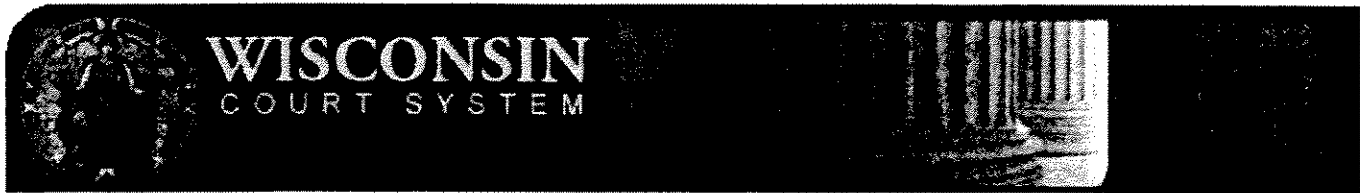

COUNT 01: POSSESSION WITH INTENT TO DELIVER CONTROLLED SUBSTANCE - COCAINE (MORE THAN 1 GRAM BUT LESS THAN 5 GRAMS)

On July 21, 2006, at 2155 South Kinnickinnic Avenue, City of Milwaukee, did knowingly possess with intent to deliver more than 1 gram but not more than 5 grams of cocaine, a controlled substance, contrary to Wisconsin Statute sections 961.16(2)(b)(1) and 961.41(1m)(cm)1r.

AS TO COUNT 01:

Upon conviction of this charge, a Class F felony, the maximum possible penalty is a fine of not more than \$25,000 or imprisoned for not more than 12 years and 6 months or both.

Upon conviction of this offense, the court shall suspend the defendant's operating privilege for not less than 6 months nor more than 5 years pursuant to section 961.50(1), Stats. If the court suspends the defendant's operating privileges the court shall impose a reinstatement assessment fee of \$50.00. If the defendant's driving privileges are already revoked or suspended, any revocation imposed must be served consecutively.

Complainant is a City of Milwaukee Police Detective and makes this complaint on information and belief which is based on review of City of Milwaukee Police Department reports which complainant believes are truthful and reliable.

Upon a statement of City of Milwaukee Police Detective Robert Rehbein who states that on

10/4/2007

Friday, July 21, 2006, he together with Detective Britt Kohnert and Officer Jason Enk of the Milwaukee Police Department were conducting surveillance at Chasers Pub tavern located at 2155 South Kinnickinnic Avenue, City and County of Milwaukee; that Detective Rehbein had previously received information that a white female, later identified as defendant Jennifer Hauglie was involved in selling cocaine both inside and outside of the tavern; at approximately 10:55 p.m., Detective Rehbein observed a black male identified as Ernest Harris walking back and forth in front of Chasers Pub for approximately five minutes. At approximately 11:00 p.m., Detective Rehbein observed a black four-door Cadillac parked in front of Chasers Pub; that the driver of the Cadillac was Jennifer Hauglie; that Hauglie entered the tavern briefly and then walked back outside and did a hand-to-hand transaction with Harris.

Upon a statement of City of Milwaukee Police Detective Britt Kohnert who states that he approached Ernest Harris and Ernest Harris stated that he was "just a smoker" and stated that he had purchased \$40 worth of crack cocaine from Hauglie; that Detective Kohnert recovered a foil wrapper containing what appeared to be crack cocaine from Harris.

Upon a statement of City of Milwaukee Police Officer Jason Enk who states that recovered \$40 from Hauglie's left hand and a plastic wrapper containing crack cocaine from her right front pocket of her jean shorts; Detective Rehbein recovered and searched Hauglie's person and recovered an additional \$900 in U.S. currency together with a sandwich bag containing what appeared to be marijuana.

Detective Rehbein subjected the suspected cocaine base recovered from Earnest Harris to the Cobalt-Thiocyanate Field Test and it tested positive for the presence of cocaine base with the weight of 0.42 grams without the containers.

Detective Rehbein further states that he subjected the suspected cocaine base recovered from Jennifer Hauglie to the Cobalt-Thiocyanate Field Test and it tested positive for the presence of cocaine base with a weight of 3.79 grams without the container.

Detective Rehbein further states that he subjected the suspected recovered from Jennifer Hauglie's purse to the Duquenois-Levine Field Test and it tested positive for the presence of tetrahydrocannabinol (THC), the active ingredient in marijuana, and weighed 7.17 grams without the container.

Upon a statement of City of Milwaukee Police Detective Brian Otzelberger who states that he interviewed Jennifer Hauglie who states that she is a bartender at Chasers Pub but had been inside the bar as a customer having a drink when Ernest Harris asked her if she was "good," meaning did she have any drugs and she said no and she would have to make a run; that she and her husband left and went to Hanks Again Bar at 7th and Cleveland and one of her suppliers was in there; that she got a little better than a "8-ball" (1/8th of an ounce of crack cocaine) and paid \$200 for it; that she went back to Chasers and Harris wanted a \$20 piece which she broke off and gave to him; that she and her husband then returned to Hanks because of a friend of theirs was there; while she was there she got a call from Harris who was at Chasers and she thought he asked her for a "ball"; that she returned to Chasers and once back at Chasers she met with Harris outside the bar and he stated he wanted a forty piece and she broke off a piece and gave it to him and he gave her four \$10 bills. The next thing she knew the police were there.

Detective Otzelberger further states that Jennifer Hauglie stated that she has been working at

Chasers for about one and half months and while there she saw other people selling and making money so she decided to start selling to make money; that she gets a lot of her crack through people she knew who used and sold; that she only sells while at the bar and she is a bartender there; that customers will ask and she finds out how much they want, goes into the bathroom, breaks off what they want and returns and gives it to them; that they give her the money by either setting it down on the bar or on a barstool and leaving; that unless she has some left over she doesn't go to the bar with her crack on her; if no one else in the bar has any then she'll call up and order up either a 16th or an 8-ball and have it delivered; that the marijuana she had on her person she bought for her husband and her uncle; she states she does not do drugs.

Detective Kohnert further states that he interviewed Ernest Harris who states he has been smoking crack for about 8 years and that he goes on a little party binge about once a month; that he had called up a white female he knows as "Jenny" using his cell phone to call Jenny's cell phone; that he has bought \$60 worth of crack cocaine from her today; that around 7:00 to 8:00 p.m. he bought \$20 worth of crack cocaine and then the \$40 worth of crack cocaine when they were both arrested; that Jenny is a bartender at Chasers Pub and that through a friend of his he has purchased crack cocaine from her on three or four prior occasions but today was the first time that he had bought from her directly; that after he gave her the \$40 and she gave him the crack cocaine the police rolled up on them; that as soon as the officer walked up on him he stated, "I'm a smoker, I got a forty in my pocket."
