This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 11/07/15, Milwaukee police were working the Wisconsin WINS Tobacco Initiative and had a 17 year old student enter 406 W Center Street in attempts to purchase tobacco products. The student purchased a 2 pack of Swisher Sweet Grape cigars for \$1.00 without being asked for ID from the clerk identified as Rana Anwar. Anwar was advised that he would need to enroll in the M.A.R.T.S program.
- 2. Applicant was cited for Sale of Cigarettes to Minor/Underage from incident # 1.

 On 05/10/16, Milwaukee police conducted follow up regarding a referral from the Heath Department for the Convenience Store Robbery Deterrence Safety training. Officers spoke with Rana Anwar and he stated he was aware of the next class that was scheduled for July 7th, 2016 and would be attending. Incident # 2 previously reported, disposition now added on 12/29/17.

4. On 09/24/16, applicant was cited for Sale of Cigarettes to Minor/Underage at 406 W Center Street.

5. On 08/11/18 at 10:15am a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Black and Mild Cigars at 406 W. Center Street, The sales clerk admitted to selling the item, but stated he only looked at the birth year on the drivers license. The station was mailed a MARTS enrollment packet.

- 6. On 12/27/19 at 6:21pm, Milwaukee Police conducted a license premise check at 406 W. Center Street. While inside the establishment, officers could smell, and see, cigarette smoke inside and observed cigarette ashes in a potato chip box next to products that were for sale. The station has four electronic slot machines that patrons smoke at while playing which was observed by officers while they were watching earlier security footage. Officers also found marijuana, packaged in small baggies for individual sale, inside a jacket that was left abandoned by the slot machines.
- 7. On 12/23/19 at 6:18pm, Milwaukee Police were dispatched to 406 W. Center Street for a subject with gun complaint. The complaint stated that there were a bunch of subjects at that location and one of them was waving a gun and other subjects were selling drugs and were located by the slot machines. No firearm was located.

Updated 01/26/21

8. On 01/21/20 at 12:21pm, Milwaukee Police along with Special Agent Georgeann KING of Wisconsin Alcohol & Tobacco, and Special Enforcement Inspector Lori GALLUP, conducted a compliance investigation at the location of 406 W. Center St. The investigation was regarding drug complaints, customers smoking in the location, and loitering panhandling issues. The business agent, Rana ANWAR was at the location during the investigation. Officers contributed the main factor to the complaints, being 4 electronic gambling machines in the lobby of the gas station. Officers located cigarette butts on the floor, throughout the gas station. Also there was a significant amount of cigarette butts, and ash near the gambling machines. Agent KING located several tobacco products in the gas station's inventory that were not properly purchased. Inspector GALLUP addressed the expired occupancy permit, issued an order for the public restroom to be repaired, and then reopened. Investigators found a currency disbursement receipt from one of the gambling machines. Agent KING did order the agent to remove the gambling machine under Wisconsin Statues after it was determined that the machines were not being used for novelty entertainment purposes. Officers informed the business agent that subjects are loitering in the lobby, playing the machines and using that as

a cover to sell drugs. The agent was cooperative and stated the machines are owned and controlled by ATS Novelties LLC, and will consider removing them.

- 9. On 02/17/20 at 12:35 pm Milwaukee Police conducted a license premise check at 406 W. Center Street. Officers observed four gambling machines in the front lobby part of the gas station. Officers spoke with the cashier on scene who stated that the gas station pays out on the machines and showed officers receipts from the machines. Officers looked over the current licenses of the gas station and discovered an entertainment license was not issued by the city, regarding the gambling machines. The agent Rana ANWAR was notified regarding the violations and issued citations.
- 10. On 02/28/20 at 10:20pm Milwaukee Police conducted a license premise check at 406 W. Center Street. Officers observed two subjects operating two of the four gambling machines in the front lobby. The subjects were instructed by officer to stop using the machines, and to leave the gas station, which they complied. Officers continued with the premise check and located near a rack of chips a clear Tupperware container with numerous multicolored pills. Officers suspected the pills to be ecstasy and the pills were later tested positive for Methamphetamine. Officers were informed that the gas station has had previous complaints of subjects selling drugs, and smoking in the store. The suspects would use the gambling machines to be at the location and conceal contraband with in the chip racks. Officers were allowed to review video and observed the two subjects being in the store for over a hour playing the gambling machines. Officers had knowledge from a license committee on 02/19/19 that the gambling machines were not to operated, and a violation of the business plan. The gambling machines could not be operated without an entertainment license through the city. It was confirmed through the online licensing system that a PEP license was not located or applied for. Officers order the clerk to shut down the machines, which he complied. The agent was later contacted and issued a citation regarding the gambling machines.
- 11. On 03/05/20 at 11:52pm Milwaukee Police conducted a canvass at 406 W. Center St, regarding a shots fired complaint at 2719 N. Vel R. Phillips St. Officers spoke with the gas station clerk who stated that he did not see or hear anything regarding the incident. The clerk allowed officers to review video surveillance. Officers discovered that the incident occurred in the parking lot of the gas station. The video revealed the victim's vehicle parked near two gas pumps. The suspect exits his vehicle and conducts a hand to hand transaction with the victim. The suspect vehicle then moves towards the east entrance, stops the vehicle, suspects then exits his vehicle to open the truck. The victim exits his vehicle then approaches the suspect and begins to fight with the suspect outside the vehicle. The victim's vehicle then moves to the front of the suspect and victim fighting. Both parties then get in their vehicles. From his vehicle the suspect fires three gun shots at the victim's auto. The suspect auto then exits west bound from the location. The victim sustained a single gunshot to his stomach.
- 12. On 07/27/20 at approximately 8:17am Milwaukee Police checked at 406 W. Center St for a scene regarding a shooting complaint. The gas station clerk allowed officers to review video surveillance. From Camera # 3 officers observed the suspect, and the suspect vehicle a tan/beige 2000's Dodge Caravan with no plates. From the camera footage officers observed the victim pull into the gas station in his vehicle, and begin to pump gas. A short time later the suspect vehicle moves towards the victim, and the suspect exits the passenger side of the suspect vehicle. The suspect and the victim engage in a conversation outside near the victim's vehicle. The victim is then seen hobbling away from the location eastbound. The suspect then location in the suspect auto with an unknown driver. The victim returns to his vehicle and

leaves the gas station driving southbound. Officers recovered one spent casing near the gas pumps.

- 13. On 12/19/20 at 9:56pm Milwaukee Police conducted a license premise check at 406 W. Center St. Officers observed four gambling machines along the east wall of the gas station. Officers spoke with the gas station clerk who stated that the machines have not been in use and had them unplugged. The clerk was asked by officers why the machines were still in the store if they were not in use, the clerk did not have an answer regarding. Officers did observe an amusement license on the gambling machines expired May of 2020. Officers did not observe or locate an entrainment license with the city for the machines. Officers contacted the agent regarding the license check, and confirmed that no application or license was in LIRA.
- 14. On 03/11/2021 at 3:26pm officers conducted a license premise check at BP gas station at 406 W. Center St. The officers spoke with the clerk about a standing trespassing complaint. The employee signed the form and he was provided with signs to post at the business.

15. On 03/24/2021 at 10:23pm officers conducted a license premise check at BP gas station at 406 W. Center St. The officer spoke with the manager, who stated he supports the standing no loitering complaint and welcomes additional police presence.

- 16. On 08/12/22 at 3:47p.m., Milwaukee Police were dispatched to a Shooting at 406 W. Center St. Investigation revealed two suspects approached the victim, who was parked at a pump, and discharged a firearm striking the victim and their vehicle. The officers recovered three casings in the lot. The employee was cooperative and allowed officers to view video surveillance of the incident.
- 17. On 10/31/22 at 5:49p.m., Milwaukee Police were dispatched to a Subject with Gun at 406 W. Center St. Investigation revealed the victim and suspect standing outside, exchanging words. The victim then goes inside, behind the glass partition. The suspect is seen tucking an object into their waistband and following the victim in the store, pounding on the glass, demanding money owed to them. The clerk stated the suspect displayed a firearm, so they called the police. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 18. On 04/11/23 at 10:30p.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. On arrival officers observed several people that are known to the officers as panhandlers, loitering around the building. Officers spoke to the employee who stated they have three no loitering signs posted and does not want them loitering. The employee stated when the police come the subjects leave briefly, however, return soon after. There were no violations and cameras were working and functional.

19. On 06/14/23 at 2:16a.m., Milwaukee Police were dispatched to a Shoplifting at 406 W. Center St. Investigation revealed a subject entered the store and began throwing items on the counter and the floor, however, did not take anything. The subject was no longer on scene and the employee was cooperative with the police.

- 20. On 06/21/23 at 1:23a.m., Milwaukee Police were dispatched to a Subject with Weapon at 406 W. Center St. Investigation revealed a subject entered the store and attempted to conceal items, however, the cashier confronted the subject. The cashier then locked the subject in the store, at which time the subject became agitated and began to throw items around, also taking a shovel and breaking a mounted plasma tv. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 21. On 06/28/23 at 7:35a.m., Milwaukee Police were dispatched to a Threat at 406 W. Center. Investigation revealed a subject entered the store and began to throw things around, made threats to the employee, then took pictures of the employee's vehicle. The subject was no longer on scene, and the employee was very cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 22. On 06/29/23 at 12:20a.m., Milwaukee Police were dispatched to a Battery at 406 W. Center St. On arrival officers attempted to interview the victim who was naked and bleeding from their face and head, however, the victim refused to speak to officers. The employee stated the victim walked into the business, naked and requested police services. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, however, it did not capture the entire incident as it took place on the street.
- 23. On 07/07/23 at 12:17a.m., Milwaukee Police were dispatched to a Shots Fired at 406 W. Center. Investigation revealed an employee's unoccupied vehicle was struck by gunfire, while parked in the parking lot. The employee stated they heard the gunfire, however, only saw the muzzle and did not get a description of the vehicle or subject(s).
- 24. On 07/12/23 at 3:24p.m., Milwaukee Police were flagged down by a citizen who stated they were assaulted at 406 W. Center St. The citizen stated they were inside the gas station, when they were accused of shoplifting. The citizen denied taking anything and stated the items they had were from another store. The citizen stated the employee then locked them inside and a security guard proceeded to strike them, causing them to bleed from the nose. Officers conducted follow up and spoke to the employee who stated the citizen is a known shoplifter, they have called the police on in the past. The employee admitted to locking the citizen in, however, denied a security guard being onsite and stated it was a frequent customer that got into a physical fight with the citizen. The officer attempted to view video surveillance of the incident, however, it was two days later, and were told the video did not go back to the incident date.
- 25. On 07/29/23 at 12:05p.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. This was in regards to a shooting unrelated to the property. A victim of a shooting made statements they work at the gas station and are paid under the table to provide security and clear the location of loitering. The officers interviewed an employee on scene who admitted to knowing the subject, however, denied they were employed in any way. The employee stated the subject loiters there frequently. The employee was advised the subject has been involved in numerous shooting and there exists a chance of incidents occurring there if they continue to allow them to loiter. The employee stated they will not allow the subject to loiter on their property in the future.
- 26. On 09/02/23 at 11:46p.m., Milwaukee Police were dispatched to a Subject with Weapon at 406 W. Center St. Officers interviewed the caller/employee who stated a subject entered and began throwing things around, then left items, without paying. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 27. On 09/11/23 at 12:12a.m., Milwaukee Police were dispatched to a Shots Fired in which multiple casings were recovered in front of 406 W. Center. Officers further observed a window to the gas station had been struck by gunfire. The officers interviewed the employee who stated they observed the window being struck by gunfire and ducked for cover. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 28. On 10/14/23 at 10:14p.m., Milwaukee Police were dispatched to a Shooting at 406 W. Center St. The officer interviewed the clerk who stated they heard 2-3 gunshots from the area of the pumps, and a subject exit a vehicle, run across the street, then return to the gas station and collapse on the ground. The clerk stated they did not see the suspect. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident. Video depicts a suspect armed with a handgun, discharge his gun toward the victim, then fled on foot.
- 29. On 11/15/23 at 11:43a.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. Assisting in this assignment were agents from Wisconsin Department of Revenue Alcohol and Tobacco and DNS. This was due to an anonymous complaint the business was selling single cigarettes. The officers did not find any evidence indicating the sale of single cigarettes, however, the DOR Agent did confiscate several boxes of tobacco products without invoices. The agent admitted via telephone to the Agent, the products were purchased illegally. The officer observed the business sells digital scales and fake tire gauges, which are typically used for narcotic use and sales. The DNS inspector issued a nuisance order due to a garbage violation.
- 30. On 01/02/24 at 9:33p.m., Milwaukee Police were dispatched to a Drug Dealing at 406 W. Center St. Prior to arrival the officers were advised multiple hand to hand drug transactions were taking place from a vehicle in the lot. On arrival officers observed the vehicle parked and conducted a Field Interview of the occupant. Officers detected a strong odor of marijuana emanating from the vehicle as well as a white powdery substance on the center console. An officer viewed video surveillance at the establishment and did observe multiple people walking up to the vehicle, conducting hand to hand transactions. A search incident to arrest revealed a back pack in the trunk of the vehicle containing suspected cocaine; suspected methamphetamine; and a green leafy substance suspected marijuana, as well as three scales. Officers also recovered a firearm with a switch and extended magazine, which was reported stolen.

The officers then conducted a License Premise Check of the establishment and found the store to be organized but messy. The cashier denied seeing the vehicle in the parking lot and stated they only look forward at customers and does not look outside at the pumps. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 31. On 03/12/24 at 11:23p.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. Officers were advised subjects were outside arguing, on arrival the officer did not observe anyone arguing.
- 32. On 03/28/24, Milwaukee Police took a walk-in DV-Robbery that occurred on 03/27/24 at 2:30a.m., at 406 W. Center St. Officers were advised by the victim; a known suspect

displayed a firearm and demanded the victim's car keys. The officer interviewed an employee who stated only the manager has access to the video surveillance system.

33. On 05/03/24 at 10:32p.m., Milwaukee Police were displationed to a Shooting at 406 W. Center. Investigation revealed two people were shot and approximately 10 casings were recovered at the scene. Officers viewed video surveillance which depicts multiple hand to hand drug transactions and people loitering prior to the shooting. The video further depicts subjects that had been in the lot for over an hour, carrying rifle style firearms strapped to the front of their bodies. Those two subjects were observed engaging in a conversation with two other subjects that arrived and parked at a pump. A physical fight takes place between the passenger and an armed subject, when gunfire is exchanged between both parties. The employee stated they did not see or hear anything nor did they call police, despite them being seen on video walking from behind the counter with several armed subjects both inside and outside of the business. A citizen was interviewed in an attempt to view their video surveillance, however, they stated due to recent burglaries in their garage, the direction of the camera was changed. The citizen further stated their house has been struck by gunfire on multiple occasions and therefore no one lives in the lower. The citizen stated there is heavy drug use at the business as well as people loitering and feels the business should close earlier to deter the criminal activity.

- 34. On 05/16/24 at 4:29a.m., Milwaukee Police were dispatched to a Shots Fired at 406 W. Center. Officers were advised by the caller who was awakened by a commotion followed by a gunshot. They observed several subjects beating another subject and stripping them of their clothes and demanding the victim's keys. Officers did locate a spent and live cartridge at the scene. Video surveillance depicts the victim pull into the business lot and approach a parked vehicle. The suspects slap something out of the victim's hand, then chase the victim off screen. The suspects return and get in the victim's vehicle and drive off. The victim later went to D5 to report the incident.
- 35. On 05/18/24 at 3:12a.m., Milwaukee Police were dispatched to a Welfare of a Citizen at 406 W. Center St. Officers were advised a couple were arguing outside the business, however, did not observe anyone engaged in an argument.
- 36. On 06/14/24 at 12:27p.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. Officers were advised a subject was smoking marijuana at the premise. The subject was gone on police arrival and the business was cooperative.
- 37. On 07/01/24 at 12:25a.m., Milwaukee Police were dispatched to a Noise Nuisance at 406 W. Center St. On arrival the officer did not observe any violation. The cashier stated a vehicle at the pumps earlier was playing loud music, however, they were in an out of the business.
- 38. On 07/24/24 at 5:41a.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. The caller stated they were battered by an unknown subject, however, refused medical attention and did not want to file a police report.
- 39. On 08/14/24 at 7:43p.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center. Officers were advised a juvenile that was causing problems, was no longer on scene. During the investigation the officer noted several expired food items and noted they had advised of the same violation a few months earlier. The officer further made note of a No Loitering sign, however, has observed loitering, pan handling and subjects drinking alcohol in the lot. The officer contacted the Agent and advised them of the investigation.

- 40. On 09/11/24 at 1:33a.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. Officers were advised there 8-10 outside causing a disturbance. On arrival no disturbance was observed.
- 41. On 09/21/24 at 3:30a.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. Officers were advised a subject was refusing to leave the bathroom. The subject left on officer's request.
- 42. On 10/10/24 at 9:25p.m., Milwaukee Police were dispatched to a Subject with Weapon at 406 W. Center St. On arrival officers were advised a subject on scene had threatened the cashier with pepper spray. The employee did not want to press charges; however, the subject had a warrant and was subsequently arrested.
- 43. On 10/30/24 at 12:54a.m., Milwaukee Police were dispatched to a Trouble with Subject at 406 W. Center St. The caller stated there were subjects outside yelling and causing a disturbance. On arrival officers did not observe a disturbance.
- 44. On 01/07/25 at 10:00p.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. Investigation revealed numerous expired food items. The officer contacted the Agent and advised them of prior incidents with expired food and the need to check the dates and remove expired food regularly.

Upon arriving at American Family Field, I called the victim, Staci MCDADE (w/f, 9-18-79) who stated she was not going to be at work until after 3pm. MCDADE stated we could meet her at her friend's home where she was for the time being and provided the address 1770 S Pearl St.

DELAYED REPORTING DV-ROBBERY

I spoke to the caller, Staci MCDADE (w/f, 9-18-79). They stated MCDADE stated that yesterday (3-27-24) at approximately 9:00pm, she ran into her ex in the area of N 4th St and W Center St and they spoke for a while. After speaking for a while they both went their separate ways, BURNSIDE in his car, MCDADE in hers. MCDADE stated they again ran into one another about an hour later in the area and had another conversation. MCDADE stated that this was also uneventful and that sometime around 2:30am (on 3-28-24), she was at the gas station near the air pumps on the south side of the building. She stated that during this interaction BURNSIDE asked, "When we going to smash?" and MCDADE informed him they wouldn't because it causes too many problems. At this point BURNSIDE became upset, pulled out a firearm and took her keys while armed with the firearm.

PO MCKINLEY spoke briefly with an unidentified employee who was not working at the time of the incident. He informed PO MCKINLEY that he does not have access to the video and that a manager would have to be contacted at a later time.

This license premise report is written by PO Nora BURLO, assigned to District 5, Late Power Shift, Sq. 5471 with PO James TERRELL.

On 5/3/24 at 10:32 PM, PO TERRELL and I were dispatched to the BP Gas Station, located at 406 W Center St, to check for the scene of a shooting (IR# C2405030171) at the gas station. As we continued to respond to the gas station, we were notified that the victim of the Shooting Complaint, had been parked at pump #1 and had been inside of a black Lincoln MKX (unknown plate). We were notified the victim stated there were two suspects regarding the shooting- one b/m wearing a black sweatshirt and one b/m wearing a green hooded sweatshirt.

Upon our arrival at the gas station, officers located a large amount of blood directly next to pump #1. There was one black sandal and one white sandal on the ground, on the blood. PO TERRELL placed our marked MPD squad vehicle along one entrance/ exit of the gas station and placed tape around the perimeter. I then located approximately 10 brass casings- 9mm and 40cal on the ground, concentrated on the N/W section of the parking lot.

I checked the surrounding vehicles and residences for any property damage that might have occurred. There was no property damage observed.

I spoke with a male subject, identified as *Flamond F E HIGHTOWER (B/M, 6/11/65)*, who stated he owns and lives at the address 418/ 420 W Center St, which is a duplex. He stated no one lives on the first floor of the residence because bullets have come through the walls from past shootings & shots fired incidents. HIGHTOWER then pointed out approximately 4 old bullet strikes to the EAST side residence. HIGHTOWER pointed out exterior surveillance cameras affixed to his residence and checked to see if the shooting was captured on his cameras. He informed me the shooting was not captured because he recently changed the direction of the cameras to directly face his driveway. He stated several male and female subjects loiter and use heavy drugs outside of the BP gas station constantly. HIGHTOWER stated unknown individual(s) had stolen items out of his garage. Due to that, he changed the direction the cameras faced. HIGHTOWER stated the BP gas station needs to close at a normal time and suggested 9:00 PM, instead of it being open twenty-four hours.

PO TERRELL was able to watch the gas station surveillance footage to see what had occurred. Due to this being an active shooting investigation this report will be a general summary of what occurred during this incident.

Multiple vehicles (white Dodge pick up truck, Blue Cadillac, and silver Dodge Charger) were parked in the gas station for more than one hour. Hand to hand drug transactions were observed between occupants of those vehicle with civilians standing in the gas station lot on the side of the build. A black Lincoln sedan parks next to pump #1 and two subjects are observed exiting the vehicle and entering the gas station to make a purchase. Two subjects carrying rifle style firearm strapped around the front of their bodies associated with the vehicles that had already been parked at the location. Those subjects are observed speaking to the two subjects of the black Lincoln sedan. The subjects of the Lincoln exit the location and walk towards their vehicle. The driver of the Lincoln sits inside of the vehicle. As the front passenger begins to sit inside the Lincoln, the gas station employee is observed walking from behind the counter and making a statement to the front passenger of the Lincoln. The front passenger then reenters the premise. As the front passenger of the Lincoln is making a purchase, he is confronted by an armed subject and then a second armed subject. The front passenger of the Lincoln exits the gas station and walks towards the Lincoln with an armed subject following him. The armed subject hands his firearm to an already armed subject and attacks the front passenger of the Lincoln. The subject with two firearm begins to point the firearm towards the driver of the Lincoln. Gun fire is then exchanged between multiple occupants of the vehicles originally parked at the gas station and the occupants of the Lincoln. Two subjects were shot in this incident.

There were multiple subjects observed inside of the gas station carrying and brandishing firearms for approximately 10 minutes prior to the shooting incident.

End of video surveillance summary.

PO TERRELL spoke to the clerk, *Jasvir SINGH (W/M, 10/8/83)*, who stated he did not see the shooting and did not hear anything. It should be noted that SINGH can be seen walking from behind the counter, while several subjects were seen with long guns and handguns inside and outside of the gas station. He never attempted to contact police officers and did not flag officers down when we arrived on scene.

There are no security guards working at the location and none hired on for security.

On Thursday, May 16th, 2024, I was working a replacement shift and assigned to Squad 5340, with PO Greg GREGORY. PO GREGORY and I were dispatched to the address of 406 W. Center St., located in the City and County of Milwaukee (WI), at approximately 4:29 AM, for a Shots Fired/Subject W/ Weapon complaint. This address is a business of operation, which is a BP Gas Station.

The initial caller, who verbally identified herself as Cornelius S KIRK (B/F 12-02-69), reported that there was a male getting beaten and stripped of his clothing. KIRK stated that she heard a gunshot and did not know if the victim was struck. KIRK stated that the subjects took the victim's vehicle, described as a white work van. KIRK also stated that the subjects were in a white sedan. KIRK stated that the victim was moving and that the victim was in the middle of the street. KIRK stated that all four subjects are males and that the victim went to the BP Gas Station, wearing no clothing. KIRK stated that all males were wearing masks and were telling the victim to give them his keys.

Upon our arrival, PO GREGORY and I did not observe anyone in need of police assistance. PO GREGORY and I asked the gas station attendant if anyone came into the gas station in need of help, and the gas station attendant stated no. PO GREGORY and I entered our squad vehicle and began to look for a possible victim in the area. A short time after, Dispatch advised PO GREGORY and I that our victim, later verbally identified as Kevin J HUTTNER (W/M 08-01-84), was at District 5 of the Milwaukee Police Department. PO GREGORY and I changed our location to District 5 to speak with HUTTNER.

I spoke directly to KIRK via telephone upon our arrival to the BP Gas Station. KIRK stated that she was asleep inside of her residence, and that she was awoken by commotion coming from outside. KIRK stated when she looked outside, she observed 4 men beating on a male subject. KIRK stated that the subjects were demanding the victim, HUTTNER, to give them his keys. KIRK stated that one of the male subjects said to HUTTNER, "I should have killed you, I should have killed you". KIRK stated that one of the subjects pulled out a gun and began to hit HUTTNER with the gun, and that is when she called the police to report what was going on.

PO Hector SOSA (Squad 5390) and PO Ray PEARSON (Squad 5390) reported to 406 W. Center St., to look for a scene. PO SOSA and PO PEARSON located evidence at the scene, including a spent casing, as well as a live cartridge. PO SOSA and PO PEARSON also were able to recover video surveillance footage of the incident (Refer to PO SOSA/PEARSON'S Supplemental Report for complete report, excerpt included).

Upon watching the surveillance footage of the BP gas station, SGT EDWARDS and I, observed A white 4 door Dodge Avenger, parked in the BP gas station at approximately 4:18am. At approximately 4:20 am, we observed a white Chevrolet express van pull into the gas station. The occupants of the dodge are 3, unknown black male actors, estimated to be between the ages of 17-25. The victim, later Identified as (Kevin J HUTTNER W/M 08-01-84) was seen walking up to the white dodge when he was confronted by one of the males. We observed one of the males slap something out of HUTTNERS hands and chase him off screen. The men returned a few minutes later and drove off in HUTTNERS white 2007 Chevrolet Express van, (AWJ-7755, VIN# 1GCFG15XX71157458), while some went into the Dodge and a white Toyota and drive off screen.

PO SOSA and PO PEARSON spoke with Lovedeep SINGH (W/M 09-25-90), who was working his assigned shift as the gas station attendant. PO SOSA stated that SINGH was cooperative during this investigation.
