Dear Mr. Langley,

In regards to C.I. File NO: 05-S-42, yes we wish to appeal this decision.

First of all my daughter, Kimberly Klein is a college student & Marquette University & never had a vehicle Stolen before. She is not all that familiar with Milwaukee & doesn't know any repair garages there, as she Usually comes home & has car check-ups & repairs done here locally in Manitowoc. She has no idea what Milwaukee's policies are in regards to (when a car is stolen & what to do) the officer Crystal Jacks (from District 1) was not very informative as to let Kimberly know what her options were other than being towed To the city lot.

This is how the incident happened. – Kimberly got out of work @ 2:30 a.m. in the morning (October 3, 2004) and came out to Her car and it was not there. Looked all around – NO CAR..... She called the police & then called us at Home in Manitowoc.

Four hours later her car was found on a different street (10-12 blocks) away from where Kimberly had parked it by her work. The window was busted & the trunk, also the dash was busted up & the ignition all busted, so the car could not be started. (( It was stolen, found 10-12 blocks away from Kim's employment, & in a "NO PARKING ZONE". """" BOTTOM LINE LINE – THE CAR WAS STOLEN, BUSTED UP, LEFT IN A "NO PARKING ZONE" AND WHAT ARE THE THIEVES GETTING OUT OF THIS????? But the innocent party (getting out of work @ 2:30 a.m.) all she wants to do is go back to her dorms and Get some rest ----- & she is in a predicament as to what to do plus then she has to end up paying the towing charge & also city lot rates for days there & she had nothing to do with this.. What are police officers for anyways, aren't they to protect the innocent???? Doesn't sound like it when it took Officer Crystal Jacks from the night of the incident (October 3, 2004 until December 17, 2004 to get to my daughter a Police report. Sounds like to me, your whole system needs to be looked at. It was another whole story When we came to the City Lot to pick up Kim's car ( THE RUDEST PEOPLE, I EVER MET). Not helpful @ all. Basicly wanted the money (\$115.00 cash ) & that was all, didn't want to answer any questions & I also had To ask for a receipt, they didn't even want to give me that.


After Kimberly got the report (more than 2 months from the incident) it was X-mas break from school & Kim could not be in the dorms, so was here in Manitowoc. So she did not get to go before the Prosecutor

until January 18, 2005 & then they told that the time had lapsed, and she would have to send a letter to get reimbursed . Well, I hope you reconsider. If anything I think the Officer should be liable. If Kim would have been properly informed and also would have gotten her report on a timely basis, all this could be done & over with.

Please review & reconsider, she is a student trying to work hard & study hard & trying to pay all her tuition And books etc.. (This bill of \$115.00 should not be her responsibility – THE THIEVES SHOULD BE PAYING.)

I thank you for reconsidering your decision.

My car was stolen on the night of October 3, 2004. Officer Crystal Jacks from district one responded to my call. Four hours later we found my car parked on a different street in a no parking zone broken into and damaged enough where the car was unable to start. Crystal Jacks wrote up the police report and told me to pick it up in two to three weeks at the district three office. Meanwhile she had my car towed to the impound lot. The next day the lot was open I picked up my car which had to be loaded on to my dad's trailer because it was unable to start. My total charges were \$115, which included the tow and the Sunday that it was sitting at the lot.

I arrived at district three office approximately four weeks later to make sure that the police report would be filed and that I would not have to return. I spoke with the man and he said there was no police report filed under my name. He then looked up the call that I made on Sunday, October 4<sup>th</sup> at approximately 2:30am, which is when I got off of work and realized my car was gone. He found the report she, Crystal Jacks, made over the computer that night and then showed me that at the end of it there is a code, I believe it was C8, which meant that it had not been filed yet. He then gave me the name of the police officer I dealt with, Crystal Jacks, and gave me a phone number to call district one to speak with her.

It is not the beginning of November. I then called district one and left a message on Crystal Jacks voicemail inquiring about my police report. I gave her my name the date and time of the event and the identification of my car. Two weeks later she returned my phone call stating that she had no police report or even notes in her notebook to remind her of my incident. She told me she needed to meet up with me again to write me up a new police report since she had never filed the original one and then lost it. I met with her on November 19, 2004, to be exact. She then wrote me a new police report and then again said I needed to wait another three weeks until it could be filed again.

I waited three weeks then called district three to see if there had been a report filed under my name. Still there was no report filed. I then took a different action and call the lieutenant of district one. I was furious. I left a message and he called back and I spoke with him and told him the situation and that I needed my police report filed so I could get my money back from when my car was stolen then towed. He then had Crystal Jacks call me. She called me and asked if she could mail to my address the police report so I would receive it faster. I waited. Then a week later she called me again. She did not mail my report to me yet. I was even more irate. She asked if she could drop it off at the Marquette University dorms where I live. Friday, December 17, 2004 at midnight I FINALLY received my police report.


This is somewhat ironic because the very next day Saturday, December 18, 2004 was the day to move out of the dorms and Marquette University because they close over winter break. So until January 18, 2005 I was not in Milwaukee and unable to come to
