<u>DPW-INFRASTRUCTURE SERVICES DIVISION</u> Salaries & Wages Equipment	\$80,000	\$80,000	The 2012 Carryover file included \$80,000 for the purchase of two 2-ton dump trucks used for street maintenance. These funds were carried over from the 2012 Salary Account and need to be transferred to the Equipment Account.
<u>DPW-INFRASTRUCTURE SERVICES DIVISION</u> Salaries & Wages Operating	\$100,000	\$100,000	The 2012 Carryover file included \$100,000 for additional paving materials for the repair of utility cuts. These funds were carried over from the 2012 Salary Account and need to be transferred to the Operating Account.
<u>DPW-INFRASTRUCTURE SERVICES DIVISION</u> Salaries & Wages Operating	\$135,000	\$135,000	The 2012 Carryover file included \$135,000 for contracted crackfilling for street maintenance. These funds were carried over from the 2012 Salary Account and need to be transferred to the Operating Account.
<u>SEWER MAINTENANCE FUND</u> Payment to Debt Fund on Prior GO Debt Debt Service - Sewer Maint.	\$3,500,000	\$3,500,000	2013 Debt service for commercial paper was budgeted under the prior GO debt account. This is new debt and expenditures will be charged under the general Debt Service Account for Sewer Maintenance.
<u>DPW-WATER WORKS</u> Fringe Benefits Pension Contribution (R648)	\$650,000	\$650,000	Provides appropriation to cover the full amount of MWW's additional required pension payment. The payment is tied to the city's pre-payment of Plan Year 2013 pension obligations, and will save Water considerable funds in future years.
