Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/05/23 at 8:47pm, Milwaukee Police were dispatched to 3381 N. 35th St, for a welfare check. Officers arrived and observed a subject who appeared to be intoxicated and refused to identify them self. The agent spoke with officer and stated that the subject knocked over items and he wanted her removed from the location. Officers conveyed the subject off the property.
- 2. On 04/24/23 at 4:58pm, Milwaukee Police were dispatched to 3381 N. 35th St, for a threat complaint. Officers spoke with the employee who stated that a customer threatened to harm him. The employee was cooperative with police and provided video.
- 3. On 04/26/23 at 11:49am, Milwaukee Police were dispatched to 3381 N. 35th, for a theft complaint. Officers spoke with the employee who stated that a subject took items without paying for them. The employee was cooperative with the investigation and showed officers video of the incident.
- 4. On 04/29/23 at 2:03am, Milwaukee Police were dispatched to District 7, for a shooting complaint. The victim sustained one gunshot wound to the leg. The victim spoke with officers stating the incident occurred at 3381 N. 35th St. At the location officers located the shooting scene, with multiple casings recovered outside the business location. The business was cooperative providing video of the incident. The video footage showed the incident in its entirety as well as suspect and vehicle descriptions.

- 5. On 05/25/23 at 10:54pm, Milwaukee Police were dispatched to 3381 N. 35th St, for an armed robbery complaint. Officers spoke with the caller, who stated that he was robbed at gun point, and his back pack with items was taken. The caller stated that an unknown suspect asked if he wanted a ride to the gas station, the caller accepted. The suspect took the caller to the gas station, and gave him money to purchase items from the gas station, leaving his back pack in the vehicle. The caller was refused service returned to the vehicle where the suspect pointed his gun to his chest demanding his property. The investigating officer found the caller's story to be inconsistent and spoke with the employee of the gas station. The employee provided video and video confirmed the suspect did not point a hand gun and left when the caller exited the vehicle with the back pack. The officers filed a report for the back pack taken.
- 6. On 06/05/23 Milwaukee Police were dispatched to 3381 N. 35th St, for a battery complaint. The caller stated that she was at the location and saw a group kids and wanted to prayer for them. The security guard came over and told the caller to leave the kids alone. The security guard then push the caller on the ground and told her to leave. Officers arrived at the location and reviewed video regarding the complaint. Officers observed the caller continuing to exit her vehicle and yell at security refusing to leave. Also observed was the security guard pushing the caller back in her vehicle telling her to leave. The video did not corroborate the caller's allegations.
- 7. On 06/14/23 at 6:40am, Milwaukee Police were dispatched to 3381 N. 35th St, for shooting complaint. Officers arrived and located the victim in the business who had a gunshot wound, and was unconscious. Milwaukee Fire Department arrived and conveyed the victim to Froedtert Hospital for treatment. One casing was recovered outside the location. The business was cooperative and provided video of the incident in its entirety. The video footage showed the victim approached by two suspects and one of the suspect's takes the victim's phone from the victim. The victim struggled with the suspect over the phone and the other suspect discharged a gunshot striking the victim.
- 8. On 06/19/23 Milwaukee Police respond to Froedtert Hospital for a battery cutting complaint. Officers spoke with the victim who stated that he fought with a known subject outside the location of 3381 N. 35ths St. during the fight he got stabbed by some scissors. Officers responded to the address of 3381 N. 35th St, and spoke with the employee who was unware of the incident. The employee was cooperative with the investigation providing officers access to the video surveillance. Officers could not locate a scene or evidence of the battery cutting at the location.
- 9. On 06/22/23 at 12:02 am, Milwaukee Police were dispatched to 3381 N. 35th St, for a shot spotter complaint. Officers arrived and were notified that the person who shot gun fire fled already. Officers did not observe any victims of gun fire and located numerous casings on the parking lot of the business. Officers spoke with business who provided video of the incident in its entirety. The video provided the suspect, and suspect description wanted for the shots fired in the area.
- 10. On 08/19/23 at 4:43am, Milwaukee Police were dispatched to 3381 N. 35th St for a shots fired complaint. Officers arrived and spoke with the employee who stated that a ground of younger subjects were outside the location and an altercation occurred. On the subjects then fired on gun shot during the altercation. The business was cooperative with the investigation and provide video of the incident. The video shows a subject purchasing an items armed with a hand gun at his side. Then 3 younger suspects approached behind the subject and attempted to get the handgun. All parties spilled outside the location and the handgun was discharged by

the subject. The 3 suspects fled on foot form the location and the subject left the location on a bicycle. No calls were made to police from the subject who discharged the handgun.

- 11. On 09/08/23 at 12:50pm, Milwaukee Police were dispatched to 3381 N. 35th St for a trouble with subject. Officers spoke with the employee who stated that a subject was outside the location pan handling. The subject left prior to police arrival.
- 12.On 12/18/23 at 7:47am, Milwaukee Police were dispatched to 3381 N. 35th St for a trouble with subject. Officers arrived to the location and spoke with the employee who wanted a subject to leave the location but she refused. Officers spoke with the subject who refused to leave, and was uncooperative. The subject was taken into custody, cited and released form District 7.
- 13. On 01/0/324, at 5:35am, Milwaukee Police were dispatched to 3381 N. 35^{th St} for a fight complaint. Officers arrived and spoke with a subject standing outside who appeared to be intoxicated. The subject stated that a subject tried stealing from him, inside the store. Officers then spoke with the employee who stated that the subject outside and another subject no longer on scene fought in the store. Officers reviewed video provide by the employee. Officers then further attempted to speak with the subject outside, who did not want any police services.
- 14. On 01/29/24 at 5:44am, Milwaukee Police were dispatched to 3381 N. 35th St for a violation of restraining order. Officers spoke with the employee who stated that a known subject he has restarting order against struck in him in the face. The subject fled the area, and officers observed the subject but were unable to apprehend the subject. Officers reviewed the video of the incident and filed reports regarding the violation.
 - 15. On 01/30/24 at 6:25 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Violation of Restraining Order. A subject who had an open Court Order related to the business was on the property. An employee stated they did not call for police service, leading officers to believe that employee feared for their safety, but refused to be a complainant due to possible retaliation .
 - 16. On 04/28/24 at 4:40 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Theft complaint. An employee reported that a group of subjects entered the business at approximately 2:23 AM., and walked out with \$50-\$60 dollars' worth of merchandise without paying. The employee went outside asked the subjects to pay for the items, and was handed \$6 dollars before all subjects fled in a vehicle. Security footage was obtained of the incident and no license violations were observed.
 - 17. On 05/01/24 at 9:25 AM., A Milwaukee Police officers conducted a Crime Prevention Through Environmental Design (CPTED) inspection, at 3381 N. 35th Street. The officer advised the agent and their attorney, "No Trespassing" signs needed to be posted as part of their Nuisance Abatement agreement. A rear fence should be repair to control access onto the property. The business was deemed an 80-10 Nuisance Property due to four separate shooting, which occurred at the property between August 2022 to June 2023.
 - 18. On 05/05/24 at 9:48 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street for a Theft complaint. The victim allowed an unknown suspect who was asking for change into their car. The suspect produced a handgun and demanded the victim's purse. Security footage was obtained and no business violations were observed.

- 19. On 05/25/24 at 4:50 PM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Reckless Endangering Safety complaint. An unknown suspect produced a handgun and made threats to shoot the victim. An employee told the victim to walk to the back of the business for their safety. The suspect left the business and the victim called for police services at a secure location. Security video was obtained of the incident.
- 20. On 05/29/24, A Milwaukee Police officer interviewed a victim who stated, on 05/28/24, at approximately 9:00 PM., while sleeping in a vehicle parked at 3381 N. 35th Street, they were sexually assaulted. The victim did not want to formally report the sexual assault.
- 21. On 06/23/24 at 1:35 PM., Milwaukee Police officers were dispatched to 3381 N. 35th Street for a Trouble with Subject complaint. An unknown subject was outside of the business loitering and causing a disturbance. Officers requested the subject leave and they complied without incident.
- 22. On 06/27/24 at 8:30 PM., A Milwaukee Police officer had a victim walk into the District to report a car theft. At approximately 4:00 AM., the victim allowed an unknown suspect to take his vehicle for a test drive, and the vehicle was never returned. An officer followed up at the business, checked security camera footage, but could not confirm the incident took place at the property. No license violations were observed.
- 23. On 08/21/24 at 4:37 PM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Trouble with Subject complaint. An unknown customer became upset and caused a disturbance after they had problems with their prepaid card at the pump. Security video was available.
- 24. On 09/09/24 at 1:18 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Trouble with Subject complaint. An unknown subject was on the property panhandling. Upon officer's arrival the subject was gone. No business violations were observed.
- 25. On 09/09/24 at 1:59 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Trouble with Subject complaint. No disturbance was observed nor police action taken.

Additional investigation revealed the victim fled from 3381 N. 35th Street, with items they stole. An unknown suspect who was at the business, followed the victim off the property before firing shots at them. Security video was obtained from the business.
- 27. On 10/08/24 at 10:08 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street, for a Subject with Weapon complaint. An anonymous caller stated an unknown subject was at the property making threats and had a gun. Officers were able to determine the subject did not possess a gun and suffered from a mental health condition, but was not in destress. The subject left the area on their own without incident. Security video was obtained from the business.
- 28. On 01/03/25 at 6:42 AM., Milwaukee Police officers were dispatched to 3381 N. 35th Street for a Welfare Check. An unknown female entered the business and requested the employee call them an ambulance. Upon officers' arrival Milwaukee Fire Department members were

SINGH stated that he did not call the police for this and does not know who did.

I did not speak to the licensed premise owner due to him not being on site.

It is my belief that SINGH called the police to report this incident but when when we arrived he refused to be a complainant. He gave indications that he was afraid of what the subject may do to him if the police were involved.

Upon our arrival I was met by the store worker who stated earlier in the night at approximately 2:23 AM a group of subjects entered the gas station and grabbed approximately \$50-\$60 dollars' worth of miscellaneous items. Store worker stated subjects then got in a vehicle bearing WI License plate APM-7697.

The store worked was identified as Gagandeep SINGH (U/M 01/27/1999) who was then able to show me surveillance footage of the incident. Upon viewing the footage, I was able to see multiple what seemed to be adult B/M's and B/F's. They all proceed to grab items such as drinks, chips and snacks. items are put in a bag, and they all walked out. SINGH went outside to ask the subjects to pay, and subject handed him \$6 dollars.

I was also able to see the License plate on the vehicle APM-7697. Vehicle was last seen going westbound on W. Townsend St. from the gas station.

the vehicle listed owner is a Shawnee L PORTIS (B/F 01/21/1992) she resides at 2511 S. 43rd St.

Vehicle was a BLK, 2019 GMC Terrain VIN# 3GKALVEX1KL365621.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the theft, I did not observe any violations in the licensed premise.

I will attempt follow up at a later date regarding the vehicle and hopefully identify the subjects seen on video to issue citations for theft.

Dominique THOMPSON and Squad 7269 P.O. Theodore CHANDLER.

Upon our arrival we observed no trespassing signs are around the building. The issue was with panhandlers standing outside the gas station interrupting the flow of traffic for paying customer. The fence in the rear of the business on the southwest corner has a space that is open without the proper fencing and people can enter the parking lot of the gas station from the alley. We suggested that the business could finish the fence to cover that open entrance. Therefore, moving forward nobody will have access to the alley from the business.

I spoke to licensed owner, Kulwant Dhillon and his attorney Austin Baldwin. We informed the owner, Kulwant Dhillon and his attorney Austin Baldwin that apart of the nuisance abatement agreement that is should be "No Trespassing" signs that must be in front and in the rear of the exterior of the property. Kulwant and Austin stated that they will get the signs today. We also wanted to know and informed the owner Kulwant, why he hasn't been attending the District Seven Crime and Safety meeting? Which was a part of the abatement plan for the past twelve months and Kulwant has only attended two Crime and Safety meetings. Kulwant stated that he forgot about attending the crime and safety meetings. Austin stated that he will give a copy of the Crime and Safety schedule to Kulwant so he can start attending. Kulwant has been complying with getting cameras in the rear of the business and more outside lighting. Kulwant has no loitering, no weapons and no loud music signs posted around the business, and he did hire a security guard that works Tuesday - Sunday from 9pm - 5am.

Kulwant business has been in nuisance since May 3, 2023, for 3 shooting: August 10, 2022, October 23, 2022, and April 29, 2023. The 4th shooting happens on June 14, 2023.

- 1. On August 10, 2022 at 2:46 A.M. a call was placed to the Milwaukee Police Department regarding a shooting at the premises. This call for service was given computer aided dispatch # 22-222-0170. Officers were dispatched to the location to check for a shot-spotter complaint at approximately 2:54 A.M. a shooting came into St. Joseph's Hospital with a victim that was shot at your establishment. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
