Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. - On 11/11/2021 at 10:22pm officers were dispatched to a Shooting at Clark gas station, 2175 N. 35th St. The officers interviewed the clerk, who stated there was no shots fired and no shooting in the parking lot. The clerk stated there are no exterior cameras and the interior cameras do not record.
- 10. On 02/02/2022 at 11:17pm officers were dispatched to a Shooting at Clark gas station, 2175 N. 35th St. The officers located a victim inside the station with gunshot wounds to his hand and foot. The scene was located in the alley behind the gas station. The victim stated he was walking to the gas station when he heard gunshots and felt pain. He then ran into the station to call police. The employees were cooperative. The officers were able to access the video system but found the system has not been recording since June 2021.

11. On 05/30/23 at 10:30pm, Milwaukee Police were dispatched to 2175 N. 35th St, for an armed robbery/carjacking complaint. Officer spoke with the victim, who stated that her vehicle was taken at gun point, while she was parked at the gas station. The victim stated that the suspects took her vehicle without consent and left the area in her vehicle. Officers reviewed video of the incident obtaining suspect's description and actions of the incident. Officers were able to located the victim's vehicle unoccupied parked a few blocks away. The vehicle was towed to the city tow lot for investigative purposes.

12. On 07/03/23 at 5:25pm, Milwaukee Police were dispatched to 2175 N. 35th St, for a shooting complaint. Officers located the victim lying on the floor of the business with a gunshot wound to the knee area. The victim stated that he was pumping gas at the location. While getting gas an unknown vehicle, pulled behind his vehicle and gun shots were fired towards his direction. The victim stated that he did not see the shooter. Officers spoke with the clerk regarding video. The employee stated that the exterior cameras were not operable, and no surveillance footage was recovered of the incident.

The following items pertain to 2175 N. 35th St.

13. On 12/15/24 at 10:23p.m., Milwaukee Police were dispatched to a Subject with Weapon. Investigation revealed this was a baseless call and only a dispute between two subjects.

14. On 01/22/25 at 12:36p.m., Milwaukee Police were dispatched to a ShotSpotter. Investigation revealed this was a shooting, however, had nothing to do with the business other than one of the suspects was seen on video surveillance entering and leaving the business.

- 15. On 07/10/25 at 3:38p.m., Milwaukee Police were dispatched to a Robbery. Officers were advised a suspect robbed the victim at gunpoint, while they were pumping gas. The caller then ran to another business to call police. The business was cooperative and allowed officers to view video surveillance, however, at the time of the incident only interior cameras were working.
- 16. On 08/26/25 at 8:45p.m., Milwaukee Police were dispatched to a ShotSpotter. The officer located 8 casings near a pump. The employee stated they observed a subject strike another subject inside the business, then both exit the store. The employee stated they did not see or hear shots fired, but was alerted by other customers. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is written by Jonathan STEINBERG, assigned to DISTRICT 3 Late Power SHIFT, 3430.

On Sunday, December 15, 2024, at 10:23 p.m., Squad 3430 (myself and P.O. DALESSANDRO) was dispatched to 2175 N. 35th St. for a subject with weapon call for service.

Upon our arrival we observed the caller, who was identified as Wesley Q. VAN (B/M, 12/03/79) standing in front of the gas station. WESLEY stated the subject, who pointed a firearm at him was inside the gas station. WESLEY stated the subject was wearing red pants and had a firearm. The subject WESLEY stated pointed a firearm at him walked out of the gas station. We detained the subject, who was later identified as Bobby R. GREER (B/M, 06/14/03). WESLEY was uncooperative with our investigation and refused to stay on scene. WESLEY refused to speak with me and wanted to speak to other officers on scene. WESLEY walked off going north bound on N. 35th St. from W. Garfield Ave. GREER stated he gave kids outside the gas station a dollar and WESLEY became angry and upset with him, because he interrupted his prayer session. We requested additional squads for back up. Squad 3450 (P.O. BUELOW and P.O. BUELOW) responded to the scene. I spoke with security officer Elijah J. HUNT (B/M, 03/22/97), who stated WESLEY was inside the store talking loudly and appeared to be having an altercation with GREER. HUNT stated WESLEY then got on his phone and called police and stated GREER had a firearm. HUNT stated GREER never had a firearm. HUNT stated he told GREER to go outside and speak with us. I also spoke with the cashier, who was identified as Singh BALVIR (W/M, 01/12/63). BALVIR stated WESLEY inside the store and was being loud and aggressive towards him. BALVIR stated WESLEY had a problem with GREER, but did not know why. BALVIR stated GREER did not have a firearm. BALVIR stated the cameras in and outside the store were not working.

The subject with gun complaint called in by WESLEY was determined to be baseless.

This report is submitted by P.O. Adam GONZALEZ, assigned to District Three, Day shift, 3130.

On Wednesday, 01/22/2025 at approximately 12:36 p.m., Squad 3233, P.O. Ryan SHARP and P.O. Antonio OBREGON, Squad 3233 were in the area of N. 35th Street and W. North Avenue when they heard two shots fired in the nearby area.

While checking the area and notifying dispatch of the shots squad 3233 were notified of a Shot Spotter complaint at the location of 2201 N. 35th Street for four rounds in the street. While continuing to check they were flagged down by a citizen who stated a black truck with a black male occupying it was shooting at something.

While in the area on an unrelated assignment, my partner (P.O. HAYES) and I were flagged down by 3 subjects who stated that they were shot at. The individuals were later identified as Rashaad K TURNER (B/M 8-17-2005), LANDON L BASON (B/M, 7-27-2009), and Lemoris C FLINN (B/M, 5-20-2009).

While speaking with the individuals, TURNER stated he believed he was shot and after rolling up his pants, it was determined he suffered a gunshot wound to his left leg. BASON then discovered a hole in his hooded sweatshirt and started to feel the top of his head, which is when he felt blood on the top of his head, believing he was also shot.

FLINN who was with BASON and TURNER at the time of the incident was not shot but initially stated they were standing on the north side of the gas station on W Garfield Ave in the 3500 block. FLINN stated that the three of them were on the south sidewalk when a black SUV exited the gas station parking lot driving westbound on W Garfield Ave. When the SUV passed them, the passenger, who he described as a black male wearing a black ski mask and black hooded sweatshirt perched himself on the front passenger window ledge and began shooting at them over the SUV. FLINN stated he heard approximately 6 gunshots. FLINN described the driver of the SUV as a unknown female wearing a black jacket and gray sweatpants.

During the investigation P.O. OBREGON located one casing in the street just east of N. 36th Street on W. Garfield Avenue. He also viewed one of the suspects entering and leaving the gas station parking lot. The suspect was described as a 20-30 year old, black female, heavy set, med complexion with long braids to the butt. She was wearing a pink puff jacket with a white hooded sweatshirt and black leggings with a gray/black snow boots. The other suspect was described as a black male with a black sweatshirt.

Detective OSMANSKI reviewed video surveillance, which shows the following:

At 12:27:00 a dark colored what appears to be Ford, possibly an Escape is seen traveling north on N. 35th St when it turns into the parking lot and parks at pump #4.

At 12:31:00- possible victims are observed walking westbound on W. Garfield Av and pass the windows

At 12:32:57 a female gets out of the car and enters the store. She goes to the register and makes a quick transaction and then leaves the store and goes back to the vehicle.

At 12:35:01 Ford vehicle pulls out of the north end of the parking lot and turns to go west on W. Garfield Av. Just after this, victim is seen in the window and then at 12:35:16 all three victims are seen running

It is unknown if anyone checked the business for its licenses but according to the City of Milwaukee license search the business has the following licenses with an expiration of 11/17/2025

Cigarette & Tobacco, Filling Station, Food Dealer Retail, and Weights & Measures.

The business was not directly involved but aided the investigation by providing video.

We made contact with the gas station clerk who stated there were no incidents to report today and there have been no issues at this establishment. The clerk was cooperative with the investigation.

This report is written by Police Officer Ricco DALESSANDRO, assigned to District 3, Late Power Shift, Squad 3430.

On Tuesday, August 26th, 2025, at 8:45 P.M. Police Officer Jonathan STEINBERG and I (Squad 3430, in full duty uniform, operating a marked MPD squad equipped with Axon body worn cameras affixed to our outermost garment and recording at the time of this incident) were dispatched to 2175 N. 35th St., which is located in the City and County of Milwaukee, for a ShotSpotter (Flex ID 81-1240080) call for service.

Upon arrival PO STEINBERG located 8 brass casings on the cement near pump #4.

I then entered the Clark filling station and made contact with the business agent verbally identified as Harjinder SINGH (M/W 05/18/1992) and interviewed him regarding this incident.

SINGH stated that he witnessed a customer strike another customer in the face while he was working the register. He stated that both subjects then exited his store, and he continued to work. SINGH stated he did not see or hear any shots fired and was only alerted to the situation by his customers. He stated when he did look outside, he observed someone running.

SINGH cooperated with the investigation and showed me a monitor located behind the counter which displayed multiple live camera feeds. This screen displayed multiple camera angles which capture both the inside and outside of the location. All cameras appeared to be functioning properly. I was able to recover video of the incident from exterior camera 09 and interior camera 03. Video of the incident has been uploaded to Evidence.com.

While on scene, I observed the licenses posted and they were up to date.



- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
