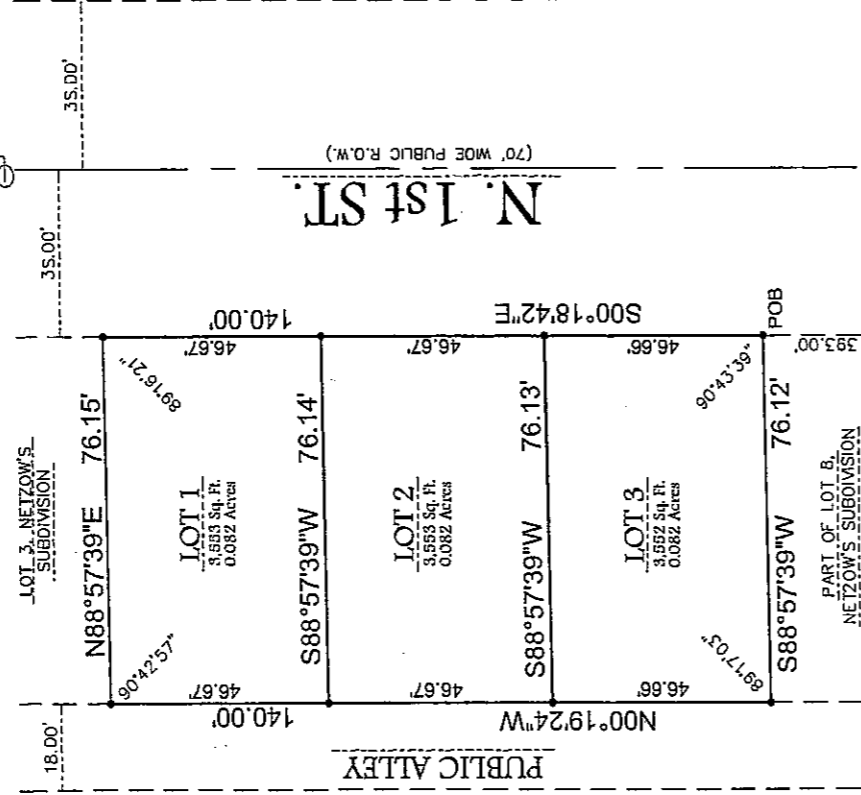

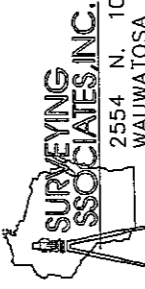

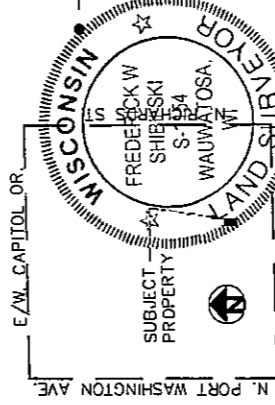

I, Frederick W. Shibilski, a registered land surveyor do hereby certify:

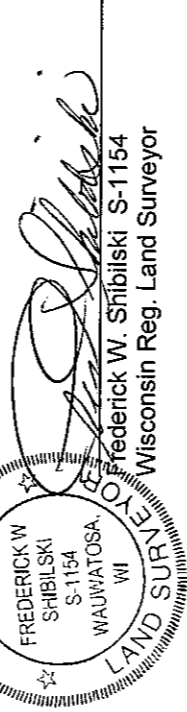

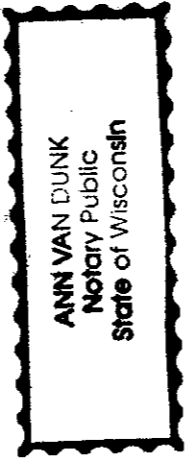
