Dear Mr. Hibbard:

This office is in receipt of your claim in the amount of \$115.00, relating to the towing of your vehicle on April 23, 2003 for blocking an alley after being stolen from 3841 West St. Paul Avenue.

Our investigation reveals that your vehicle was towed for being illegally parked on April 23, 2003. You retrieved the vehicle from the tow lot on April 24, 2003. According to the Milwaukee Police Department Vehicle Theft Report, you reported the vehicle stolen on April 29, 2003, nearly a week after it had been towed. The tow report indicates that you met with the Parking Citation Review Manager on June 25, 2003 and your request to have the tow fees refunded was denied because you reported the vehicle stolen after it had been towed. In addition you authorized the towing of the vehicle upon recovery. The City followed proper procedure, accordingly your claim is denied.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
