

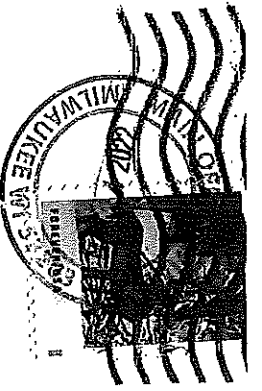


We have received your claim for the amount of \$1,652.76 in relation to the vehicle damage you sustained on November 21, 2021 at or near North 59th Street between West Burleigh Street and West Chambers Street.


Our investigation determined that the speed hump signs were constructed and installed in 2016. The Infrastructure Services Division has no record of sign damage or signs needing repair at or near the speed hump located in 3000 block of North 59th Street prior to the receipt of your claim.

It is our position that the City has no negligence in this matter, and cannot accept liability for the damages to your vehicle. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

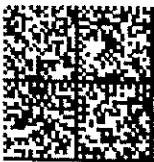
