Now, correct me if I'm wrong, but aren't trees marked with this dot scheduled for removal at some point? Due to this being the second time this tree has damaged my home in 15 months, I am seeking monetary reciprocity for this claim. Unforeseen claims have been made, cutting into my finances as a first-time homebuyer in a lovely neighborhood.

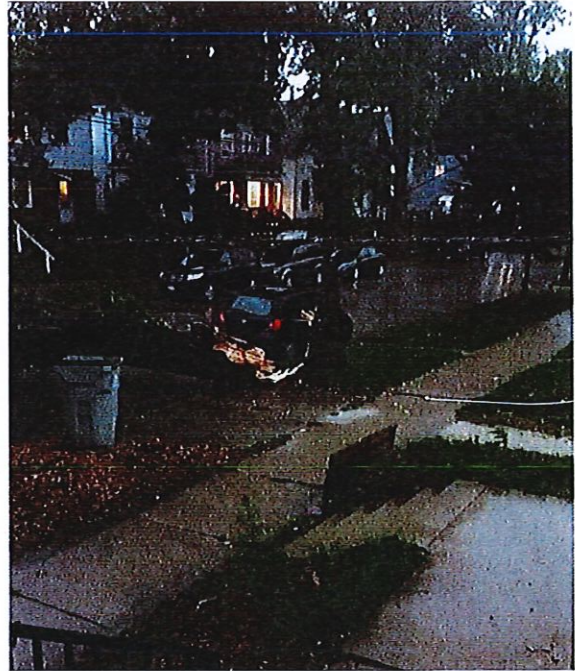
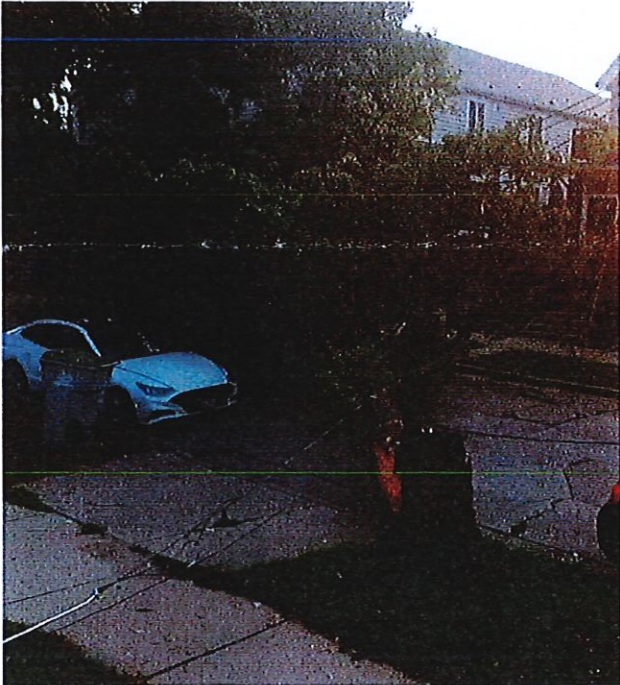
