I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:

our garbage & recycle bins have always been put between our driveway & tree. City of Milw. was notified of this
in 2018 or 2019 with written statement. Property owner of 6912-6914 was also sent a
written statement not to put bins on my property. Warning violation received 04/15/25. Spoke with
operator 18. Told her violation not ours, where we put our bins & I dispute the violation.
On 04/16/25 left voice message for Sanitation inspector, D. Ewing & State same info.
She was also told this information in 2018. We have no control over where people
put their garbage / recycle carts. It is unreasonable to remove empty
or filled garbage / recycle bins that are not ours. Have no place to put them since
on 06/10/25, receive \$70 violation charge. No other written charge received warning.
this violation isn't ours. Request to remove & reverse all charges, fees &
violations regarding this issue including online. Disputed violation 06/10/25 with
confirmation #16787655 & 522 request garbage & recycle schedule. Not received agent 12 e
confirmation #5292391 on 04/30/25 with operator 19 request garbage / recycle schedule. confirm P- 520

City of Milwaukee Ordinance No. 79-5-5 and 79-32 states garbage and recycle containers must be returned to their storage area no later than 10 p.m. on the day of collection. A \$30 initial charge will be charged if in violation upon inspection. Failure to comply with these ordinances will cause the City of Milwaukee to charge the property owner a special charge of \$40 for the first violation after notification or a special charge of \$70 for subsequent violations with the same calendar year.
