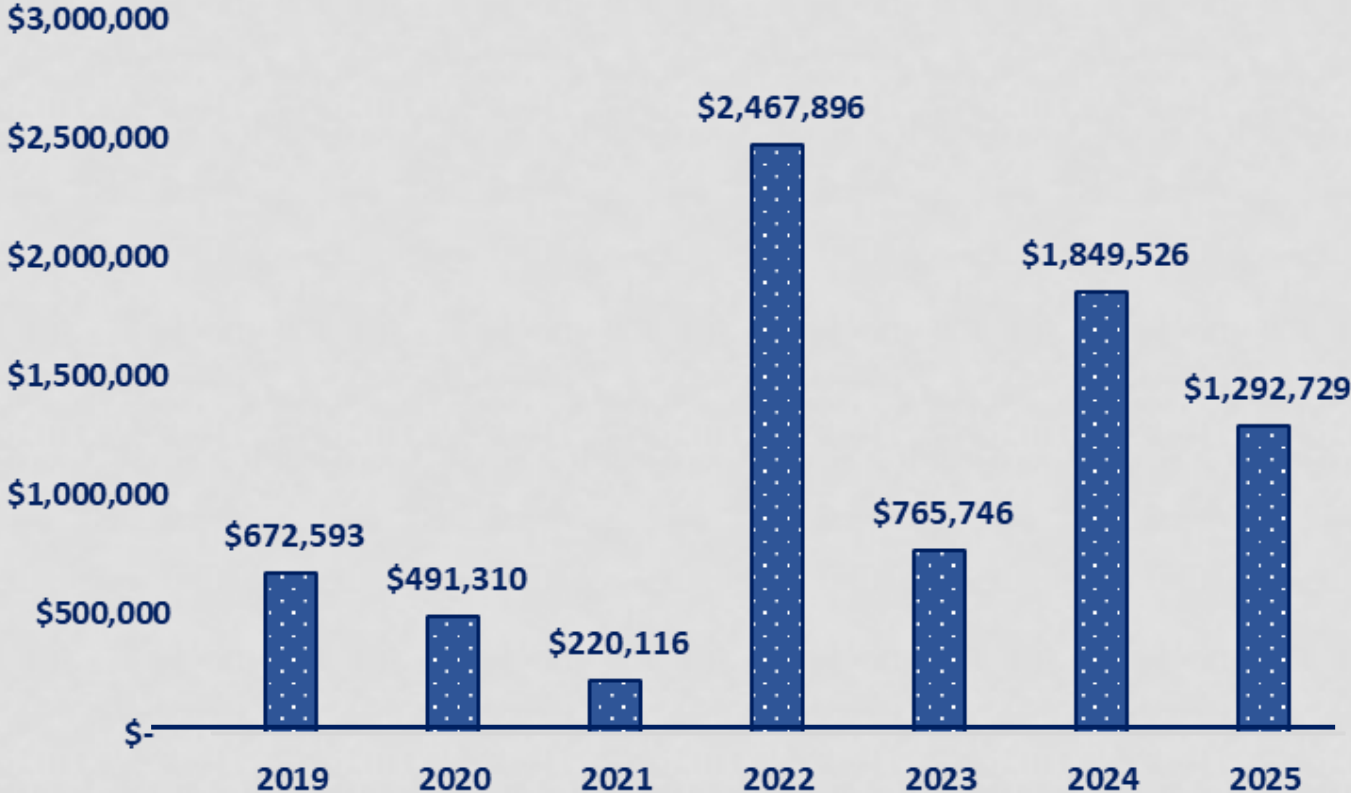
## ASSET FORFEITURE

- US Department of Justice program - “Equitable Sharing - Asset Forfeiture”
- Distributes assets seized from illegal activity **ONLY** where proof of the property’s connection to criminal activity has been certified through criminal conviction.
- **ONLY** after all exhausting all legal due process and final forfeiture is entered.
- Lengthy process to determine final forfeiture. Can take many years between date an asset is seized and the receipt of MPD’s equitable share of the asset.
- The program’s 4 goals include: punish and deter criminal activity; promote cooperation among law enforcement agencies; compensate victims; and, administer the program professionally in a manner consistent program guidelines and sound public policy.
- Milwaukee Police Department is eligible to participate in the program and receive an “equitable share” of assets seized - 94% of seizures are U.S. Currency.

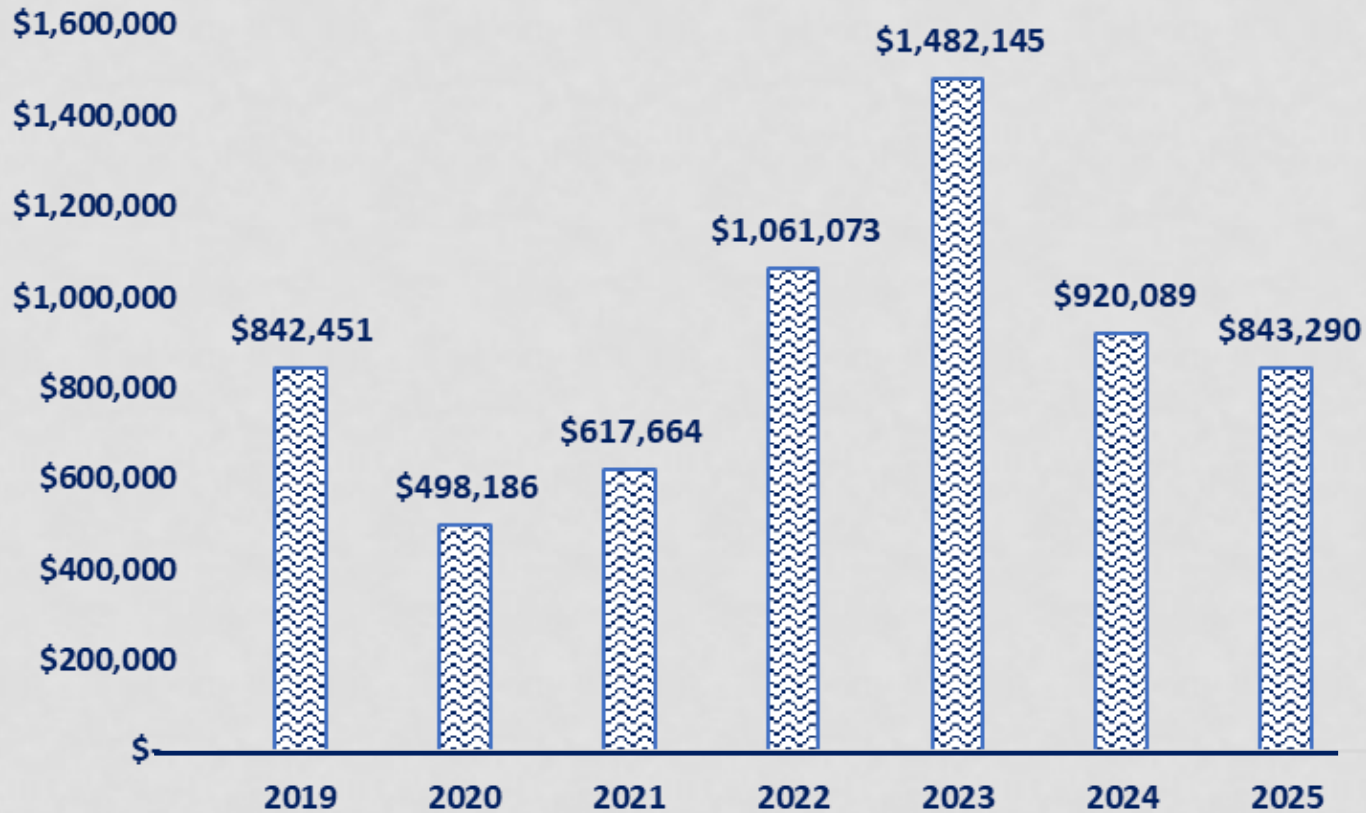
# SHARING IS BASED UPON NET PROCEEDS

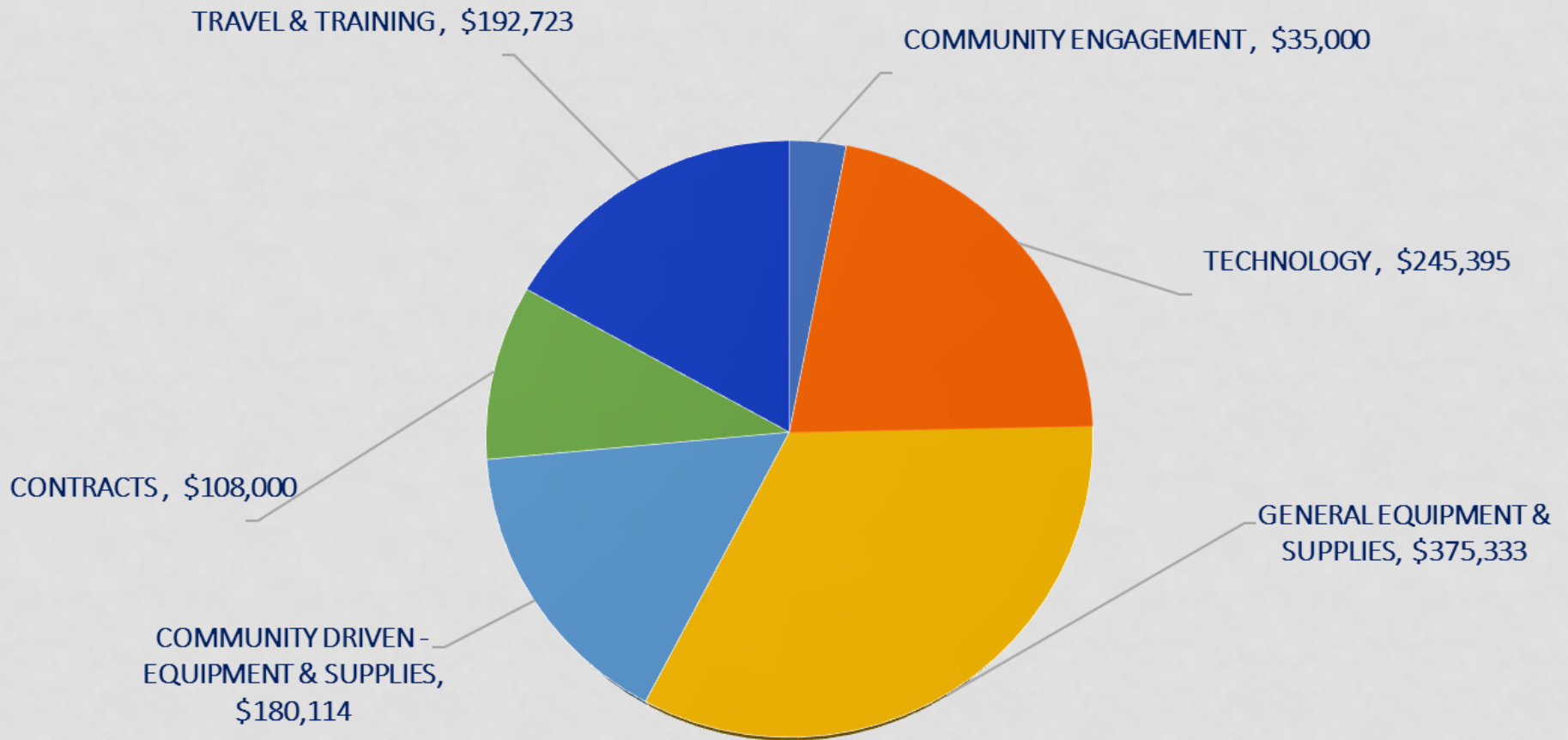

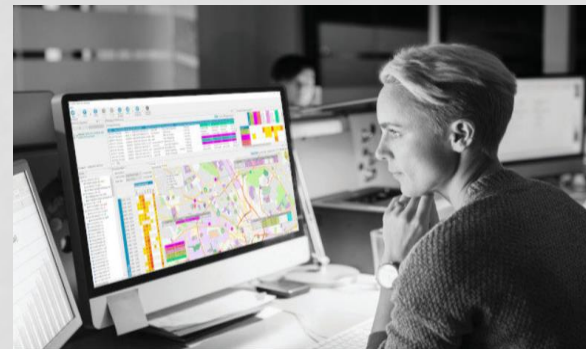
