Circumstances of Claim. Claim relates to significant damages caused to claimant's vehicle at the intersection of North Green Bay Road and West Capitol Drive. Late (after dark) on the day **June 30th, 2018**, claimant was driving South on Green Bay Road, turning left onto Capitol Drive. Within the intersection, the right tires of claimant's vehicle struck a deep pothole in the intersection, immediately bending and perforating both right wheels, and irreparably tearing both associated tires. Photographs of the pothole, which measured five to seven inches deep are attached hereto. 








Photos of Damage. Rear.




