I, Frederick W. Shibilski, a registered land surveyor do hereby certify:

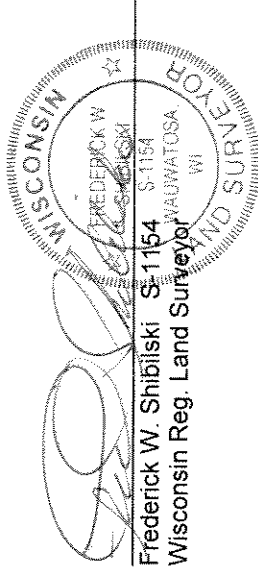
That I have surveyed, divided and mapped Parcel 1 of Certified Survey Map No. 4020, located in part of the Northwest ¼ of the Southwest ¼ of Section 19, Town 7 North, Range 22 East, in the City of Milwaukee, Milwaukee County, Wisconsin, bounded and described as follows: Commencing at the Northwest corner of the Southwest ¼ of Section 19; thence South 01° 08' 04" East along the West line of said ¼ Section, 208.89 feet; thence North 89° 01' 32" East, 33.00 feet to the Northwest corner of Parcel 1 of Certified survey Map No. 4020 and the point of beginning; thence North 89° 01' 32" East, 125.00 feet to the Northeast corner of said Certified Survey Map; thence South 01° 08' 04" East, 60.00 feet to the Southeast corner of Parcel 1 of said Certified Survey Map; thence South 89° 01' 32" West, 125.00 feet to the Southwest corner of said Parcel 1; thence North 01° 08' 04" West, 60.00 feet to the point of beginning.

That I have made such survey, land division and map by the direction of the Housing Authority of the City of Milwaukee, owner of said land.

That this map is a correct representation of all exterior boundaries of land surveyed and the land division thereof made.
