Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/09/2018 officers were dispatched to a fight at Tu Casa, 3710 W. Lincoln Av. When the officers arrived they found security had two subject detained. The subject were intoxicated and refused to leave the bar. When they were being escorted out they made threats to security, which is why security detained them. The applicant was on scene and stated she just wanted the subjects to leave. The subjects were told to leave and were banned from the property.
2. On 12/14/2018 at 1:57am officers were dispatched to shots fired at Tu Casa, 3710 W. Lincoln Av. The officer interviewed the applicant who was on scene. She stated there was a verbal argument in the tavern earlier at about 1:00am but they closed the tavern to avoid further conflict. She did not hear gunshots. The applicant's husband, Marcos ISIDORO-GAMBOA, stated he was outside at closing and there were two fights outside but he did not hear any gun shots. The sole security guard stated she attempted to use pepper spray to stop the fights and did hear about 5 gunshots. The officer watched the security footage which showed about 40 subject exiting and arguing. He observed one subject exit the tavern and engage in a verbal argument. During the argument the subject produced a firearm and pointed at the other subject. The subject with the gun left in a car and then subjects on scene were observed ducking. No one from bar called the police. The applicant was cooperative and was advised to call the police in the future if something happens at the bar.

3. On 01/27/2019 officers were dispatched to Tu Casa, 3710 W. Lincoln Av for a Trouble with Subject. Marcos ISDORO was on scene and stated that a subject was denied entry due to his dress code and as he was leaving he threatened to shoot the tavern up. ISIDORO requested the officers stay in the area in case the subject returned.
4. On 02/12/2019 a meeting was held at District 2 regarding Tu Casa, 3710 W. Lincoln Av regarding shots fired on 12/14/2018 and an abduction on 01/01/2019. At the meeting was the applicant; her husband, Marcos ISIDORO; and owners of Midwest Private Police Inc. ISIDORO stated the shots fired was not related to his business because it happened outside and down the street. He didn't call police because someone else said they were calling. He was advised that he was responsible for his patron's action outside as well as inside and he should not have his patrons parking in the parking lots of neighboring businesses. Regarding the abduction ISIDORO stated he was asked by a patron to look at video for whom the abducted patron left with and he advised that person to call the police. He stated he then allowed the police to view the surveillance video.

5. On 07/29/2019 at 12:45am officers were dispatched to Tu Casa Restaurant, 3710 W. Lincoln Av for a Battery complaint. The victim stated she was at the bar and her ex-boyfriend hit her to the face. The business was cooperative and provided video of the incident.
6. On 12/20/2019 at 2:11am officers were dispatched to Tu Casa, 3710 W. Lincoln Av, for a Trouble with Subject. The officers spoke with security, who stated there were two males in the restaurant refusing to leave at closing. After they left the security guard heard 5-6 gunshots. The officers checked the area but did not locate the subjects. The manager stated he did not witness the incident but did provide video of the subjects leaving.
7. On 01/01/2020 at 3:31am officers were dispatched to a fight at 3710 W. Lincoln Av. The officer spoke with security who stated two subjects had an argument. One subject left and the other was argumentative with security, who placed the subject in handcuffs and called police. The manager was cooperative with the officers.
8. On 01/29/2020 at 1:00am officers were dispatched to a Subject with weapon complaint at 3710 W. Lincoln Av. The officers spoke with security who stated two females were fighting. One of the females was still on scene. She confronted a female who had an affair with her husband. She pushed the subject to the ground. The security guard used pepper spray to stop the fight and one of the subjects left the scene. The applicant was on scene and requested the female be issued a no trespassing order.
9. On 02/16/2020 at 1:22am officers were dispatched to a fight at 3710 W. Lincoln Av. Upon arrival they were told two females were fighting. Both females were on scene and appeared to be intoxicated. The subjects did not want to prosecute and were released.

10. On 09/07/2020 at 12:25am, officers were dispatched to a Subject with a Gun at 3710 W. Lincoln Av. Officers were advised an altercation occurred between security and a patron. The patron who was heavily intoxicated was being asked to leave the bar, at which time the patron struck the security guard multiple times in the face with a closed fist. Management was on scene and was cooperative with police.

11. On 10/04/20 at 2:25am, officers were flagged down by security at 3710 W. Lincoln Av., for a fight. Officers observed approximately 20 patrons standing outside and began to disperse as officers arrived. A victim was observed on the ground and stated he was punched, however, did not know who hit him and did not wish to be a victim. The manager was on scene and stated he had approximately 50 patrons and 2 security guards. The manager denied knowledge of a fight outside and was advised to have more security when he has a crowd of that size. Management was cooperative and allowed police to view video surveillance, however, the fight was not captured.

12. On 05/04/21 at 8:33pm, officers along with an agent from Department of Revenue conducted a license premise check at 3710 W. Lincoln Av. All receipts and records of alcohol purchases were provided and valid. No violations were found and the agent was cooperative with police.

13. On 01/29/22 at 1:28am, Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Trouble with Subject. Officers observed an intoxicated patron outside of the bar, unconscious but breathing. Officers could smell the odor of liquor emanating from the patron. Officers were advised by the owner the subject was kicked out of the bar for being disorderly. The patron and a friend then attempted to re-enter the establishment, and were denied re-entry. The patron then began to become aggressive at which time security had to push the patron back, causing him to fall to the ground. Officers did not observe any bumps or lacerations to the patron. Officers then assisted the patron and his friend into their vehicle, where the disorderly patron began to respond to stimulus by the officer. No medical attention was requested by either patron.

14. On 04/23/22 Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Subject with Weapon. Officers were advised a patron attempted to take beer outside of the establishment. Security stopped the patron and an argument ensued, escalating to security eventually using pepper spray on the patron. Employees were cooperative and allowed officers to view video surveillance of the incident.

15. On 05/30/22 at 2:08am., Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Battery. Officers were advised an intoxicated patron was escorted out of the establishment due to an argument. The unruly patron then returned and a verbal argument ensued between the DJ and the patron, when the DJ is seen on video surveillance punching the patron one time in the face. The employees were cooperative with the investigation and allowed officers to view video surveillance of the incident.

LICENSE PREMISE REPORT

This report is being typed by Police Officer Traves MARTIN assigned to District Two, Late Shift.

On Saturday, January 29th, 2022 at approximately 1:28AM Squad 2321 (PO Tyler GNAS) and myself were dispatched to a trouble with subject at the location of 3710 W Lincoln Ave, which is located in the City and County of Milwaukee.

Upon arrival, officers observed an intoxicated subject laying in the sidewalk in front of Tu Casa Restaurant & Bar. Standing over him was an intoxicated female arguing with the staff of Tu Casa. The male subject was breathing and had a pulse but was unconscious due to alcohol. Officers could smell the odor of alcohol coming from the male subject.

Interview of MARCOS ISIDORO-GAMBOA(Owner):

MARCOS the owner of the bar stated that the intoxicated male came up to him and said "who the fuck you think you are." MARCOS informed his security to kick him out because he "doesn't want these kinds of people in his business." MARCOS stated that the male subject was being aggressive towards him. MARCOS also stated that the female friend was nowhere near to see this altercation take place, up until the male subject was already outside of the business. The male subject attempted to try and get back inside and MARCOS told him and the female friend that he is not allowed back inside of the business.

Interview of the female(friend):

The female stated that she was dancing with a friend when she observed security escorting her male friend out of the business. The female claimed that the male subject hit his head on the ground at some point. Officers did not observe any lacerations or bleeding coming from the male subject's head. Both subjects were highly intoxicated. The female stated that she had called her brother to come and pick them up. The female then requested that officers just help her put the male subject in the car. The female refused to bring her car closer to the male subject for an unknown reason and requested that we carry him to her vehicle which was approximately 100 feet away. The female became uncooperative and proceeded to argue with security. It should be noted that at no point in time did the female indicate that she wanted medical for her male friend. Officers ended up carrying the male subject to the female's vehicle and placed him inside the vehicle. Once the male subject was placed in the vehicle he began to respond to stimulus.

Interview of the Security:

Security stated the owner asked him to kick the male subject out and he kicked him out. The male subject kept trying to come back in, security told him he's not allowed back in. The male subject stated he needed his coat and security offered to go get it for him. Security grabbed the male subject's coat that he was sitting on and the female subject grabbed it as well and security told her he was taking it to him because it was cold. Female subject grabbed the coat and took it out to her male friend. Security stated the female tried to go back in and security told her she was not welcome back in and both male and female subject proceeded to become aggressive towards security and wouldn't leave. Security stated the male subject was coming at him aggressively that he had to push the male subject back and the male subject fell to the ground. Meanwhile the female subject was hitting security. Security attempted to pick the male subject up and the female requested that he leave him on the ground.

No video surveillance was observed by officers.

This License Premise Report is typed by P.O. Misael VASQUEZ, Assigned to District Two, Squad 2320, and Late Shift.

On Saturday, April 23, 2022 at 1:18 AM P.O. Kevin FREY and I were dispatched to 3710 W Lincoln Ave (Tu Casa) for a subject with weapon call.

Upon arrival, I spoke with the caller IBARRA, Carlos (M/W 08-08-84) who stated he was at Tu Casa when the security guard RODRIGUEZ, Edwin (M/W 04-15-94) used unnecessary force and pepper sprayed him. IBARRA stated he had got into an argument with RODRIGUEZ for trying to take beers outside and RODRIGUEZ then pepper sprayed him for no reason.

I then spoke with RODRIGUEZ (the security guard), who stated he saw IBARRA trying to walk out with beers but then stopped him at the door. RODRIGUEZ stated IBARRA was hostile and when IBARRA'S girlfriend tried to calm him down he pushed her out of the way. RODRIGUEZ stated he told IBARRA to keep his hands off his girlfriend and stop trying to take beers outside. RODRIGUEZ stated IBARRA continued to advance on him and pulled RODRIGUEZ by the shirt twice to draw him in close. RODRIGUEZ stated he believed IBARRA was going to punch him because IBARRA would not back up, and keep pulling him in so RODRIGUEZ pepper sprayed IBARRA and then escorted him out.

The manager, ISIDORO, Marcos (M/W 01-22-79) was very cooperative and allowed officers to review camera footage that captured the incident. The footage

This report was typed by P.O Cesar MARTINEZ-SANCHEZ, assigned to District TWo LAte Shift, Squad 2331 with assigned partner P.O Jeffrey KIBLER.

On 05-30-2022 at 2:08 AM we were dispatched to the address of 3710 W Lincoln Ave (which is in the City and County of Milwaukee) for a battery complaint. Upon our arrival we were met by the caller/victim who identified himself as Mariano RODRIGUEZ (M/W 11-11-1991). RODRIGUEZ stated that he had been kicked out of the establishment for unknown reasons, and he observed his friend "needing help" during an argument. RODRIGUEZ then stated he went back inside and was punched by the D.J of the establishment. While speaking with the staff of the establishment everyone was cooperative and were able to explain their side of the incident. The manager allowed us to reviewed surveillance footage from inside which captured RODRIGUEZ and a female subject arguing with another female. The security guard escorted RODRIGUEZ out of the establishment because he was intoxicated and causing problems, but stated rodriguez returned shortly after. RODRIGUEZ is seen exchanging words with a male subject and the male subject then is seen punching RODRIGUEZ in the face one time. RODRIGUEZ exited the bar and called police shortly after. The manager stated that the subject who punched RODRIGUEZ works as a D.J at his establishment, but did not know his information and just had his phone number.

This concludes my report.
