



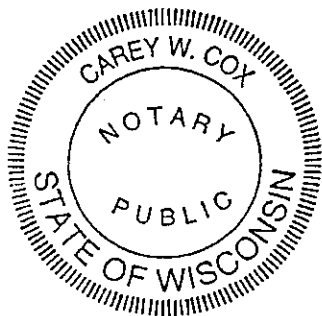

## City of Milwaukee Official Notice Published by Authority of the Common Council of the City of Milwaukee Office of the City Clerk 11/14/2008

Leonhardt, City Clerk of the City of Milwaukee, certify that pursuant to Section 4-06-3 of the Milwaukee City Charter, notice is given of the passage of the following ordinances by the Common Council of the City of Milwaukee on 10/29/2008, with the approval of Mayor Tom Barrett. **080516...** A substitute ordinance relating to employee benefits for non-represented, noncivilian fire management employees.

**080611...** Substitute ordinance relating to the change in zoning from General Planned Development to a Detailed Planned Development known as United Methodist Children's Services, on land located North of West Lisbon Avenue and West of North 39th Street, for development of apartment housing and community space, in the 15th Aldermanic District.

**080612...** Substitute ordinance relating to the change in zoning from Multi-Family Residential and Two-Family Residential to General Planned Development for the properties located at 3940 West Lisbon Avenue and part of 1929 North 39th Street and approving the First Amendment to the General Planned Development known as United Methodist Children's Services, located North of West Lisbon Avenue and West of North 39th Street, for development of apartment housing and community space, in the 15th Aldermanic District.

**080661...** A substitute ordinance to further amend the 2008 rates of pay of offices and positions in the City Service under control of the Common Council.

**080665...** A substitute ordinance relating to parking controls in various Aldermanic Districts.

**080666...** A substitute ordinance relating to traffic controls in various Aldermanic Districts.

**080676...** A substitute ordinance relating to floodplain zoning regulations.

**080687...** Substitute ordinance relating to the First Amendment to the Detailed Planned Development known as Story Hill Place, on land located on the South Side of West Bluemound Road and East of North 51st Street, for residential development, in the 10th Aldermanic District.

**080835...** A substitute ordinance relating to the composition and staffing of the ambulance service board.

**080867...** A substitute ordinance relating to state certification of food handlers and posting of health department-issued decals or placards at licensed food establishments.

**080662...** A substitute ordinance to further amend the 2008 offices and positions in the City Service under control of the Common Council.
