- 5. On 10/04/20 at 2:36am, Milwaukee police were dispatched to 2514 N. 27<sup>th</sup> St for a suspicious auto complaint. The business was closed at the time of the assignment. Police located a white Kia in the parking lot of the gas station. Police spoke with the driver of the auto and a D.O.T check revealed the auto was stolen out of Streamwood Illinois. The driver and passenger were arrested and the auto was towed to the city tow lot.
- 6. On 10/25/20 at 7:31pm, Milwaukee police were dispatched to 2514 N. 27<sup>th</sup> St for a threat complaint. Police spoke with the clerk who stated that a subject demanded to see the security cameras, due to missing money of his card. The subject was advised to come back a later time with an exact time frame to check the cameras. The subject appeared intoxicated and refused to speak with police and left without incident.

The clerk stated to Police that an unknown male was in the store causing problems, refusing to leave. The suspect returned open the door slightly, pointed a gun at the floor while stating he would kill the employee. The suspect fled prior to officer's arrival. Security camera footage was available of the incident.
- 13. 04/17/25, at 3:00 p.m., officers were dispatched to a Theft of vehicle. The victim was approached by four suspects, two armed with hand guns, and all dressed in all black. #### LICENSED PREMISE REPORT

This report is typed by P.O. Shahriar SOLATI, assigned to District Three, Dayshift, Squad 3142.

On Tuesday, 5-28-24, at approximately 12:10pm, my partner (P.O. Ryan MILLER) and I were dispatched to an RES complaint at 2514 N. 27th St. (Clarke gas station), in the City and County of Milwaukee.

Upon arrival, I observed the listed location to be a gas station. located on the N/E corner of N. 27th St. and W. Clarke St.

Upon arrival, we spoke with the victim, Jashanpreet SINGH (W/M, 5-31-04), who stated that on 5-26-24, at approximately 6:01pm, an unknown B/M walked into the listed gas station, while he was working as a cashier, and caused a disturbance. SINGH stated that the male attempted to pay for store items but the card he used was declined. SINGH stated that the male paid for the items using an alternative method but was upset. SINGH stated that the male began to walk towards the exit and proceeded to slam the door to the store several times and then grab a box of candy and throw it on the ground. SINGH stated that the male then left the store and went to his vehicle (red pickup truck). SINGH stated that the male returned and opened the store door slightly and put half his body inside the store. SINGH stated that the male then produced what appeared to be a handgun and point it at the floor while stating, "I'll kill you!" SINGH stated that the male then went back to his truck and fled the area W/B through the alleyway, just north of the 2700 block of W. Clarke St. SINGH stated that these intentional actions caused him alarm and to fear for his safety, without consent.

#### No witnesses

License premise licensee, Simranjeet S. BENIPAL (W/M, 12-28-79), was on scene but did not witness the incident and could not provide any further information.

P.O. MILLER viewed video surveillance of the incident and the following is following in an excerpt of his Disorderly Conduct while Armed report:

The suspect (B/M, 18-26 yoa, approximately 5'10", slim build, short black afro, wearing a dark blue BAPE jacket, grey jeans, red shoes) attempted to pull open the locked grate door with body force. The suspect was unsuccessful and returned to the register to pay for his drink. The suspect attempted to pay the first

time, but his payment was initially declined. The suspect then successfully paid for the drink. The suspect then walks over to the metal grate door, which was unlocked by SINGH. The suspect slams the metal grate door open five times while yelling at SINGH. When the suspect finishes slamming the door, he grabs two boxes of chocolates from a shelf and throws them on the floor. As the suspect attempts to exit the store, the metal grate door partially closes on him.

The suspect exits the store and walks to his red GMC Sierra pickup truck that is parked facing northbound at the gas pumps. The suspect leans in through the passenger door and appears to place something in his right jacket pocket. There appears to be a B/F sitting in the passenger seat. The suspect returns to the door of the store, but SINGH already locked it again. The suspect is seen reaching his right arm through the metal grate and flashes a black handgun for SINGH to see. The suspect starts to return to the truck when the B/F approaches him in the middle of the parking lot area. The two subjects enter the truck and (the suspect is driving) and the vehicle flees westbound across N 27th ST through an alley.

SINGH stated the suspect told him that he would kill him when he showed him the firearm. SINGH stated these actions caused him to fear for his life. SINGH and GREWAL stated that prior to the incident, they had never seen the suspect in the store before. SINGH was able to provide a license plate for the suspect vehicle. The license plate provided to us was a Wisconsin truck plate of TN7859, which lists to a 2001 red GMC Sierra pickup truck (VIN#2GTEK19T911228314). The listed owner (Michael W RILEY, B/M, 10-17-63) is currently deceased (IR#223220027). The listed address shows 4911 N 61st ST.

GREWAL also showed me a video from Monday, 5-27-24 at approximately 6:45 PM. The video showed the same suspect enter the store. In this video the suspect was wearing a purple plaid shirt, lighter jeans, and tan shoes. The suspect enters the store and attempts to pay for a beverage. Once again, the suspects initial payment is declined, but eventually the payment processes correctly. The suspect grabs chocolate from the same shelf as the prior day and knocks approximately three boxes off the shelf. The suspect then exits the store and enters the same red GMC Sierra pickup truck. The suspect exits the parking lot heading eastbound on W Wright ST. In this video the truck appears to have a silver logo (possible flame) on the entire driver's side. The vehicle also has a silver panel along the entire driver's side. It appears there is significant rust damage on the rear driver's wheel well.

I observed the posted licenses and all were up to date. No violations were observed. I documented one of the main posted licenses: Cigarette and Tobacco (#1032433), valid 1-17-24 through 3-16-25.

Per the district community partnership unit this location is a designated nuisance premise.

This report is written by Joseph BINTER, assigned to DISTRICT Three Day SHIFT, SQUAD 3190.

On Thursday, April 17th, 2025, at 3pm, I was dispatched to 2514 N 27th St for a Theft of Vehicle.

Upon my arrival I observed this location to be a "Clarke Gas Station". I observed the gas station to have a few customers walking in and out of the business doors, all seemed to be in good order and standing without issue. The investigation revealed to be an Armed Robbery Car Jacking, Myself (working with PO SHARP), Squad 3225 ABDULGANI (saturation), Patrol Sergeant 3211/DANKERT and a Detective were assigned to this investigation.

I spoke to the caller/victim, Brian K KIRK (b/m 01/08/95) who was contacted via cell phone number (414) 218-3869. They stated that they were at the above listed location around 2:30 pm, to obtain gas from the establishment. Once at the location the victim stated a group of four unknown black males dressed in all black, two of them carrying firearms, requested money from him and started a small argument in the store front. The victim stated that the four subjects then escorted him to his silver 2015 nissan juke, one of the subjects stated to him "you know what time it is". Made him get into the vehicle, drove several blocks away from the establishment, forced a cash app transaction, then kicked him out of the vehicle. The subjects stole the victim's vehicle at this time, making him walk around on foot.

I spoke to licensed premise, employee Timmy OLBUDN (b/m 10/18/95) who stated that around 2:30pm he observed a group of males approach our victim, an argument occurred over money. OLBUDN stated all of them left the store in the same vehicle. I requested video from OLBUDN who stated that he could not provide the video as the room that contains the equipment is locked and operated by the manager. OLBUDN was cooperative and called the manager to notify him we were on scene and about the incident. OLBUDN relayed the message that on 04/18/25 at 9am the video could be obtained from the store manager.

The business had 0# security officers on scene.

While on scene, I observed the licenses posted and they were up to date.

During my investigation for a THEFT OF VEHICLE I did not observe any violations in the licensed premise.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
