Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/15/19 Milwaukee Police were dispatched to Country Inn located at 6200 S. 13<sup>th</sup> St. for a Trouble with Subject. On arrival it was determined a guest at the hotel was complaining about the smell of marijuana coming from the 2<sup>nd</sup> floor. Officers determined which room it was coming from. An arrest was made and a subject was cited for possession of marijuana.

2. On 07/26/2020 at 10:56pm officers were dispatched to a Trouble with Subject at Country Inn & Suites, 6200 S 13<sup>th</sup> St. The officers interviewed the manager, who stated a hotel employee entered a guest's room without knocking. The guest became upset and was causing a disturbance in the lobby. The guest was asked to leave and he was packing up his items.
  3. On 02/06/2021 at 11:35pm officers were dispatched to a Sick/Injured Person at Country Inn & Suites, 6200 S 13<sup>th</sup> St. The officers met MFD, who were treating a subject who overdosed on Heroin. The subject was treated with Narcan and was revived. He stated he had been addicted to Heroin for 3 years but had been clean for 7 months. He had a relapse today. The subject refused to go to the hospital.
  4. On 03/06/2021 at 5:30pm officers were dispatched to a Trouble with Subject at the Country Inn & Suites, 6200 S 13<sup>th</sup> St. The officer spoke with the manager, who stated a large group of



people in a room causing a disturbance. The subjects left when he was advised the police were called.

On 03/29/2021 at 5:43pm officers were dispatched to a Battery at Country Inn & Suites, 6200 S 13<sup>th</sup> St. The officer spoke with the clerk, who stated he had a individual in a room rented by another individual. The clerk was unsure of her safety or status. The officer made contact with the individual and found she was not in need of police service.

The officer spoke with the manager who stated there were no secondary keys issued for that room and she does not know how the subject got in the room. The officers filed a report for the Domestic violence incident.

7. On 02/27/23 at 12:00:am, Milwaukee Police were dispatched to 6200 S. 13<sup>th</sup> Street for a threat complaint. Investigation revealed that a daughter was yelling profanities at her mother and management wanted them to leave. The family left with no further incidents.
  8. On 03/02/23 at 2:27am, Milwaukee Police were dispatched to 6200 S. 13<sup>th</sup> Street for a trouble with subject complaint. The subject left before police arrival.

17. On 06/04/23 at 12:59p.m., Milwaukee Police were dispatched to a Trouble with Subject at 6200 S. 13<sup>th</sup> St. Officers were advised a subject outside appeared to be in mental health crisis. Officers located the subject and conveyed the subject to another location per the subject's request.

On Friday, May 24, 2024, at 3:56AM, Squad 6320 (myself in full duty uniform, equipped with BWC, and operating a marked MPD squad #65640) was dispatched to 6200 S. 13th Street (Country Inn & Suites) for a Trouble With Subject complaint.

Upon arrival, I observed I spoke to the NIGHT AUDITOR/caller, Gisselle I. SALAZAR (W/F, 02-14-98, PH#414-389-7298), who stated that she began work at 11:00PM, and saw the subject (B/F, 30YOA) in the restroom at around 1:00AM. SALAZAR stated that MFD had come to this location after that for an unrelated call, and they checked on the female, but the subject still would not leave. SALAZAR tried to get the woman to leave, but was ignored so she called police at around 2:00AM. SALAZAR stated she does not believe the woman is a guest here.

SALAZAR showed me to the restroom with the subject inside. I opened the door and announced MPD. The subject got up and exited the stall. She stated that she would go upstairs to her room. I asked what room she was in, and got no reply. I advised her she would need to verify with SALAZAR what room she is staying in before going upstairs. The woman then just exited the hotel. I advised SALAZAR to lock the main door behind me after I left to avoid her return.

No additional witnesses.

The business had 0 security officers on scene.

Surveillance footage was accessible, but unnecessary.

While on scene, I observed the licenses posted and they were up to date.

On Saturday, June 22nd, 2024, I was assigned Squad 6250 in full duty uniform, operating a marked MPD squad and equipped with a body-worn camera which was activated and recording during this assignment. At 4:46p.m., I was dispatched to and arrived to the Country Inn & Suites hotel at 6200 S 13th St., in the City and County of Milwaukee for a trouble with subject call. Per CAD: CALLER STS MALE WAS SUPPOSE TO CHECK OUT OF HOTEL AT NOON. CALLER STS MALE IS REFUSING TO LEAVE THE LOCATION.

Upon my arrival, I spoke with the caller and front desk attendant, identified as "Sherry" on the CAD, who stated that a guest in room 315 at the hotel, identified as Joel R MEDROW (w/m, 03-07-1975) had overstayed his checkout time and was refusing to leave. We went upstairs, Sherry knocked on the door which was answered by MEDROW who was informed that he had to pack up and leave. MEDROW ultimately agreed to do so and began packing. He left the room and hotel about 45 minutes later.

On Wednesday, June 12, 2024, at 3:27AM, Squad 6320 (myself in full duty uniform, equipped with BWC, and operating a marked MPD squad #65098) was dispatched to 6200 S. 13th Street (Country Inn & Suites) for a Trouble With Subject complaint.

Additional squads responded to assist as follows: Squad 6330 (P.O. Edgar RODRIGUEZ and P.O. Omar PEDROZA-BELTRAN) and Squad 6313 (SGT. Kimberly ANDERSON).

Upon arrival, I spoke to the NIGHT AUDITOR/caller, Gisselle I. SALAZAR (W/F, 02-14-98, PH#414-389-7298), who stated that she was contacted by guests regarding the subject being in the parking lot looking into vehicles, then she later saw the subject (B/M, with afro, wearing white shirt, gray sweater, and black pants) in the restroom and she asked him to leave.
