This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/29/20 Milwaukee Police were dispatched to 7609 W. Capitol Dr, for a sick and injured complaint. Officers spoke with Milwaukee Fire Department medical who was treating an employee who had a laceration to her left index finger. Officer spoke to the employee who stated that she accidentally cut her finger with a while opening a bag of food. The employee was transported to the hospital by private ambulance for further medical treatment.
- 2. On 01/28/21 Milwaukee Police conducted a license premise check at 7609 W. Capitol Dr,. Officers were accompanied by an investigator from the Department of Revenue and an associate from the Supplement Nutrition Assistance during the premise check. During the course of the premise check the business agent stated that he was purchasing boxes of cigars from Illinois and selling them with in his two stores. The business agent also admitted that he was purchasing Quest Cards and using them with in the store to turn a profit. The investigator seized 15 boxes of cigars from the location. The employees of the business were cooperative during the course of the investigation.

3. On 03/09/21 at 9:30pm Milwaukee Police took a walk in sexual assault complaint at District 4 police station. The victim stated to the desk officer that at approximately 7:39pm she was at the Shell Gas Station located at 7609 W. Capitol Dr. The victim withdrew money from the ATM to purchase items. While waiting in line at the register an employee at the location approached her from behind and touched her inappropriately. The victim stated that she got into a verbal argument with the employee, and then left the location to file a complaint with police. Further follow up will be conducted by officers from District 4.

On 05/29/2020 at 12:33PM,PO Richard Gordy and I, Sqd 7141 were dispatched to a work place injury call at the Shell gas station located at 7609 W Capitol Dr.

On arrival I spoke to LT William Code of MFD Engine 34, who stated that they responded to the same thing a work place injury. Lt Code stated that when the arrived they treated Estella Washington (b/f 08/01/58) for deep cut to the index finger of her left hand. Lt Code stated that the cut almost severed the flesh tip of the finger, yet it was still attached. Lt Code stated that Washington requested to go to the hospital, so he requested a private ambulance for transport.

I then spoke Washington, who stated that a customer—requested a fried catfish dinner, so she walked over to the kitchen portion of the gas station and grabbed the bag of catfish from the freezer and attempted to cut it open with a knife from the kitchen. Washington stated when she tried to cut the bag open she also cut her left index finger. Washington stated that the cut was so severe that she thought she cut it entirely off, she then called 911 for medical.

Sqd 7195 CSO Love responded for photos.

Meda Care ambulance 272 arrived on scene and conveyed Washington to Ozaukee St Mary's Hospital.

This report is written by P.O. Douglas PAVLIK, assigned to District 7, Early Power Shift.

On 1/28/2021 at approximately 4:19PM, P.O. Raul ORNELAS and P.O. Andrew SCHNELL (Squad 7263) conducted a Business Check at the address of 7609 W. Appleton Ave. (Stop and Go Operating, Inc) which is in the City and County of Milwaukee. Upon arrival they assisted the Department of Revenue on an investigation regarding illegal purchases of tobacco. P.O. ORNELAS check all the license and they were all good and accessible for his inspection.

The Department of Revenue conducted their investigation into the owner and agent of the license Saeed M. SKEIKH (W/M 11/11/1967) and concluded that SKEIKH was going down to Illinois and purchasing cigars and bringing it back up to Wisconsin to be sold in his two stores he owns. SKEIKH admitted to the agents of the Department of Revenue that he was purchasing the cigars from Illinois and bringing them to Wisconsin to be sold at his stores.

During the Business Check the manager Francis O. NWADIARA (B/M 8/12/1975) and cashier Nwokoma C. DIKE (B/M 5/8/1971) were cooperative during the whole investigation.

Additional illegally purchased cigars were located by the Department of Revenue at the Economy Inn (7284 W. Appleton Ave.). The Department of Revenue seized four boxes of cigars out of a storage closet only accessible to the Economy Inn and SKEIKH. The Department of Revenue seized 15 additional boxes of cigars from the Stop and Go.

Also assisting with the Business Check was an associate from the Supplemental Nutrition Assistance Program (Wisconsin). SKEIKH admitted to the associate that the store has been buying Quest Cards for a discounted price and using them at the store to make a profit from the State of Wisconsin.

It should be noted SKEIKH owns Discount Quick Mart (8334 W. Appleton Ave.) and 20 boxes of cigars were seized by the Department of Revenue.

#### INITIAL INVESTIGATION

On Tuesday, March 9, 2021, I, Officer Kevin Becker was assigned as Desk Officer for District Four Station. At approximately 9:30 PM, a subject entered the front lobby requesting to file a police report. The subject was identified by Wisconsin Driver's License to be **Tasha E. MILLER (F/B 11/10/1980)**. MILLER was requesting to file a police report regarding a "Sexual Assault" that occurred at the address of **7609 W. Capitol Dr.** which is located in the City and County of Milwaukee. The following is a brief synopsis of the incident that occurred.

MILLER stated that at approximately 7:39 PM on today's listed date, she was at the listed location which is a "Shell" Gas Station. MILLER was there to withdraw money from an ATM and to purchase items from the walk in store. MILLER stated after she had obtained the money from the ATM, she approached the register at one of two that were open. While waiting for assistance, MILLER observed an employee behind her wiping down a soda machine and some shelves. As she continued to wait, the same employee approached MILLER from behind and grabbed, with his right hand, MILLER's buttock area. MILLER stated she gave him a look as if she was disgusted by his actions. MILLER stated the man seemed apologetic regarding and stated "it's not a big deal" and continued behind the register. MILLER stated the subject grabbed her buttock "like significant other's would". MILLER stated this was done intentionally and without her consent. MILLER stated they had a verbal argument about the incident and MILLER then threw bags of chips off of the rack and exited the location. MILLER stated she did not call police and waited to report because she wanted to get her child home and away.

The suspect was identified as the following;

• Black, Light Complexion, Male, Medium Build, Approximately 5'7" (Last seen wearing) a Yellow T-Shirt, Light blue pants.

MILLER stated she grew up in the area and knows that he works there with one other male.

MILLER refused photos of her however she was wearing a Light Blue in Color baseball cap, a Black in Color winter jacket with a blue undershirt, and jeans.

Follow-up will be conducted regarding this incident.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 7/13/2021 at 9:10 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
