

(see photo #3 bottom circle) I also noticed a corner shaped dent the same height as a garbage containment box. (see photo #3 top circle) My barbeque platform had been bent down. (see photo #2 top arrow)

I called the city at 2PM. The next morning at 8:30 AM an inspector hand delivered me claim instructions. On this form was listed " City " Vehicle Number 32913.

Later on that day I noticed my air conditioner pulled partially out, and the entire porch ripped four inches away from the mobile home, (see photo #2) Contractors were concerned as to how they could reposition the porch without further damage. My claim is for six hundred dollars. (see estimates)
