Dear Mr. Patton and Atty. Bobot:

This is to notify you that on Friday, October 18, 2013, the City's Licenses Committee voted to recommend to the City's Common Council that the Class "B" Tavern and Public Entertainment Premises licenses not be renewed for the premises located at 3000 S. 13th St. ("The White House") based on items 10-24 the police report (excluding item 25 and also the underage items in 17 and 20) and police and neighborhood testimony.

On October 21, 2013, you were mailed true and correct copies of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the renewal applications for the Class "B" Tavern and Public Entertainment Premises licenses, in which the Committee recommended that the licenses not be renewed. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Tuesday, November 5, 2013, commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not appear, and you did not file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council adopted the recommendation of the Licenses Committee to not renew the Class "B" Tavern and Public Entertainment Premises licenses based on the police report and police and neighborhood testimonys. If you previously paid the license fees you may be eligible for a refund, except for a portion of the fee that may be retained, by bringing in your receipt or filing an application for a refund within one year to date of Common Council action with the License Division, Room 105, City Hall.
