This report is written by Police Officer MONREAL, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/10/2017 officers were dispatched to La Caleta, 1801 S Muskego Av, for a theft complaint. A suspect grabbed an employee's phone and ran out of the business. The business was very cooperative with the police.
- 2. On 03/04/2018 officers were dispatched to a fight at La Caleta, 1801 S Muskego Av. The investigation revealed a fight on the dance floor between three subjects that security broke up using pepper spray. The officer observed that the posted licenses were expired. The applicant was on scene and stated the new licenses were at her home. The officers observed the video surveillance and issued a citation to one subject for Disorderly Conduct.
- 3. On 03/11/2018 officers were dispatched to a battery complaint at La Caleta, 1801 S Muskego Av. The officers interviewed an intoxicated subject who stated security had dragged him out of the bar and assaulted him. The officers interviewed security who stated the subject was attempting to fight other patrons and threatened to kill the security officer. When the security officers were escorting the subject out he hit one to the face. The security officer then hit the subject back. The subject was issued a citation for Disorderly Conduct and Battery. While checking the tavern the officers observed the posted license was expired. The applicant was issued a citation for Display of License- Posting required.

- 4. On 03/20/2018 officers were dispatched to a Trouble with Subject complaint at La Caleta, 1801 S. Muskego Av. The applicant was on scene and had called regarding a subject who had been banned from the tavern that was refusing to leave. The subject left prior to the officer arrival. No violations were observed.
- 5. On 09/08/2018 at 10:41pm officers were dispatched to a subject with gun complaint at 1801 S Muskego Av. The officers interviewed several patrons who stated they were sprayed in the face with O.C. Spray by a security guard for not reason. The security guard stated he sprayed them as they were charging toward him. The incident was advised on that night because the officers could not view the video surveillance. On 09/10/2018 the officers contacted the applicant and were able to view the video. The video did show the security guard spraying subjects by the door but did not show any of the confrontation outside. The video showed there were inconsistencies with the stories of all parties.
- 6. On 10/03/2018 officers were dispatched to a battery complaint at La Caleta bar, 1801 S Muskego Av. The officers interviewed the victim who stated she got into a verbal argument with a female that was talking with the victim's husband. The fight turned physical with the subject punching the victim to the face. The suspect then fled the scene. The officers spoke with the applicant who stated the suspect was a former employee but had none of the suspect's information.
- 7. Juana GASPAR-JERONIMO (33% Shareholder) has the following warrants with the City of Milwaukee Municipal Court.

- 8. On 05/13/2011 Omar MONREAL SALAS (50% shareholder) was cited for Operating while Intoxicated. He was convicted on 06/12/2011 and his license was revoked for 6 months. This item added as part of a change in ownership.
- 9. On 10/31/20 at 1:44am, Milwaukee Police were dispatched to an armed robbery which occurred near the address of 1801 S. Muskego Avenue. Investigation revealed that a patron left the tavern, was walking to his vehicle, and was beaten/robbed. When the victim walked back to the tavern to get help, security asked him to leave and they closed the door on him. Contact was made with the security guard outside the tavern and he stated that no incident(s) happened inside the tavern.

- 10.On 03/27/21 at 2:17am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a fight compliant. Investigation revealed that two subjects were battered by a group of six subjects and one victim received sutures. The fight happened inside the tovern and the victims did not know why they were attacked.
- 11. On 04/02/21 at 11:32pm, Milwaukee Police were dispatched to 1801 W. Muskego Avenue for a shooting complaint. Investigation revealed that two groups of patrons inside the establishment engage in a verbal argument inside the bathroom. An employee entered the bathroom and told the patrons to disperse. While one of the groups were entering their vehicle, another vehicle approached and shot three people. The owner and bartender were cooperative with police and allowed them to review surveillance footage.
- 12. On 04/19/21 an 80-10 Nuisance Designation was drafted for nuisance activity at 1801 S. Muskego Avenue and the letter was mailed to the building owner.
- 13. On 05/04/21 at 8:00pm, Milwaukee Police, along with Wisconsin Department of Revenue Agents, conducted a license premise check at 1801 S. Muskego Avenue. When officers arrived, they observed an unlicensed bartender at the bar portion of the premise and the applicant in the restaurant portion. During the check, the applicant could not provide an invoice for any of the beer or liquor on the premise. The agents confiscated 62 liquor bottles and 65 boxes of beer.
- 14. On 05/18/21 at 10:00am, Members of the Milwaukee Police Department, City Attorney's Office, and a member of Safe and Sound, had a meeting with the members representing the business located at 1801 S. Muskego Avenue. The meeting was to discuss the Nuisance Designation put on the business and the abatement plan the business proposed. The abatement plan was denied because it did not address calling for police services, not training employees, not checking for weapons, and not preventing loitering outside the premise. The Captain of the Second District stated that a new plan would be considered if presented within ten business.
- 15. On 05/27/21 at 1:43am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a shots fired compliant. Officers were unable to find the complainant and no evidence recovered.
- 16. On 05/30/21 at 2:44am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a ShotSpotter complaint. Investigation revealed that the officers advised the caller and no evidence was found.
- 17. On 06/06/21 at 2:00am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a ShotSpotter complaint. Investigation revealed that a subject was walking by the tavern and discharged a firearm into the air. Four spent casings were found and the applicant did not call the police to report the incident.
- 18. On 06/13/21 at 1:11am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a ShotSpotter compliant. Officers were unable to find the complainant and no evidence recovered.

- 19.On 07/24/21 at 10:08pm, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a ShotSpotter compliant. Officers were unable to find the complainant and no evidence recovered.
- 20.On 10/18/21 at 2:08am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a ShotSpotter compliant. Officers were unable to find the complainant and no evidence recovered.
- 21.On 01/17/22 at 2:05pm, a subject walked into the Second District Police Station to report a battery which occurred at 1801 S. Muskego Avenue on 01/16/22. A surveillance camera revealed that the subject who was reporting the battery started the altercation with another subject and had to be separated by a third party.
- 22. On 02/03/22 at 2:00pm, a meeting was held at the Second District Police Station with the applicant of 1801 S. Muskego Avenue and representatives of the City of Milwaukee. The meeting was held to discuss the current operation of the tavern. The applicant told representatives that they have purchased the building they conduct business in, removed the problem tenants who live above the establishment, hired a new security service, and have painted the building to help with the aesthetic of the neighborhood.

- 23. On 11/12/22 at 9:35p.m., Milwaukee Police were dispatched to a Tavern Violation at 1801 S. Muskego. The caller stated they believed the bartender to be 18 and consuming alcohol. It was later determined the subject the caller was referring to, was a waitress. On arrival the officers made contact with the bartender, who was of legal age to consume alcohol and met with the manager who stated the waitress was not consuming any alcohol. The employees were cooperative with the officers.
- 24.On 01/20/23 at 9:36p.m., Milwaukee Police were dispatched to a Battery at 1801 S. Muskego Av. Investigation revealed an intoxicated patron was unruly and attempting to hit the security guard. The subject was gone on police arrival.
- 25. On 03/04/23 at 11:08p.m., Milwaukee Police were dispatched to a Tavern Violation at 1801 S. Muskego. The caller stated there were minors in the establishment consuming alcohol. The officer spoke with the manager who stated there was a family there with minors, however, the minor was not consuming alcohol. The officer spoke with the family, who stated they were there to eat and dance and the minor appeared completely sober to the officer. The employees were completely cooperative with the investigation.
- 26. On 04/15/23 at 1:00a.m., Milwaukee Police were dispatched to a Battery at 1801 S. Muskego. Investigation revealed the victim just left the bar and was entering their parked vehicle, when they were approached by a subject that began to punch the victim in the face. The victim began to fight back and the suspect picked up a weapon and began to smash the victim's window, then fled the scene. The security guard stated they believed it was a homeless man that hangs around outside the bar. The security guard stated there was video surveillance, however, officers were unable to review it due to the manager not being available. The victim then stated they no longer wished to remain on scene and denied medical attention.

- 27.On 04/23/23 at 2:05a.m., Milwaukee Police were dispatched to a Sick and Injured at 1801 S. Muskego Av. On arrival officers along with MFD were led to an intoxicated patron who was incapacitated by alcohol. The patron's brother unived on some and took the patron home once they were released by MFD. While on scene the officer's checked the business license and found the hours of operation to be 8A-2A. The officer's interviewed the manager who stated they were unaware their hours of operation were not until 2:30a.m. The manager further stated they were unaware if the patron had been over-served by staff.
- 28. On 04/23/23 at 2:06a.m., Milwaukee Police were dispatched to a Battery at 2013 W. Rogers St. The caller stated they were at 1801 S. Muskego Av., when they were punched in the face by another patron. The caller further stated they received a phone call from their friend who was still at the bar, stating the subject who battered them, had a gun and was looking for them. The caller stated they wanted to point out to officers who battered them and was conveyed back to the scene. While on scene the security guard advised the officer's, the caller is a regular customer, however typically causes trouble. The security stated they did observe a verbal argument inside the bar and escorted the group outside, where a physical fight took place. The security guard stated they attempted to break up the fight and were bit on finger by the caller. The security guard stated they no longer wanted the caller to patronize the bar. The subjects from the other group could not be located and no one saw a firearm. Security stated there was no video surveillance available inside or outside.
- 29. On 06/24/23 at 2:20a.m., Milwaukee Police were dispatched to a Subject with a Gun at 1801 S. Muskego. Investigation revealed security had denied entry to an intoxicated patron. The suspect then pulled out a firearm and began waving it and made threats to the security guard. The security guard stated the suspect then went to the gas station across the street and pointed the vehicle out to the officers, at which time the officers heard one gun shot from that direction. The suspect was taken into custody and a firearm was recovered.

Muskego Av (City and County of Milwaukee) for an alleged tavern violation. The anonymous caller stated that they observed the bartender whom they believed to be 18 you drinking alcohol.

Upon arrival my partner and I made contact with the sole bartender- Alejandra L. HERNANDEZ(W/F 01/27/1993) who was above the legal drinking age. HERNANDEZ was cooperative and friendly. We also made contact with the owner Omar MONREAL-SALAS(W/M 01/30/1982). #### INITIAL INVESTIGATION

This report is written by Police Officer (P.O.) Quentin C. ARNOLD, assigned to District Two, Late Power Shift, Squad 2432 partnered with P.O Antwan POWELL. Officer POWELL and I were equipped with an AXON body worn camera, which captured this investigation.

On Saturday, March 4th, 2023, at approximately 11:08 P.M., Squad 2432 Officer POWELL and I (While in full duty Milwaukee Police Uniform with the Milwaukee Police Badge on our outer most garments, operating a marked Milwaukee Police Squad 234 equipped with operating emergency lights and audible siren) were dispatched to a tavern violation at the address of 1801 S Muskego Ave. located in the City and County of Milwaukee, WI.

The tavern violation CAD stated that there were underage minors within the tavern, and they were actively drinking. Upon arrival I met with the lead security guard who we identified as MEDINA, Israel. MEDINA informed me that the manager was located in the kitchen. My partner and I walked through the tavern and located the manager identified as MONREAL-SALAS, Omar (W/M, 1/30/1982, 414-885-8683. MONREAL-SALAS stated that he was aware of minors being within the tavern but, they were not consuming any alcohol. MONREAL-SALAS stated that they were eating food and dancing and were never served anything but soda.

We made contact with the family within the establishment who stated they were there to eat and dance before going home. There was only one minor within the group who appeared completely sober and showed no signs of intoxication. After our short interaction they were allowed to finish eating.

MONREAL-SALAS was cooperative throughout our interaction and my partner, and I did not observe any infractions throughout the tavern.

PELAEZ TORRES stated he was leaving the Caleta Bar and got in his vehicle which was parked directly in front of the establishment. PELAEZ TORRES' vehicle is a 2007 Chevrolet Cobalt (WI plates APG9062).

PELAEZ TORRES then stated as he got in his vehicle, an unknown black male wearing a brown hooded sweatshirt approached him from the front driver side door and began to tell him something, but due to language barriers PELAEZ TORRES did not understand what the unknown suspect stated. PELAEZ TORRES stated the suspect did not attempt to take anything from his person or vehicle and did not have any weapons at the time of the battery. PELAEZ TORRES went on to stated that the suspect began to punch him through the window, causing him pain and discomfort. PELAEZ TORRES then stated he got out of the vehicle and began to fight the suspect back. As he fought back the suspect ran around the bar and grabbed an unknown object, which PELAEZ TORRES believed to be a metal pole, and began to hit his front side passenger side window with it. PELAEZ TORRES stated the suspect was able to break the window and began to run away. PELAEZ TORRES started running after him and losing him a few blocks away.

While on scene we were able to interview the security guard of the Caleta Bar, who identified himself as Jose L CARRASQUILLO (M/W 08-15-1964). CARRASQUILLO stated he did not see anything and stated that the manager was not available, and we were not able to review video surveillance. CARRASQUILLO stated he believes the suspect was a homeless subject that regularly stands outside the bar but did not know the subject's name or information.

Due to a high volume of calls citywide, not CST's were available. PELAEZ TORRES stated he no longer wanted to wait on scene and canceled the CST. PELAEZ TORRES also denied any medical attention and stated he was ok. PELAEZ TORRES was provided with a PV-17 and contact information.

On Sunday, April 23rd, 2023, at 2:06 AM we were dispatched to the address of 2013 W Rogers St (which is located in the City and County of Milwaukee) for a Battery complaint. Upon our arrival to the dispatched address, we made contact with the caller/victim who identified himself as Carmen A LOPEZ-PENA (M/W 07-16-1986). LOPEZ-PENA stated that at approximately 1:30 AM he was drinking at La Caleta Bar and Restaurant located at the address of 1801 S Muskego Ave (which is also located in the City and County of Milwaukee).

LOPEZ-PENA went on to stated that while he was in inside the bar, he was provided a beer by a female who was also there. After the female gave him a beer, an unknown Hispanic male along with another subject punched him in the face, casing swelling to his left eye. LOPEZ-PENA then stated 2 security guards kicked everyone involved out of the bar.

LOPEZ-PENA stated that he left the bar and went home but was alerted by a friend who was still inside the bar that the individual who punched him in the face was out looking for him and was armed with a firearm. We conveyed LOPEZ-PENA back to the scene as LOPEZ-PENA stated he was concerned for his friends, and wished to point out the individual who battered him. LOPEZ-PENA was then conveyed back to 1801 S Muskego Ave.

While on scene, Squad 2351 along with 2341 were there investigating a different incident (CAD 231130160). LOPEZ-PENA began to attempt to identify the subject who battered him and saw the suspect's friend and stated he battered him too. I conducted a canvas and interviewed both security guards separately. The first security guard identified himself as Jose L CARRASQUILLO (M/W 08-15-1964) and stated that he did observe an argument inside the bar between LOPEZ-PENA (who is a regular customer but causes trouble) and an unknown subject.

CARRASQUILLO stated he escorted the group outside and they began to fight in the sidewalk in front of the establishment. CARRASQUILLO stated that he believed LOPEZ-PENA was the aggressor and was choking the suspect. CARRASQUILLO then stated he attempted to break up the fight and was bit on his finger by LOPEZ-PENA. CARRASQUILLO stated he no longer wanted LOPEZ-PENA to patronize the bar. The second security guard identified himself as Carlos GONZALEZ (M/B 06-12-1994). GONALEZ also stated he saw the fight on the sidewalk, and stated there were no guns involved.

We attempted to locate the suspects that LOPEZ-PENA initially pointed out, but they had left the scene due to 2351 and 2341 investigating the separate incident. CARRASQUILLO stated there was no video surveillance available inside or outside. LOPEZ-PENA located his friend and when asked if he observed LOPEZ-PENA getting battered he walked away and stated he didn't see anything.

LOPEZ-PENA was then conveyed back to his home address and was provided a PV-17. LOPEZ-PENA refused medical attention numerous times.


