1. The claimant is Sherry Ann Urbaniak who resides at 9545 West Oklahoma Avenue in the City and County of Milwaukee, State of Wisconsin.

- 5. That the injuries sustained by Sherry Ann Urbaniak are as follows: a Galeazzi fracture of the left forearm and an abrasion to her right hand along with multiple superficial abrasions. That these injuries were sustained as a consequence of Sherry Ann Urbaniak's tripping and falling on a defective portion of the public sidewalk in the 9400 block of West Oklahoma Avenue in the City and County of Milwaukee, State of Wisconsin.
- 6. That the sidewalk was defective as a consequence of the negligence on the part of employees of the City of Milwaukee who, having notice of the defective condition of that public sidewalk, failed to repair the same in a timely manner.
- 7. That as a consequence of said injuries Sherry Ann Urbaniak incurred medical expenses of \$27,784.54 and will, in all likelihood, incur additional medical expenses in the future.
  - 8. According to her treating physician, the injuries sustained by Sherry Ann Urbaniak are

permanent in nature and will in all likelihood require additional surgery in the future.

9. That Sherry Ann Urbaniak makes a claim against the City of Milwaukee based upon the heretofore described injuries and the heretofore described negligence on the part of employees of the City of Milwaukee in the amount of Fifty Thousand Dollars (\$50,000.00).

- 1. That the attorneys for Sherry Ann Urbaniak, an adult resident of the City of Milwaukee, residing at 9545 West Oklahoma Avenue, are Safer & Stein Law Firm, S.C., 9001 North 76<sup>th</sup> Street, Suite 310, Milwaukee, Wisconsin 53223.
- 2.
