We did eventually locate them 2.20.25. Aside from the lack of renewal of their license at that time they had no hot or cold running water available for hand washing. There was dirt and debris noted on the food contact surfaces of the equipment. The truck was ordered closed. It looks like when the provisional was issued we did a reinspection and were able to reopen them.
