There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/18/22 at 10:29p.m., Milwaukee Police were dispatched to a Subject with a Gun at 5321 W Green Tree Rd. Investigation revealed a patron was argumentative with other patrons in the tavern, therefore security escorted the patron out. Once outside the patron remained in the parking lot stating "I'll blow you away" to the security guard. The officers conducted a traffic stop of the patron's vehicle and did recover a firearm. The patron stated they did not have the weapon inside the establishment as they were checked for firearms upon entry. The agent and staff were very cooperative with the investigation.
2. On 02/06/23 at 12:09a.m., Milwaukee Police were dispatched to a Subject with a Gun at 5321 W. Green Tree. Investigation revealed two subjects, who were not patrons, were pacing back and forth in front of the building, when they pulled out firearms and began to fire at the building. The suspects then began running away on foot through the parking lot, continuing to fire shots. A house near the establishment was hit, along with multiple vehicles in the area. No patrons or citizens were injured during the incident and officers recovered multiple casings both inside and outside of the establishment. The agent was on scene and all employees were cooperative with the investigation, allowing officers to view video surveillance of the incident.

3. On 02/22/23 at 11:54a.m., Milwaukee Police conducted a License Premise Check at 5321 W. Green Tree Rd. On arrival officers observe security denying access to a patron, who became argumentative with security. Once the patron observed the officers, they returned to their vehicle, and officers observed security remain calm throughout the incident. No violations were observed.
4. On 05/19/23 at 2:10a.m., Milwaukee Police were dispatched to a Trouble with Subject at 5321 W. Green Tree Rd. Prior to arrival officers contacted the caller who stated they were frustrated due to loud noise coming from the business. The officer interviewed the security guard who stated there were a few small fights and arguments in the parking lot earlier and had since cleared the bar. The employees were cooperative with the investigation.
5. On 07/19/23 at 1:44a.m., Milwaukee Police were dispatched to a Tavern Violation at 5321 W. Green Tree Rd. The caller stated there were underage patrons, drinking inside the bar. On arrival officers observed approximately 15 patrons that all appeared to be of legal drinking age. The security officer was cooperative with the officers and showed them an ID reader used to verify age.
6. On 08/27/23 at 12:09a.m., Milwaukee Police were dispatched to a Noise Nuisance at 5321 W. Green Tree Rd. On arrival officer observed a large crowd of people outside of the establishment. The agent was on scene and stated they set up a sound system on the patio for people to enjoy music. The agent agreed to stop the music outside immediately.
7. On 09/02/23 at 1:24a.m., Milwaukee Police were dispatched to a Shooting at 5321 W. Green Tree Rd. The caller stated they had been pepper sprayed on shot, however, this was deemed to be not true as MFD was on scene and evaluated the caller. The agent was on scene and stated the caller had been causing a disturbance inside the bar and was trying to physically fight with other patrons, when they were escorted out and called people on the phone to come and shoot up the establishment. The agent was cooperative and allowed officers to view video surveillance of the incident.
8. On 10/01/23 at 1:26a.m., Milwaukee Police were dispatched to a Sexual Assault at 5321 W. Green Tree. Investigation revealed a sexual assault did not occur. The caller was attempting to enter and refused to allow security to search them, therefore, was denied entry. Video surveillance was observed and at no time did any security touch the caller.
9. On 10/01/23 at 9:57p.m., Milwaukee Police were dispatched to a Subject with Gun at 5321 W. Green Tree Rd. Investigation revealed an argument took place between the victim and a subject regarding the ownership or rental of a car. While the victim was inside the establishment, the other subject arrived and put a gun to their stomach and demanded the car. The victim turned over the keys and the suspect fled the scene with the car. The officers later conducted a traffic stop of the vehicle, a firearm was recovered and the suspect was taken into custody. Video surveillance of the incident was provided by the establishment.
10. On 10/21/23 at 2:00a.m., Milwaukee Police were dispatched to a Shots Fired at 5321 W. Green Tree Rd. The caller stated they observed a subject exit the bar and fire a shot into the air. The agent was on scene and stated no one from the bar fired shots, however, there was a vehicle parked across the street and fire a round into the air as they were driving away. A casing was recovered and seemed to be in the location the agent stated, not where the caller stated the incident occurred. The agent was cooperative and allowed officers to view video surveillance of the incident.

11. On 10/26/23 at 12:40a. m, Milwaukee Police were dispatched to a Shots Fired at 5321 W. Green Tree Rd. The caller stated they heard several shots fired in the area and a subject screaming near the bar. On arrival officers did not locate any evidence of shots being fired and interviewed the agent who stated they did not have any problems at the bar, nor did they hear any shots fired. The agent was cooperative and checked video surveillance for any evidence of vehicles in the area discharging a firearm, however, found none.
12. On 10/26/23 at 8:18p.m, a Milwaukee Police Officer conducted follow up at 5321 W. Green Tree Rd., to interview the agent regarding Shots Fired complaints. The officer asked the agent about a Shooting that was later downgraded to an Endangering Safety by Use of a Dangerous Weapon. The agent stated they recalled the incident and was cooperative with police and provided video surveillance of the incident. The officer then interviewed the agent regarding an incident on 09/29/29 at 2:50a.m., however, the agent stated the business was already closed at that time and they were no longer on scene, therefore, had no knowledge of the incident. The agent stated the area around their establishment has issues with shots being fired and residents always assume it's coming from the bar. The agent stated they are attending an upcoming meeting at the District to discuss the business and has recently changed their Plan of Operation to increase age limit to 25 and set in place a dress code to enter.

This report submitted by PO Nicholas SCHLEI, assigned to District 4, Early Shift.

On Sunday, December 18, 2022, at approximately 10:29 PM, PO Jason DAERING and I, Squad 4281, were dispatched to a Subject with Gun complaint at New Entertainers tavern, 5321 W Green Tree Road, in the City and County of Milwaukee, Wisconsin.

Upon arrival the security guard for the tavern, identified as Edward H. STRAY (B/M 02-20-1997), pointed towards a silver Subaru hatchback that was leaving eastbound on W Green Tree Road, pointing it out as the vehicle with occupants that were causing the disturbance at the tavern.

A field interview was conducted at approximately 6701 N 60th Street, also in the City and County of Milwaukee, Wisconsin, of the same silver Subaru Outback hatchback, Wisconsin registration AMD-2750. Upon approaching the vehicle officers observed the rear seat passenger on the passenger side was in possession of a tan handgun, stored in the pocket on the back of the front passenger seat.

The female disregarded multiple commands to stop reaching about the floor of the vehicle and was removed from the vehicle, as it was unknown if additional firearms were concealed where she was reaching. She resisted officers attempts to restrain her in handcuffs and was escorted to the ground so that officers could gain control of her arms for handcuffing.

The female was identified by Wisconsin driver's license as Keyara WALLACE (B/F 06-10-1999).

I had recovered the handgun as WALLACE was seated in the vehicle. I observed it to be a tan FN 509 9mm semi-automatic handgun, loaded with 11 cartridges in the extended magazine and one in the chamber.

A query through NCIC records revealed WALLACE does have a valid Carry Concealed Weapon permit.

STRAY stated to investigating officers that WALLACE, who was identified via a picture STRAY took of her outside, was being loud and boisterous in the tavern and started an argument with an older couple. STRAY stated he physically escorted WALLACE from inside, and she and four females she was with stayed on scene, being loud, profane, and making threatening remarks in the parking lot. STRAY stated specifically that WALLACE made threats indicative that she may have a gun, stating "I'll blow you away" to him, which made him concerned she may have a firearm and caused him to be alarmed.

WALLACE was arrested and conveyed to District 4 for processing, and released with a future court date.

WALLACE stated she did not have the firearm in the tavern and that the security at the tavern did check for weapons.

Officers had full cooperation from security and from the Business Agent in this investigation.

#### NATURE OF CALL/ JUSTIFICATION

On Thursday, February 2, 2022, at approximately 11:54 am, PO Jacob AWOLOLA and I (Squad 4467), conducted a Tavern Check at the "Regal Beagle Bar and Lounge" located at 5221 W. Green Tree Rd. This address is located in the City and County of Milwaukee.

#### INVESTIGATION

Upon arrival, I observed that the club was open for business and patrons were inside of the building. I observed that the parking lot of the business was filled to capacity with vehicles and there was an exterior security guard on scene. The main entrance door of the business had two security guards posted at the door who were physically checking patrons prior to allowing them to enter the building. The security staff also utilized a handheld metal detector to check for weapons. I observed multiple patrons inside of the business and the business was not at capacity.

I observed that the security guards posted at the main entrance door was engaged in an argument with a female who was denied access into the club. The female was yelling profanities and causing a scene which carried from the entrance door to the parking lot. Once the female noticed officers on scene, she quickly ran to her vehicle that was double parked on N 52nd St and departed the scene. I observed that the security personnel remained calm during the incident despite the unruly female.

This report is written by PO O'Neal STAMPS III, assigned to District 4, Late Power shift.

On Monday, February 6, 2023, at approximately 12:09 am, the business located at 5321 W Green Tree Rd was struck multiple times by gunfire while occupied by patrons. This address is located in both the City and County of Milwaukee, WI.

On the mentioned day, two unknown black males approached the main entrance by walking through the parking lot. The two males approached the security guard, later identified as Edward H STRAY (B/M 02/20/1997) and paced back and forth without attempting to enter the bar. The two males then pulled firearms from their hooded sweatshirts and fired multiple rounds at the business, striking it approximately 9 times. Approximately 15 patrons were seated inside of the building when the bullets struck the building and three round went through the exterior wall and entered the building. No one inside was struck by the gunfire. The projectiles that entered the business entered through the front window and traveled through a digital machine then struck a padded table. One projectile was recovered inside the business on top of a bar stool.

The two males then turned and ran westbound through the parking lot then south on N 54th St. The two males continued to fire shots at the business while they fled the scene. An unknown SUV was leaving the parking lot during this incident and appeared to have one of the windows shot out. The SUV was seen traveling southbound on N 54th St in the same direction as the two male subjects ran.

A white 2021 Hyundai Sonata bearing plate AFH-8661 was parked facing southbound on N 54th St across

from the business and was struck twice by gunfire. No one was inside of the vehicle when it was struck.

The patrons who were inside of the bar were no longer on scene when police arrived. STRAY and the bartender later identified Sadie L. EAVES (B/F 01/09/1980) were inside of the business when police arrived and was able to provide a statement. The owner of the business, Justin D. JACKSON (B/M 12/11/1976) was also inside of the bar when this incident occurred. JACKSON was in the office located on the second floor and heard the gunshot but did not observe the incident.

A residence located at 6759 N 54th St was also struck by gunshots during this incident. The residence was struck in the front window seal of the unit and a projectile was lodged in the frame of the window. Otha L. BOWMAN (B/M 11/30/1979) and Brianna P. BOWMAN (B/F 07/28/1990) reside at the mentioned address. OTHA was in a back bedroom inside of the home and BRIANNA just pulled her vehicle into the driveway when this incident occurred. No one at the residence was injured during this incident.

~~Officers were able to view security footage provided by JACKSON that captured the entire incident.~~

Multiple casings were located in the parking lot of the business along with a projectile. Casings were recovered in the roadway that extended from the opening of the business parking lot to the front of 6759 N 54th St. A canvass revealed that there were no other cameras in the area that captured this incident.

JACKSON stated that there were no issues with customers this evening and business was fairly slow. JACKSON stated that he did not know of anyone who would want to shoot at his business.

CIB responded to the scene to investigate this incident.

Upon our arrival I observed a security guard later identified as Edward H STRAY (B/M 02/20/1997) standing in the parking lot of the business. I observed approximately 3 vehicles parked on the parking lot with 5 vehicles parked on W Green Tree Rd in front of the business. I observed that the exterior lights were functioning and the area was well lit. PO MAJEED and I did not observe nor heard any commotion coming from inside of the bar. I observed approximately 15 patrons inside of the bar who appeared to be of the legal age to consume alcoholic beverages. I observed a security station just inside of the main entrance door that was equipped with a hand held metal detector and also an identification card reader which was activated and functioning properly. the owner of the business, Justin D. STARY stated that tonight was a slow night for the bar and not many partons arrived this evening. STRAY did state that at approximately 12:30 am, a group of females exited the bar and went into the parking lot. STRAY stated that the group of females began to tussle with on another and he along with another security guard intervened to separate the group. STRAY stated that no one was hurt during the brief altercation and the females went their separate ways. STRAY stated that the security staff was able to handle the situation and did not call the police because the situation was resolved.

### Dispatch and Cal Type

On Sunday, October 1st, 2023, P.O. CAPELLE and I were dispatched to the address of 5321 W Green Tree Rd, which is located in the City and County of Milwaukee, for a "Subject with Gun" call for service. Upon arrival I was met by the caller and victim who identified herself as Shaniqua S JONES (F/B 08/29/1992). JONES stated that a known female pointed a firearm at her without her consent. JONES verbally identified the female as Crystal S SHAMBLEY (F/B 12/24/1985). JONES stated that she and SHAMBLEY recently began talking and beginning a relationship together. JONES stated that she and SHAMBLEY have never lived together and share no kids in common.

### Scene

~~The address of 5321 W Green Tree Rd is a bar named the Regal Beagle. This location is a one-story~~  
building located on the south-eastern side of the intersection of N 54th St and W Green Tree Rd. The bar has multiple surveillance footage cameras, the footage was later provided to officers and uploaded to Axon evidence for viewing purposes.

### Interview of JONES (Victim)

I spoke with JONES on scene regarding the incident. JONES stated that she and SHAMBLEY recently began an intimate relationship and have been talking for approximately 2 (two) weeks. JONES then stated that on Friday, September 29th, 2023, she began the steps to purchase a vehicle from SHAMBLEY. Jones described the vehicle as a Nissan Maxima, bearing Wisconsin plate number AHC-3906. JONES then stated that she paid SHAMBLEY 265 dollars to borrow the vehicle until 10/02/2023, when she would finalize the purchase of the vehicle with SHAMBLEY. JONES then stated that she did not believe nor was she under the impression that she was the owner of the Nissan Maxima.

JONES then stated that on the day of the incident, she and SHAMBLEY got into an argument over text message. It should be noted that JONES did not go into detail about the argument, only that an argument took place. JONES then stated that she was at the Regal Beagle bar with another female, who JONES refused to identify to me, and was ignoring SHAMBLEY's phone calls. JONES then stated that while at the bar, SHAMBLEY arrived agitated and armed with a firearm. JONES also stated that SHAMBLEY arrived in a gray Mazda truck. JONES then described the firearm as gray in color but did not know the make and model. JONES then stated that SHAMBLEY approached her and put the firearm up to her stomach and stated, "Give me the car". JONES also stated that there was an unknown male who accompanied SHAMBLEY. JONES then stated that she gave SHAMBLEY the keys to the Nissan Maxima and SHAMBLEY fled the area. JONES also stated that the unknown male got into the Nissan Maxima and fled the area. JONES did mention that the male subject's vehicle was currently parked on N 55th St, just North of W Green Tree Rd.

While conducting the interview with JONES, it should be noted that a newer model gray Mada SUV was observed travelling West on W Green Tree Rd. It should also be noted that JONES pointed at this vehicle and stated, "That's her right there in that truck". I then observed the vehicle stop on N 54th St next to an unknown model sedan, silver in color. JONES described the silver sedan as the unknown male's vehicle.

The silver sedan then fled West on W Green Tree Rd and the gray Mazda SUV began travelling East on W Green Tree Rd.

P.O. CAPELLE and I then conducted a subject wanted stop of the gray Mazda. The vehicle is described as a gray Mazda CX-9, bearing Wisconsin plate number APL-5275. During this stop I made contact with the driver and sole occupant of the vehicle who was later confirmed as Crystal S SHAMBLEY (F/B 12/24/1985). The subject wanted and arrest of SHAMBLEY will be explained in detail below.

I then returned to the Regal Beagle and continued my interview with JONES. I began asking JONES about the ownership of the Nissan Maxima. JONES stated that she did not yet own the vehicle but that she was only renting for the time being. JONES then allowed P.O. O'Neal STAMPS to take digital photographs of her phone, depicting the text messages and the exchange of US currency to borrow the vehicle.

JONES was issued a PV-17.

### **Subject Wanted and Arrest of SHAMBLEY**

After JONES identified the suspect vehicle, a gray MAZDA CX-9 bearing WI plate number APL-5275, P.O. CAPELLE and I conducted a subject wanted stop of the vehicle.

During this stop I made contact with the driver, SHAMBLEY, who was the sole occupant of the vehicle. SHAMBLEY was taken into custody and placed into the rear of the squad car. While taking SHAMBLEY into custody, she stated that her firearm was in the vehicle, SHAMBLEY stated that it was between the front driver seat and the center console of the vehicle. I then conducted a probable cause search of the vehicle and located a firearm on front driver side floorboard, between the seat and the center console.

The firearm is described as a Taurus spectrum .380 with a pink and white frame and gray slide. This description corroborates with the previous description of the firearm that JONES provided me during her interview.

SHAMBLEY also stated that she did not pay the fee for her certificate for completing her CCW course and is not currently a valid CCW permit holder. A check through Etime confirmed SHAMBLEY's statements.

SHAMBLEY was arrested at 10:27 pm at the address of 5300 W Green Tree Rd and later conveyed to District 4 for processing. SHAMBLEY would later be admin released with a future court date.

While at District 4, SHAMBLEY refused to make a mirandized statement to officers.

P.O. O'Neal STAMPS, of squad 4467, responded and took digital photographs of the vehicle that depict the location of the firearm that was recovered. P.O. Upon arrival, I located one brass in color COLT 40 S&W casing at the south side of the street at intersection of N 53rd St / W Green Tree Rd.

P.O. EISSENS spoke to the caller (Larresa D. TAYLOR, b/f, 6-21-69) who stated she observed an unknown black male leave the bar (Regal Begal 5321 W Green Tree Rd) and then walked into the middle of the road with a handgun in his hand and shot the gun 2 times in the air. TAYLOR showed us the area where she observed the unknown male fire the shots. P.O. EISSENS and I along with Sgt. CARABELLI checked the area and didn't locate any casing in that area.

P.O. EISSENS and I spoke to security (Romaine JACKSON, b/m, 12-08-96) who stated no one from the bar fired shots. R. JACKSON stated he observed a Nissan that had at least 3 black females driving westbound on W Green Tree Rd and then did a u-turn and went eastbound on W Green Tree Rd and fired one round in the air.

The owner (Justin D. JACKSON, b/m, 12-11-76) of Regal Begal came outside and showed us his surveillance footage cameras that shows at approximately 1:48am, a dark colored sedan waiting for patrons of the bar to cross the street before driving driving eastbound and making a u-turn at the intersection of N 53rd St / W Green Tree Rd.

P.O. EISSENS took 12 photos at approximately 2:58am of the scene.

P.O. EISSENS sent J. JACKSON a link to have the video downloaded to evidence.com and J. JACKSON uploaded the footage.

P.O. EISSENS inventoried the brass in color COLT 40 S&W casing under inventory #23033664 item 1 of 1.

## NATURE OF CALL/JUSTIFICATION

On Thursday, October 26, 2023 at approximately 8:18 pm, I was tasked to conduct follow up at the Regal Beagle Lounge located at 5321 W Green Tree Rd. This address is located in both the City and County of Milwaukee, WI.

## INVESTIGATION

Upon arrival at the mentioned address I spoke to the business owner Justin D. JACKSON (B/M 12/11/1976) in the main parking lot of the establishment regarding recent Shots Fired complaints. I spoke to JACKSON regarding an incident that occurred on 10/20/2023 which came over as a Shooting complaint that was later downgraded to Endangering Safety by Use of a Dangerous Weapon. JACKSON stated that he recalled the events of that night and stated that he spoke to a MPD Sergeant regarding video that may have captured the incident. JACKSON stated that he spoke with Sgt. Jasen RYDZEWSKI and provided surveillance for in and around the bar, however the camera does not show who was shooting off firearms, just people running. JACKSON stated that the security guards on duty that night did speak with the responding officers and provided statements. A check in department records revealed that a License Premise report was filed regarding this incident by PO AWOLOLA.

I then spoke to JACKSON regarding a Shots Fired complaint that occurred on 09/29/2023 that came in at approximately 250 am. JACKSON stated that on that day he closed the bar at 2:00 am and was no longer on scene at that time. JACKSON stated that no one was on scene at the time that officers arrived and had no knowledge of any shots being fired in the area nor any useful information regarding the incident. JACKSON stated that the area around his business has an issue with shots being fired that has nothing to do with his establishment but the residents in the area always assume that the bar is the issue.

## FOLLOW UP

JACKSON stated that he recently had his license review hearing on October 17, 2023. JACKSON stated that he submitted changes to his business to increase the safety for his employees and patrons. JACKSON stated that he increased the age limit to enter the bar from 21 to 25 years old. JACKSON stated that he also set in place a dress code that prohibits t-shirts, face masks, hoodies, baseball caps and anything that partially/fully concealing anyone's identity.

JACKSON stated that he is aware of the upcoming meeting at District 4 on November 13, 2023 at 3:00 pm and plans to attend the meeting.


