Background

Mayers Strategic Solutions, LLC consults with communities across the country on reimagining public safety by establishing their own policing reforms centered on Community Empowerment through an approach that I developed and informed by my years of experience as a community lawyer called the C.A.T. Method, which stands for Community Empowerment, Accountability, Transparency. The C.A.T. Method helps communities to identify, strategize, and implement long-term and positive changes in law enforcement practices, policies, and culture. The **C.A.T. Method** consists of: **Community Empowerment** through specific community processes; **Accountability** through mechanisms that create an inhospitable environment for law enforcement officers who engage in misconduct; and **Transparency** through mechanisms that advance the interconnectedness and coordination amongst community members, law enforcement, government officials, and the news media to pro-actively strategize policing reform to support public safety and ensure police accountability.

Project Scope

The presentation on Community Empowerment-centered policing reform will be at least one and a half hours long. The duration of the development and implementation of Milwaukee's Community Policing Action Plan is to be determined.



Project Objective

The presentation on Community Empowerment-centered policing reform will empower community leaders in Milwaukee, Wisconsin to reimagine public safety by identifying, strategizing, and implementing evidence-based, best practices on policing reform through the C.A.T. Method to achieve Community Empowerment. Also, the C.A.T. Method will be applied to the development and implementation of Milwaukee's Community Policing Action Plan for long-term and sustainable reform.

Deliverables & Process

Goal: Develop and implement Milwaukee's Community Policing Action Plan. Educate community members and leaders in Milwaukee, Wisconsin on Community Empowerment-centered policing reform.
