If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 

This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/11/2020 at 10:25pm officers were dispatched to a Noise Nuisance at Karina's Pizza, 2952 S 13th St. The officer heard loud music coming from the location and someone speaking on a microphone. The officer advised the subjects to turn the music down. At 11:25pm the officer was called back to the location for loud music. The officer listened outside and could hear music but stated it was at a reasonable volume. The officer spoke with the applicant, through a translator, that she needed to keep the volume down due to the close proximity to the neighbors.
2. On 01/25/2021 officers were dispatched to an Armed Robbery at 2952 S 13th St. The officers interviewed the applicant, who stated a subject walked up to the counter, displayed a firearm on his hip and demanded money. The employee pulled a gun from under the counter and pointed it at the subject. The subject left without obtaining any money. No license violations observed.

INITIAL INVESTIGATION

This report is written by P.O. Joshua YANG, assigned to District Six, Late Power Shift. On Sunday, October 11, 2020, I was assigned to the License Premise Car (Squad 6468). I was operating a marked black and white Milwaukee Police Department squad car, equipped with red/blue emergency lights and audible siren. I was in full MPD uniform, with badges and nameplates affixed to my outermost garment. I was equipped with a body worn camera, which were activated and captured this incident.

At approximately 10:26 pm, I was dispatched to a noise nuisance complaint at 2952 S. 13th St. (Karina's Pizza), located in the City and County of Milwaukee.

Upon arrival, I heard music and someone speaking through a loud microphone coming from inside of the location. I knocked on the door and observed that there were approximately ten people inside of the location. I asked who was in charge here and received no answer. An unknown Hispanic male attempted to speak to me in Spanish but I could not understand what he was saying. I then again asked what was going on here and a female subject stated they were having a party. I advised everyone that the music was too loud and they need to keep it down to a reasonable volume. I advised them that I would not be issuing any citations yet as this is the first complaint I've received for the location.

At approximately 11:25 pm, I was dispatched to the same location, 2952 S. 13th St. (Karina's Pizza) for a noise nuisance complaint. Squad 6440, P.O. Shawn SWITZER and P.O. Benjamin DELANEY also responded to assist.

Upon arrival, I stood outside the door of the location for a minute or so and I could hear a low volume of music coming from inside the location. The music was not as loud as it was before and it was at a reasonable volume. I knocked on the door and spoke with a female who was later identified as **Wendy M. MEDINA-GONZALEZ (W/M, 2/5/02)**. I asked MEDINA-GONZALEZ who was in charge of the location and she stated one of the owners of the location was on scene. The owner was later identified as **Gabriela ZAPOT-MENDOZA (W/F, 8/25/82)**. ZAPOT-MENDOZA was not fluent in English so MEDINA-GONZALEZ assisted with translating. I advised ZAPOT-MENDOZA that she needs to keep the music down

On Monday January 25th, 2021 squad 6241 (ALMAS, H/PLEVAK, N) was dispatched to the address of 2952 S. 13th St (KARINA'S PIZZA), which is located in the City and County of Milwaukee Wisconsin to investigate an Armed Complaint.

Upon arrival I spoke to one of the owners who is identified as Gabriela NMI ZAPST-MENDOZA (F/W 8-25-82). ZAPST-MENDOZA advised me of the elements of the Robbery. I then broadcasted the incident over the Milwaukee Police Radio system. There were no employees or patrons injured in this incident.

A white Male described as: W/M, 30 to 35 YOA, 6'0 to 6'1, 180 to 200 pounds, wearing a Maroon knit hat, dark green balaclava type COVID mask, Black hooded zip-up jacket, Black gloves, Black pants and black running shoes with White soles, entered Karina's pizza and walked up to the service counter and intentionally displayed a silver semi-automatic firearm that was attached to his right hip and stated "Give me the Money', The store employee then stated "you see my children"? and pulled out a fake gun from underneath the service counter and pointed it at the actor. The actor obtained nothing and fled out of the restaurant on foot in an unknown direction.

The victim did not consent to the offense and will prosecute.

The is no licensing violations regarding this incident.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 3/30/2021 at 10:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
