
PLEASE TAKE NOTICE that Sterling Jackson, by his attorneys, Sperling Law Offices LLC, states that the following circumstances gave rise to his injuries:

1. That on or about October 4, 2022, Mr. Jackson was driving his vehicle at or near the intersection of N. Teutonia Avenue and W. Villard Avenue, in the City and County of Milwaukee, State of Wisconsin.

2. That on that date and at said intersection, Officer James Filsinger, a City of Milwaukee and City of Milwaukee Police Department employee, in the course and scope of his employment, was negligent and careless in the operation of a vehicle owned by the City of Milwaukee. Filsinger was careless and negligent in failing to properly manage and control his vehicle, failing to yield the right of way and failing to keep a proper lookout, among other negligent acts and omissions, causing a collision with Claimant Sterling Jackson's vehicle.

3. As a result of this circumstance, Mr. Jackson suffered injuries to his right ankle, head, including a concussion, among other injuries and he has and will incur medical costs, property damage, and other injuries and damages.

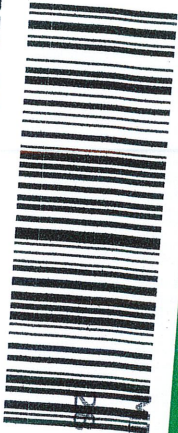
