Dear Mr. Barberena:


We have received your claim in the amount of \$1,155.80, relating to damage from a loss on December 13, 2017.

The Fleet Division of DPW investigated. They indicated that our driver had signaled in advance of the turn. You were traveling in a lane which is for bicycles and parking only. There is a sign which notes this. The liability for this accident is upon you. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
