## Dear Alderman Gordon:

This is in response to a request we received from Milwaukee Police Officer Kevin Porter to install the above-captioned traffic control restriction.

Our traffic engineering staff has investigated this request and found that when the traffic signal at West Fond du Lac Avenue at North 27th Street turns red in the morning rush hour period, a heavy backup in traffic for the southeastbound direction occurs. This backup usually extends past the intersection of North 28th Street. When southbound motorists on North 28th Street try to merge unsuccessfully with motorists on West Fond du Lac Avenue, crashes occur. The installation of this turn restriction will eliminate this traffic conflict.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
